MOTION FOR RE-COMMITAL OF A BILL

1. **Re-Committal of the Nigerian Maritime Security Trust Fund (Establishment) Bill, 2022 to the Committee of the Whole.**

Sponsor: Sen. Gobir, Ibrahim Abdullahi (*Sokoto East-Senate Leader*).

The Senate:

Recalls that the Nigerian Maritime Security Trust Fund (Establishment) Bill, 2022 was passed by the National Assembly and was transmitted to the President for assent;

Observes that some fundamental issues which require fresh legislative action by both Chambers of the National Assembly emerged after a critical analysis of the Bill by Mr, President C - in - C;

Aware that a Technical Committee of the Senate and House of Representatives and Directorate of Legal Services met and worked on the Bill;

Relying on order 1(b) and order 52(6) of Senate Standing Order, 2022 as amended.

Accordingly resolves to:

Rescind its decision on the Bill as passed and re-commit same to the Committee of the Whole for re-consideration and passage.
