This is the third in the series of Nigeria Quarterly Human Rights Report issued by Policy and Legal Advocacy Centre (PLAC), documenting reports of human rights violations and developments between July and September 2022.

In the quarter, several incidents relating to the violation of civil and political rights were reported. PLAC issued a Call to Action in September 2022 to express concern over the protection of the right to freedom of expression and the press, following an attempt by Nigerian media regulator, the National Broadcasting Commission's (NBC), to shut down the operations of some broadcast stations for failing to pay their licence renewal fees. PLAC therefore called for a downward review of these fees, to enable the operators to comply.

This report also highlights the responses of security agencies to some of the abuses reported to them, as evidenced by some of the interventions documented herein. The Nigerian military reported the rescue of several Chibok schoolgirls who were part of 276 girls kidnapped on 14th April 2014 by Boko Haram terrorists who attacked the Chibok Girls' Secondary School in Borno State.

More than half of the 62 abducted passengers of the Abuja/Kaduna train that was attacked by terrorists on 28th March 2022 were released by their kidnappers in the period under review, although the process that led to their release was unclear. However, insecurity remains a huge concern,

with violent attacks and threats of attack in Abuja, Nigeria's seat of power, a location hitherto considered the most secure in the country. Insurgency in Nigeria started out in the North East geo-political zone as far back as 2009 and slowly spread to the North West. It has now seeped into the North Central zone, including the Federal Capital Territory, Abuja.

In September 2022, the Academic Staff Union of Universities (ASUU), which commenced a strike action in February 2022, extended the strike indefinitely, keeping students of public tertiary institutions out of school for a period of seven months. There were reports of other unions that embarked on industrial action to register their grievances against unfavourable working conditions, high operational costs and unsustainable business environment.

Human rights protection in Nigeria is at an abysmal level. In a democratic society, respect, protection and fulfilment of human rights are expected to improve over time. However, this can only be achieved if the government through its agencies displays regard for people's rights, in the discharge of their duties and intervene to ensure that citizens also respect the rights of fellow citizens.

PLAC will continue to engage the Human Rights Committees of the National Assembly, civil society groups working on human rights, the National Human Rights Commission and other relevant government establishments, as well as Nigerian citizens to identify cases of human rights violations and contribute towards efforts to hold perpetrators to account and obtain justice for victims.



Civil and political rights, which comprise a variety of human rights continue to be violated on a constant basis in Nigeria. Some of these rights are those most commonly violated by the security forces, such as the right to life, right to dignity of human person, right to personal liberty, right to fair hearing and the right to peaceful assembly. Although there were violations reported in the period under review, some interventions were also observed.

The #EndSARS protest against police brutality in October 2020 resulted in the establishment of Independent Investigative Panels on Human Rights Violations against the Special Anti-Robbery Squad (SARS) and other units of the Nigerian Police, in States across Nigeria and the Federal Capital Territory, Abuja, to hear cases of police brutality. The National Human Rights Commission (NHRC) had in March 2021, set up the Federal Government's panel of enquiry on police brutality in Abuja. The panel which probed allegations of human rights violations committed by the defunct SARS and other units of the Nigeria Police, awarded N289 million to 74 victims of gross human rights violations on 14th September 2022. Families of deceased victims and survivors received cheques as a mark of the awards at a ceremony held at the NHRC headquarters in Abuja. It marked the second and final batch of compensation by the Abuja panel to victims of widespread rights abuses by the police. The compensations in the judgments, according to the Commission, were awarded in cases bordering on extrajudicial killing, unlawful arrest and detention,

cruel, inhuman and degrading treatment and torture, alleged enforced disappearance, confiscation of property, among others. In December 2021, the Commission had awarded N146 million to 27 families and survivors who were victims of gross rights violations.

On 27<sup>th</sup> September 2022, the Abuja panel submitted its report to the National Human Rights Commission with recommendations and penalties. The panel, in its recommendation, found 72 police officers guilty of the allegations levelled against them. In the report, 28 of them were recommended for prosecution, 25 were recommended for dismissal, 15 for disciplinary actions, and four were recommended for demotion. Executive Secretary of the Human Rights Commission, Anthony Ojukwu, SAN stated that payment of compensation and holding indicted officers of the Nigeria Police accountable for the violation of the rights of the people were the first steps on the road to justice.

A Federal High Court sitting in Lagos sentenced a retired policeman, Ariwayo Oloyede, alias Oyinbo, to one-year imprisonment for human trafficking, on 30th September 2022. The ex-police officer was convicted alongside a Burkina Faso-based Nigerian, Christian Owanebi, who had jumped bail and was sentenced to seven years imprisonment for the same offence by Justice Abimbola Awogboro. The Judge held that the expoliceman, who had been attending court sessions consistently without default, was sentenced to one year imprisonment on each count, to run concurrently. They were found guilty of three counts of conspiracy and human trafficking, preferred against them by the National Agency for the Prohibition of Traffic in Persons (NAPTIP). The convicts were accused of conspiring with one another to procure a 19-year-old girl, Onyinyechi, for prostitution in Burkina Faso in November 2012.

#### **Violations by State Forces**

On Sunday, 3<sup>rd</sup> July 2022, the Paramount Ruler of Udoda community in Ahoada West Local Government Area of Rivers State, His Highness Okaya Gospel and the Youth President, Peter Francis protested continual attacks by thugs, military invasion and air raids in the area. The request

for basic amenities by the community, which hosts several petroleum pipelines is said to have been met with attacks and raids instead. Over 30 indigenes of the community, including a chief had been killed since the raids and attacks started in 2019. The community was deserted as people's houses had been razed and their properties stolen in the course of various invasions and attacks.

Agba Jalingo, publisher of Cross River Watch media outfit was arrested by Police at his residence in Lagos State. Jalingo, in a series of Facebook posts on 19<sup>th</sup> August 2022, stated that his residence was besieged by police officers. The journalist alleged that the police officers held his wife and daughter hostage. Jonathan Ugbal, editor of Cross River Watch, later disclosed that Jalingo was taken to Alapere police station and would be transferred to Abuja. Jalingo was arrested in connection with a petition of defamation of character filed by Elizabeth Frank Ayade, sister-in-law to the Governor of Cross River State, Ben Ayade.

This was an instance of using State apparatus to address personal issues, that otherwise could be resolved through civil legal proceedings.

#### **Right to Freedom of Expression and the Press**

On 19<sup>th</sup> August 2022, the National Broadcasting Commission (NBC) announced that it was revoking the licenses of 53 television and radio stations over unpaid licence fees to the tune of N2.6 billion. Director-General of NBC, Malam Balarabe Ilelah ordered the affected stations to shut down within 24 hours following the announcement, and directed NBC offices nationwide to collaborate with security agencies to ensure immediate compliance. The Commission had in May 2022, published the list of licensees indebted to NBC, giving them a period of two weeks to renew their licences and pay their debts. Three months after, the Commission declared the continued operations of such stations illegal and as constituting a threat to national security, and therefore announced the revocation of their licences.

However, in determining an application on the matter filed by a civil rights group, the Socio-Economic Rights and Accountability Project (SERAP) and the Nigerian Guild of Editors (NGE), on 29<sup>th</sup> August 2022, a Federal High Court in Lagos, issued an order restraining President Muhammadu Buhari and the NBC from revoking the licences of the broadcast stations and shutting them down on the ground of failing to renew their licences. The application was filed alongside the main suit challenging the NBC's planned action against the broadcast stations.

#### **Political Rights**

The office of the Independent National Electoral Commission (INEC) in Igboeze North Local Government Area of Enugu State was set ablaze by arsonists on Sunday, 3rd July 2022. INEC Resident Electoral Commissioner (REC) in Enugu State, Mr. Emeka Ononamadu reported that 748 ballot boxes, 240 voting cubicles, office furniture and other equipment were destroyed in the attack inspite of the efforts of the Enugu State Fire Service. The attack came during the continuous voter registration exercise and other preparations by INEC for the 2023 general elections. It is unclear who was responsible for the attack.



The protection and fulfilment of these rights determine the quality of life of citizens. Nigeria, like many countries around the world, has been experiencing economic crisis. The devaluation of the Nigerian Naira by the Central Bank in 2021 and the ever increasing foreign exchange rates, have increased the prices of goods and services.

#### **Education and Employment**

The Nigerian government on 25<sup>th</sup> July 2022 ordered the immediate closure of unity schools in the Federal Capital Territory (FCT) over threat of attack by bandits. One of the affected schools is Federal Government College, Kwali, in the Kwali Area Council of the Federal Capital Territory (FCT), Abuja. Bandits had on 24<sup>th</sup> July 2022, attacked Sheda and Lambata villages, suburbs of Kwali Area Council, in the environs of the Federal Government College. The development interrupted the third-term examinations in the schools and the Senior School Certificate Examination (SSCE) by the National Examinations Council (NECO).

The Nigeria Labour Congress (NLC) announced that it will embark on a nationwide protest on 26<sup>th</sup> and 27<sup>th</sup> July 2022, in solidarity with the strike action by the Academic Staff Union of Universities (ASUU). ASUU had been on strike since February 2022 over the failure of the Federal Government to honour an agreement on issues bordering on funding universities, as well as on salaries and allowances of lecturers. In a letter

dated 15<sup>th</sup> July 2022 and addressed to chairpersons of the NLC in the States, President and General Secretary of the NLC stated that the protest was aimed at getting children back to school and supporting unions in Nigeria's public universities fighting for quality education. However, Minister of Information, Lai Mohammed, declared the proposed protest as uncalled for and illegal.<sup>1</sup>

On 20<sup>th</sup> August 2022, the Senior Staff Association of Nigeria Universities (SSANU), and the Non-Academic Staff Union of Allied and Education Institutions (NASU) suspended their strike action effective from 24th August for a period of two months, to allow the government to implement the agreements reached. Part of the agreements was the decision of the government to set aside the sum of N50 billion for payment of earned allowances. The unions had been on strike since 27<sup>th</sup> March 2022. <sup>2</sup>

The Academic Staff Union of Universities (ASUU) on 29<sup>th</sup> August 2022 announced that it was extending its strike action indefinitely. The announcement followed an emergency meeting of the union's National Executive Council at its national headquarters at the University of Abuja between 28<sup>th</sup> and 29<sup>th</sup> August 2022.

The Minister of Education, Adamu Adamu, on 6th September 2022, announced that the government could only afford 23.5 per cent salary increase for all categories of the workforce in Federal Universities, and 35 per cent increment for professors. He also stated that the sum of N150 billion and N50 billion will be provided in the 2023 national budget as revitalisation fund for Federal Universities and payment of outstanding arrears of earned academic allowances, respectively.<sup>3</sup>

On 7<sup>th</sup> September 2022, the Minister of Education, while insisting that the Federal Government's offer to ASUU in terms of salary increase was sustainable, reiterated that the government was maintaining its 'No Work, No Pay' policy for university staff.<sup>4</sup>

On 22<sup>nd</sup> August 2022, the Federal Government reiterated that it would launch the National Plan for Financing Safe Schools in September 2022, to provide a safe and secure learning environment for children. The Minister of Finance, Budget and National Planning, Zainab Ahmed had earlier announced that the Federal Government was set to launch a National Safe School Plan before the end of the third quarter of 2022. The plan outlines how Nigeria intends to protect schools and other places of learning. The Finance Minister pledged commitment to adequate budgetary allocation to finance the plan.

Bread makers, under the aegis of Premium Bread makers Association of Nigeria (PBAN) embarked on a four-day warning strike on 21st July 2022 over the rising cost of baking materials, following a notification issued by the association to that effect on 19th July 2022. PBAN threatened to extend the strike action if the government failed to intervene. The strike followed from the huge losses bakeries were incurring due to high operational costs, occasioned by high prices of baking materials and diesel, making the business operating environment unsustainable. The association sought the government's intervention to stop the 15 per cent development levy on wheat import, request the National Agency for Food and Drug Administration and Control (NAFDAC) to review downwards the N154,000 penalty charged bakeries on late renewal of certificates; grant members of the association access to grants and soft loans provided by the Central Bank of Nigeria (CBN) to Micro, Small and Medium Scale Enterprises (MSMEs) and stoppage of multi-agencies regulation of the breadmaking industry. The association also stated that multiple meetings with the Federal Ministry of Industry, Trade and Investment, Abuja (FMITI) in 2021 did not yield any result.

Electricity workers under the National Union of Electricity Employees (NUEE) embarked on a strike over welfare issues on 17<sup>th</sup> August 2022, leaving many Nigerian cities in darkness, including the Federal Capital Territory, Abuja. Power generation crashed below 4,000 megawatts as the workers went on strike to protest a compulsory promotion interview for principal managers, unpaid entitlements, among other issues. The union had announced the strike on 16th August 2022 during a protest at the Transmission Company of Nigeria's headquarters in Abuja. Electricity distribution companies notified customers of impending power outage as a result of the strike. However, the Federal Government announced that the union had halted the strike soon after it commenced, although it attributed the collapse of the country's grid to the electricity workers' strike.

The National Union of Electricity Employees on 6<sup>th</sup> September 2022, announced that they were ready to embark on another nationwide strike, after a previous strike action in August 2022. The union alleged that after almost nine years of privatising the Power sector, the Federal Government refused to pay entitlements of some of the workers of the defunct Power Holding Company of Nigeria (PHCN). The union noted that privatisation of the Power Sector has neither added value nor improved the life of the average Nigerian.

#### Healthcare

On 5<sup>th</sup> July 2022, the failure of the Nigerian State to take action to guarantee the safety of life and property as required under the Nigerian Constitution manifested when bandits razed two primary health centres in Batsari Local Government Area of Katsina State. Following the attack, the Executive Secretary, Katsina State Primary Health Care Development Agency, disclosed that 69 out of the over 1,800 healthcare centres in the State were temporarily closed as a result of insecurity in some LGAs in the State, as most health facilities were taken over by bandits and the solar refrigerators in the facilities converted to use by them. The affected primary healthcare facilities are located in Jibia, Safana, Batsari, Faskari, Sabuwa and other LGAs of the State. Some of the health workers in these facilities were kidnapped but later released. As a result of the attacks, the State Government made plans to renovate one health centre in each of the 361 wards across the State.



Insecurity has been an issue of paramount concern in Nigeria in recent years. Kidnappings, killings, farmers-herders clashes, banditry have been on the increase, raising trepidation among citizens and residents, in going about their daily activities, including travelling to various locations in the country. Some of the rights violated by the menace of insecurity are contained in Chapter 4 of the 1999 Nigerian Constitution and these include the right to life, right to dignity of human person, right to liberty and the right to freedom of movement. While some interventions were recorded, the trend of insecurity still continued in the period under review.

#### **Security Interventions**

This quarter saw the release of more passengers of the Abuja-Kaduna train, who were abducted following a terrorist attack on the train on 28<sup>th</sup> March 2022. PLAC had issued a statement on 16<sup>th</sup> May 2022 calling for the intervention of the Federal Government to secure the release of the passengers. PLAC equally enjoined the National Assembly to bring to bear and fully exercise their constitutional responsibility of oversight of the Federal Government and its agencies charged with the responsibility of providing public services and defence of the country.

Nigerians have criticised the government for its inability to protect its citizens as part of its constitutional responsibility. It will be recalled that in the second quarter of 2022, particularly on 11<sup>th</sup> June 2022, the terrorists were reported to have released 11 abductees following negotiations by Tukur Mamu, a media consultant to Sheikh Ahmad Gumi, an Islamic cleric and self-acclaimed intermediary between the government and terrorists. Mamu is also the publisher of a media outfit, Desert Herald.

On 9<sup>th</sup> July 2022, seven of the abducted passengers of the Abuja-Kaduna train were released after 102 days in captivity. The released abductees included the son of Prof. Ango Abdullahi, Chairman of Northern Elders Forum (NEF), a socio-cultural group in Nigeria. Others were Bosede Olurotimi, Abubakar Zubairu, Alhassan Sule and Sadiq Ango Abdullahi, Muhammad Daiyabu Paki, Aliyu Usman and a foreign national of Pakistani origin, Dr. Muhammad Abuzar Afzal.

The terrorists also released three more abductees on 25<sup>th</sup> July 2022, shortly after releasing a video<sup>5</sup> where they were seen flogging some of the abductees and threatening to sell and kill the remaining hostages if their demands were not met. It is unclear what exactly these demands are. They also threatened to abduct President Muhammadu Buhari and the Kaduna State Governor, Nasir El-Rufai. Those released consisted of two males and one female. The circumstances surrounding the release of the passengers were not clear, as some of their family members disclosed that the terrorists asked for the sum of N100 million to secure the release of their loved ones.

After 125 days in captivity, five more hostages who were abducted in the Abuja-Kaduna train attack were released by their terrorist abductors on 2<sup>nd</sup> August 2022, making it the fourth batch of victims to have secured their freedom. Those released include Prof. Mustapha Umar Imam, Akibu Lawal, Abubakar Ahmed Rufai, Mukthar Shu'aibu and Sidi Aminu Sharif.

The terrorists had earlier released 11 victims in the first batch, seven victims in the second batch, three in the third and five victims in the fourth batch, leaving 35 victims in captivity at the time.

On 10<sup>th</sup> August 2022, seven more hostages were released, including a family of six and a woman. The family of six include Abubakar Garba, his wife, Maryam and their children - Ibrahim, Fatima, Imran and Zainab, who was one year and six months old at the time. Also, a 60-year-old woman, Aisha Hassan was released. She was said to have been released due to life-threatening health challenges. This brought the number of hostages being held by the terrorists to 32.

On 19<sup>th</sup> August 2022, four more hostages were released after spending four months in captivity. They include an 85-year-old woman, Halimatu Atta, her daughter, Adama Aliyu, Mohammed Sani Abdulmaji and Modin Modi Bodinga. Again, there was no mention as to whether ransom was paid for the release of the hostages. With the release of the sixth batch of four hostages, 23 hostages were still in the custody of the terrorists at the time.

On 7<sup>th</sup> September 2022, the Department of State Services (DSS), Nigeria's secret security agency, announced that its foreign partners had worked with it to intercept Tukur Mamu as a person of interest in Cairo, Egypt, on his way to Saudi Arabia, and returned him to Nigeria. The DSS stated that he was wanted to answer critical questions as part of investigations on some security matters in parts of the country.<sup>6</sup> No further details were provided about his arrest. It will be recalled that Mamu was at the forefront of negotiations for the release of the abducted passengers of the Abuja-Kaduna train.

A Federal High Court in Abuja sentenced a notorious kidnapper, Hamisu Bala, also known as Wadume, and two others, to seven years imprisonment on 22<sup>nd</sup> July 2022. Wadume was convicted of two of the 13-count charges against him and two others, bordering on escaping from lawful custody and unlawfully dealing in prohibited firearms. The court also convicted

Aliyu Dadje, a Police Inspector, who was the station officer at the Police headquarters at Ibi Local Government Area of Taraba State, to three years imprisonment for tampering with official records to conceal a crime. The charges followed the killing of three police officers and two civilians on 6th August 2019 by some soldiers. The policemen, who were from the Intelligence Response Team, Abuja, had arrested Wadume at Ibi before they were ambushed on the road and killed by military personnel.

Ten military officials who were charged in connection to the incident, and who were tried separated include: Captain Tijjani Balarabe; Staff Sergeant David Isaiah; Sergeant Ibrahim Mohammed; Corporal Bartholomew Obanye; Private Mohammed Nura; Lance Corporal Okorozie Gideon; Corporal Marcus Michael; Lance Corporal Nvenaweimoeimi Akpagra; Staff Sergeant Abdulahi Adamu and Private Ebele Emmanuel.

The Nigerian Army in a statement on its official Twitter handle on 27<sup>th</sup> July 2022, announced that its troops rescued four women in Borno State. Two of them were identified as girls abducted from the Government Girls' Secondary School in Chibok, Borno State. Boko Haram terrorists had attacked the school and abducted 276 girls on 14<sup>th</sup> April 2014. The Army stated that the women were rescued by troops of 202 Battalion during a clearance operation and were taken for medical treatment.

Troops of Sector One, 'Operation Hadin Kai' of the Nigerian Army rescued a Chibok girl identified as Aisha Grema and her four-year-old child on 12<sup>th</sup> August 2022, in Bama Local Government Area of Borno State.

The Edo State Police Command on 14<sup>th</sup> August 2022, rescued one kidnap victim, neutralised five suspected kidnappers and recovered arms and ammunition from them. The Command disclosed that it received information about kidnappers operating in Ughoshi-Afe bush, Ibillo in Akoko Edo Local Government Area of Edo State. The suspected kidnappers on sighting the security operatives reportedly opened fire on them, resulting in a shoot-out in which five of the assailants were killed. One kidnap victim, a 38-year-old man was rescued unhurt and re-united with his family.

On 13<sup>th</sup> August 2022, the Nigerian Army stated that three persons amongst whom was a 12-year-old child who was abducted since her infancy, were rescued by troops of 242 Battalion.

On 20<sup>th</sup> August 2022, the Edo State Police Command in collaboration with men of the vigilante group and hunters, laid ambush at Iyuku Forest where they killed a suspected kidnapper, rescued four abducted victims while other members of the gang escaped with various degrees of gunshot injuries. The Police acted on information from a victim who escaped from the kidnappers' den on 18<sup>th</sup> August 2022.

On 8<sup>th</sup> September 2022, the Defence Headquarters in a statement by its Director, Defence Media Operations, Major General Musa Danmadami, revealed that troops of 'Operation Hadin Kai'<sup>7</sup> arrested a terrorist informant in the Asokoro area of the Federal Capital Territory, Abuja. Also, a foreign terrorist logistics supplier and arms dealer identified as Abatcha Bukar and 13 other terrorists were arrested in Borno State. According to the statement disclosing some of the activities of the armed forces between 25<sup>th</sup> August and 8<sup>th</sup> September 2022, three abducted Chibok girls and 19 other kidnap victims were rescued within the period.

Troops of the Nigerian Army rescued one of the Chibok schoolgirls abducted by insurgents in 2014. The girl, identified as Yana Pogu, was rescued on 29<sup>th</sup> September 2022 in Borno State by the troops of the Nigerian Army under 'Operation Hadin Kai.' Pogu, who was rescued with her four children, had birthed a set of twins four months earlier.

On 13<sup>th</sup> September 2022, the Edo State Police Command reported that it killed three out of a six-man kidnapping gang who abducted a 13-month old baby in Achigbor Community along Benin – Auchi road in Uhunmwonde Local Government Area of Edo State. According to a statement by the State Deputy Spokesperson of the Command, ASP Jennifer Iwegbu, the Police got a tip off from the mother of the baby before going after the kidnappers. In the course of a shootout, the Police killed three of the assailants and the baby was rescued unhurt and returned to the mother.

On 17<sup>th</sup> September 2022, scores of armed bandits were reportedly killed as the Nigerian Air Force (NAF) bombed their base in Zamfara State. The victims were said to be members of the gang of notorious banditry kingpin, Muhammad Bello, aka Turji. Turji narrowly escaped the bombardment. The attack was carried out at Fakai area where Turji was suspected to be residing following reliable intelligence.

The Police in Jigawa State in collaboration with a local vigilante group arrested two suspected kidnappers in Taura Local Government Area of the State on 18<sup>th</sup> September 2022, following reliable intelligence. They were arrested during a special operation in Larabawa village, Gabasawa area of Kano State and Larabar Gurgunya village in Taura, Jigawa State. The Police Public Relations Officer, DSP Lawan Shiisu, confirmed the arrest, stating that the suspects were believed to be members of a criminal gang that had been terrorising parts of the State and neighbouring Kano State. He added that preliminary investigation showed that the suspects were responsible for an attack on personnel of the Nigeria Immigration Service on 9<sup>th</sup> August 2022.

On 22<sup>nd</sup> September 2022, Justice Adenike Coker of the Lagos High Court, Ikeja sentenced a dismissed cop, Olalekan Ogunyemi, to life imprisonment for killing a football fan, Kolade Johnson. Ogunyemi, who was attached to the Special Anti-Cultism Squad of the Nigeria Police, shot Johnson in the lower abdomen on 31st March 2019, at a football viewing centre at Mangoro, Ikeja, Lagos. Johnson was watching a football match when he was shot and killed.

The Edo State Police Command, on 22<sup>nd</sup> September 2022, killed a suspected kidnapper in Obadan community along the Benin-Auchi Road, in Edo State. The Edo State Police Command explained that two victims of the kidnapper, Samson Osegbowa, 65 and Stanley Peters, 38 who were abducted while working on their farmland at Ago-Orio, Uhunmwonde Local Government Area of the State were also rescued.

Operatives of the Ogun State Police Command invaded the hideout of kidnappers who had been terrorising Kara Bridge end of Lagos-Ibadan

expressway and arrested a member of the gang, while a victim, Sheu Anafi was rescued unhurt. The Police invaded the kidnappers' hideout following a report lodged at Warewa Divisional headquarters by a commercial driver, who reported that he was coming from Ilorin with seven passengers, when they were attacked by some gunmen, which caused the passengers to run into a nearby bush. However, when they all regrouped to continue their journey, it was discovered that one of the passengers, 62-year old Sheu Anafi had been abducted by the gunmen.

#### **Violent Attacks**

Suspected terrorists operating in the forest area of Danmusa Local Government Area of Katsina State, shot and killed Bara'u Dantudu, the Dandire 'B' ward Chairman of a Nigerian political party, the Peoples Democratic Party (PDP), while he was on his farmland on 30<sup>th</sup> September 2022.

Hoodlums numbering about 50 attacked members of the Bauchi State House of Assembly on Monday, 4<sup>th</sup> July 2022, at a guest house located close to the Assembly complex, where the lawmakers were holding a meeting. They injured six members, smashed cars and windows of the building. Hours earlier, some as unidentified persons had attempted to set the House of Assembly complex ablaze but were intercepted by security agencies.

Gunmen kidnapped two Catholic priests, Reverend Father Udo Peter of St. Patrick's Catholic Church, Uromi, and Reverend Father Philemon Oboh of St. Joseph Retreat Centre, Ugboha in Edo State on 2<sup>nd</sup> July 2022, around Ehor and Iruekpen communities along the Benin-Auchi expressway in Edo State.

On 4<sup>th</sup> July 2022, at least 12 persons, including nine bandits and three members of a vigilante group were killed in a clash between bandits and vigilantes in Zak community of Wase Local Government Area of Plateau State. Operatives of 'Operation Safe Haven' (OPSH) of the Nigerian Army repelled the attack and moved on to Gajin Bashar community to fight

bandits who had stormed the area to attack the people.

An advance convoy of Nigeria's President, Muhammadu Buhari was ambushed and attacked on 5<sup>th</sup> July 2022 along Dutsinma on its way to the President's hometown, Daura in Katsina State. The advance team comprised security guards, protocol and media officials. The attackers opened fire on the convoy but were repelled by personnel of the military, Police and Department of State Services (DSS) accompanying the convoy. Two persons in the convoy were reported to have sustained minor injuries, although the convoy eventually arrived Daura safely.

On 5<sup>th</sup> July 2022, the Kuje Medium Security Custodial Centre in Abuja was raided by terrorists, who gained access to the facility using explosives. They were reported to have freed 879 inmates, including Boko Haram terrorists who were held in the facility. According to the Nigeria Correctional Service, one personnel of the Nigerian Security and Civil Defence Corps (NSCDC) and four inmates were killed in the attack, while 16 other inmates sustained injuries. By the following day, 6th July 2022, about 400 inmates were reported to have been recaptured while about the same number of inmates were still at large.

The Islamic State in West Africa Province (ISWAP) terrorist group claimed responsibility for the attack. In a short video reported to have been released on 6<sup>th</sup> July 2022, the group stated that it succeeded in freeing dozens of prisoners.<sup>8</sup>

On 15<sup>th</sup> July 2022, a seven year-old boy identified as Ayuba was killed, while a couple was injured by stray bullets when bandits attacked Paikon Basa community in Gurdi ward of Abaji Area Council of the Federal Capital Territory (FCT). The bandits abducted four residents, raided some shops and carted food stuff away. The bandits were reported to have proceeded to neigbouring Mawogi community, two kilometers away from Gasakpa, where they abducted six villagers.

Terrorists in large numbers invaded Yakwada village in Giwa Local Government Area of Kaduna State and kidnapped an in-law to Prof. Ango Abdullahi, Convener of the socio-cultural group, Northern Elders' Forum, her four children, and other persons on 10<sup>th</sup> August 2022. The terrorists abducted at least nine persons in total and killed a patrol guard, Aminu Lawal in the process.

The abducted woman, Ramatu Samsila, is the wife of the Village Head of Yakawada, Rilwan Saudu, who is the son of Professor Abdullahi's elder brother, a former Vice Chancellor of the Ahmadu Bello University, Zaria in Kaduna State. Some of those abducted include neighbours of the Village Head, two of whom were nursing mothers at the time. Three residents of the area also sustained injuries in the attack.

Gunmen abducted a Catholic priest and a seminarian along Okigwe-Umunneochi Road, between Imo and Abia States in South-East, Nigeria on 12<sup>th</sup> August 2022. The abducted priest, Chinedu Nwadike, is the Deputy Registrar of Spiritan University, Abia State and he was abducted alongside a Catholic seminarian, Emmanuel Nwafor on their way to Enugu State. According to the Director of Communication of the Enugu Catholic Diocese, Benjamin Achi, the kidnappers demanded N50 million ransom.

Four reverend sisters were abducted by gunmen in the Okigwe-Umulolo axis of Okigwe Local Government Area of Imo State on 21<sup>st</sup> August 2022. They were abducted on their way to a thanksgiving mass in the Okigwe area. Zita Ihedoro, Secretary-General of The Sisters of Jesus The Saviour Generalate, confirmed their abduction in a press statement. The kidnapped persons were identified as Johannes Nwodo, Christabel Echemazu, Liberata Mbamalu and Benita Agu. However, they were later released unconditionally on 23r<sup>d</sup> August 2022, two days after their abduction, according to the Generalate.

On 1<sup>st</sup> September 2022, the village head of Zarada Sabuwa village in Gagarawa Local Government Area of Jigawa State, Ahmad Muhammad, and his wife Hauwa Ahmadu were killed by their son, Munkaila Ahmadu. The suspect was also reported to have injured two others in the community.

The Police arrested the suspect took him into custody and commenced an investigation. Munkaila Ahmadu disclosed that he killed his parents because they uttered what he described as blasphemous comments against the Prophet Mohammed (SAW). He further explained that his parents mocked him and opposed him being a praise singer for the Prophet.

An employee of the Independent National Electoral Commission (INEC) in Anambra State, Duruocha Joel who was reported missing, was found dead on Isu-Aniocha-Urum road, Awka North Local Government Area of Anambra State, on Thursday, 29<sup>th</sup> September 2022. Joel was a Principal Executive Officer II on Grade Level 10 at INEC. The development was disclosed in a statement by INEC's National Commissioner and Chairman Information and Voter Education Committee, Festus Okoye, on Friday, 30<sup>th</sup> September 2022. The cause of his death was unknown at the time of the report.

#### **Attacks on Security Agents**

On 5<sup>th</sup> July 2022, an Assistant Commissioner of Police, Aminu Umar and another police officer were killed in a terrorist ambush in Dutsinma, Katsina State. They were part of a team on a clearance operation in the area when they were attacked by terrorists numbering over 300 on motorcycles, shooting sporadically.

On 20<sup>th</sup> July 2022, five policemen and three civilians were killed, many others injured and an unspecified number of animals rustled by terrorists in an attack on Gatigawa village in Kankara Local Government Area of Katsina State. The terrorists numbering over 300 were said to have stormed the community on motorcycles. The policemen were on special duty in Katsina State from Kano State.

On 22<sup>nd</sup> July 2022, gunmen ambushed some officials of the 7 Guards Battalion of the Nigerian Army Presidential Guards Brigade around the Bwari Area Council of the Federal Capital Territory (FCT), Abuja, killing eight personnel and leaving three others wounded. Two of the slain personnel were officers, including a captain and lieutenant, while the

others were soldiers.

However, the military reinforced and returned to the area of the attack to conduct a 'clearance patrol' between 24th to 26th July 2022. At the end of the exercise, it was reported that at least 30 terrorists were killed, and their hide out destroyed, according to the Defence headquarters. They also recovered six motorcycles, two AK47 rifles, one fully loaded LMG magazine, amongst others during the operation.

Armed bandits attacked a military base, Forward Operating Base in Mutumji, Dansadau Local Government of in Zamfara State on 10th September 2022, killing at least a dozen security personnel while three sustained injuries. Those killed include nine Air Force personnel, two Police personnel and one Nigerian Army personnel. The bandits also carted away weapons, other equipment and set the base ablaze. The incident was said to have occurred amid heightened offensive by security forces against bandits in the North-West region of Nigeria. Several bandits were killed and many arrested in several operations, which necessitated the shutdown of telephone networks in Zamfara and some parts of Katsina State.

On 11<sup>th</sup> September 2022, gunmen attacked the convoy of Senator Ifeanyi Ubah, representing Anambra Senatorial District, in Enugwu-Ukwu community in Njikoka Local Government Area of Anambra State, Nigeria's South-East. Five persons, including two Police personnel and three civilians, two of whom were the Senator's aides were killed in the attack. Two other police personnel were injured in the attack.

According to a statement by the Nigeria Police on 22<sup>nd</sup> September 2022, a human rights activist, Zainab Duke, and her domestic staff were arrested based on an allegation of assaulting a female Police officer, Inspector Teju Moses, who was assigned to the activist as an orderly. A video of the injured Police officer went viral on 21<sup>st</sup> September 2022 when the incident was said to have occurred, within the Area 11 axis of Abuja.<sup>9</sup>

After two years and 10 months, the Nigerian government has been ordered by the Economic Community of West African States (ECOWAS) Court of Justice to compensate the family of deceased Kogi State Women leader of the People's Democratic Party (PDP), Mrs. Salome Acheju Abuh, with the sum of N10 million. Mrs. Abuh was burnt alive by political thugs at her residence in Ochadamu, Kogi State during the governorship election in Kogi State on 16<sup>th</sup> November 2019. Following her murder, her family members instituted a fundamental rights lawsuit against the Nigerian government at the ECOWAS Court of Justice. The Court held the Nigerian government liable for neglect and failure to protect Mrs. Abuh's life. It held that security operatives who were present at the time of the attack failed to act and save her.

The issue of gender-based violence remains a major concern in Nigeria's human rights sphere. Between 27<sup>th</sup> and 28<sup>th</sup> August 2022, youths from Umueghu in Amaegbuato autonomous community, Nkpa in Bende Local Government Area of Abia State were reported to have tied up, flogged and tortured a widow from the area, Amarachi Okechi over allegations of witchcraft. She was accused of being a witch and being responsible for the death of her husband and the illness of her husband's niece. However, by 30<sup>th</sup> August 2022, it was reported that the woman was rescued through the joint efforts of the Abia State House of Assembly member representing the area, Hon. Emmanuel Ndubuisi, the wife of the State Governor, Nkechi Ikpeazu and the Gender-Based Violence Resource Centre in the State and

taken to hospital for treatment. In addition, law enforcement agencies were notified of the incident. A similar incident occurred in Ebbaken comunity, Boje in Boki Local Government Area of Cross River State, where two widows, Martina Osom and Rose Akon were tortured and beaten to death by youths in the community on allegation of practising witchcraft.<sup>10</sup>

On 3<sup>rd</sup> September 2022, two suspected fraudsters, Rotimi Fisher and Sherif Adebayo defrauded a 23-year-old lady in the Ipaja area of Lagos State. They also lured her to an uncompleted building where Adebayo was reported to have raped her. She was on her way to a destination in Iyana Ipaja when Fisher approached her to help him locate an address. He was said to have presented himself as a foreign businessman, seeking the address of a purported client. He was then joined by Adebayo who pretended to be assisting with locating the address.

On 26<sup>th</sup> September 2022, a four-year old girl, Khadijah Adam, was reportedly raped by 49-year-old neighbor, Baba Idi, a resident of Lungun Haliru Mai Ruwa, Gama Quarters, Nassarawa LGA, Kano. Khadijah revealed to her mother that the perpetrator threatened to kill her with a pair of scissors if she told anyone about the incident. According to reports, Khadijah became hysterical upon sighting Idi at a Police cell where they had gone for identification. She suffered a heart attack and died. Khadijah's parents, Muhammad Adam and Jamila Adam called on security agencies and other relevant stakeholders to ensure that justice prevails.

As part of its constitutional duty to protect life and property and ensure equality of all persons, government ought to take steps to apprehend and prosecute persons committing gender-based violence.

The incidents documented in this report reflect continued challenges with human rights violation in Nigeria, including violation of the right to education, employment, insecurity, among others.

The strike action by staff of public universities in Nigeria over issues of emoluments and the general operation of universities has lingered and needs to be adequately addressed. The strike action is a barrier to the right of students to quality education. The Federal Government's decision to withhold the salaries of striking workers for the period of their industrial action is a violation of their employment rights and their right to protest unfavourable working conditions. The public tertiary education system in Nigeria requires an overhaul, to adequately address the gaps in the system that stand as barriers to the rights of students to obtain quality education and the rights of lecturers and other university staff to gainful employment.

Insecurity is perhaps Nigeria's greatest challenge at this time, particularly the menace of terrorism, banditry and kidnapping. The attack on the President's advance convoy in his home State, Katsina and the raid by terrorists on the Kuje Custodial Centre on the same day, constitute an affront on the Nigerian government and cast doubts on its ability to secure the lives of citizens. Although not the first jailbreak in recent times, the attack on the Kuje Custodial centre in Nigeria's Federal Capital Territory by members of a terrorist group went on unabated for hours, with the assailants aiding the escape of hundreds of inmates. It is further worrying that the raid took place despite intelligence of an impending attack, which was earlier provided by Nigeria's State Secret Service. A day after the attack, it was reported that over half of the escapees were recaptured, while search for the others was on-going. These missing inmates who may have reintegrated into society or are still on the run, constitute a security threat to other Nigerian citizens and residents. The attack on the Presidential Guards Brigade of the Nigerian Army in Bwari, Abuja a few weeks after these incidents exacerbated security concerns in the Federal Capital Territory, Abuja.

The Nigerian constitution guarantees the right to life. Yet, the government appears unable to guarantee this basic right. The levels and extent of insecurity in the country is mind boggling. The government needs to live up to its constitutional responsibility to protect its citizens.

The award of compensation to victims and families of deceased victims of police brutality, by the Independent Investigative Panels on Human Rights Violations against the Special Anti-Robbery Squad (SARS) and other units of the Nigerian Police set up in Abuja by the National Human Rights Commission, is a welcome development. The panel also indicted 71 Police personnel in its recommendations.

Interventions in human rights protection in Nigeria appear to be occurring at a rather slow pace. Sustained efforts from stakeholders in government, civil society and the private sector are required to improve upon this, to cut across the vast variety of rights.



Following from the human rights trend observed in the third quarter of 2022, PLAC makes the following recommendations:

- i. The Nigerian government should develop a holistic approach to fund tertiary education institutions, in order to put a lasting end to the frequent strike action by lecturers and other university staff and to develop infrastructure in these institutions.
- ii. The Federal Government should launch a thorough investigation, to identify and apprehend the actors responsible for the attack on the Kuje Custodial Centre and bring them to account. The government should also ensure that all inmates who escaped in the attack and in other attacks on custodial centres across the country are tracked and recaptured.
- iii. Federal and State Governments should make all necessary efforts to ensure that compensation awarded to victims of police brutality by the panels set up in the States and the Federal Capital Territory to review cases of police brutality, are paid expeditiously.
- iv. It appears that there are on-going efforts by Nigerian security agencies to tackle violent criminal attacks. However, reports of terrorist attacks, kidnapping and banditry continue to mount on a daily basis. It is imperative that security forces intensify efforts in

their operations and take firm control of the security situation in the country, in order to restore citizens' confidence in their abilities.

v. Incidents of gender-based violence identified in this report means that there is an important need for the government to expand awareness and create education aimed at reducing or totally eliminating the problem.

	Chairman, Information and Voter Education Committee of INEC,Festus Okoye, disclosed this on Monday, 4th July 2022 in Abuja. According to Okoye, the Resident Electoral Commissioner (REC) Enugu State, Mr. Emeka Ononamadu, informed the INEC headquarters that during the attack, 748 ballot boxes, 240 voting cubicles, office furniture and other equipment were destroyed in spite of the best effort of the Enugu State Fire Service deployed from Nsukka. Okoye also stated that, "The commission is working to ascertain the status of voter registration machines for the ongoing Continuous Voter Registration (CVR) exercise, as well as uncollected Permanent Voters Cards (PVCs) locked up in the fireproof cabinet." He also stated that the incident has been reported to the Nigeria Police for investigation and further action.
