**MOTION FOR RE-COMMITAL**

1. Re-Committal of the Federal University of Medicine and Medical Sciences, Abeokuta Ogun State (Establishment) Bill, 2023 to the Committee of the Whole.

Sponsor: Sen. Gobir, Ibrahim Abdullahi (*Sokoto East-Senate Leader*).

*The Senate:*

*Recalls* that the Federal University of Medicine and Medical Sciences, Abeokuta Ogun State (Establishment) Bill, 2023

was passed by the National Assembly and was transmitted to the President for assent;

*Observes* that some fundamental issues which require fresh legislative action by both Chambers of the National Assembly emerged after a critical analysis of the Bill by Mr, President C - in - C;

*Aware that a Technical Committee of the Senate and House of Representatives and Directorate of Legal Services met and worked on the Bill;*

*Relying on order 1(b) and order 52(6) of Senate Standing Order, 2022 as amended.*

*Accordingly resolves to:*

*Rescind its decision on the Bill as passed and re-commit same to the Committee of the Whole for re-consideration and passage.*
