AN ACT TO ALTER THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA, 1999 TO DELETE THE ITEM "PRISONS" IN THE EXCLUSIVE LEGISLATIVE LIST AND REDESIGNATE IT AS "CORRECTIONAL SERVICES" IN THE CONCURRENT LEGISLATIVE LIST ; AND FOR RELATED MATTERS.

[3rd day of March, 2023] Commencement ENACTED BY THE National Assembly of the Federal Republic of Nigeria-1. The Constitution of the Federal Republic of Nigeria, 1999 (in this Act Alteration of referred to as "the Principal Act") is altered as set out in this Act. the Constitution 2. The Second Schedule to the Principal Act is altered in — Alteration of the Second (a) Part I, by deleting item 48 "Prisons"; and Schedule (b) Part II, by inserting after paragraph 10, a new paragraph "10A"— "10A Correctional Services : (1) The National Assembly may make laws for the Federation or any part thereof with respect to ----(a) correctional service and the establishment in any part of the Federation of correctional centres and custodial facilities; and (b) the establishment of any authority for the management of federal correctional centres and custodial facilities in any part of the Federation.

(2) A House of Assembly may make laws for the State with respect to ----

(a) correctional service and the establishment in that State of correctional centres and custodial facilities; and

(b) the establishment in that State of any authority for the management of State correctional centres and custodial facilities in any part of that State".

3. This Act may be cited as the Constitution of the Federal Republic of Citation Nigeria, 1999 (Fifth Alteration) (No. 15) Act, 2023.
