AN ACT TO ALTER THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA, 1999 TO DELETE THE REFERENCE TO THE PROVISIONS OF THE CRIMINAL CODE, PENAL CODE, CRIMINAL PROCEDURE ACT, CRIMINAL PROCEDURE CODE OR EVIDENCE ACT; AND FOR RELATED MATTERS.

Commencement

ENACTED BY THE National Assembly of the Federal Republic of Nigeria—

1. The Constitution of the Federal Republic of Nigeria, 1999 (in this Act referred to as "the Principal Act") is altered as set out in this Act.

2. Section 254F of the Principal Act is altered by deleting subsection (2).

3. This Act may be cited as the Constitution of the Federal Republic of Nigeria, 1999 (Fifth Alteration) (No. 9) Act, 2023.
