5. Privilege

Rising on Order 10 of the Senate Standing Orders, 2022 (as amended), Senator Solomon Adeola Olamilekan drew the attention of the Senate to an interview that was aired on Channels Television in which a Distinguished Senator asserted that members of the 9th National Assembly removed office equipment from their offices at the end of their tenure in June, 2023. Senator Olamilekan stated that it is usually the practice in the National Assembly that at the end of the tenure, the Management of the National Assembly notifies members that they had an option to purchase the equipment in their offices which would have depreciated in value in the last four years. The members, either elect to pay directly for the equipment or have the cost deducted from their severance allowance before they were allowed to remove them from the offices. He thus viewed the assertions of the Distinguished Senator in the interview as a breach of his privilege and that of the Senate. He therefore urged the Senate to mandate the Distinguished Senator concerned to apologise to the Senate over the erroneous impressions created by the assertions he made in the interview.

By the Leave of the Senate, Senator Adams A. Oshiomole (Edo North) duly apologised to the Senate in order to resolve the issue.

6. Matter of Urgent Public Importance: Walk

Rising on Orders 41 and 51, of the Senate Standing Orders, 2022 (as amended) Senator Olalere Kamorudeen Oyewumi (Osun West) drew the attention of the Senate to the "Urgent Need to Intervene in the Devastating Flooding Incident in Ikire, Apomu and Gbongan Areas of Osun State". He sought and obtained the leave of the Senate to present the matter forthwith:

The Senate:

notes that, the forecast of NIMET predicted that the level of rainfall in 2023 will be greater than that of 2022 and that over 180 local Government Areas in 32 States (including Osun state) fall within the high flood risk; his because in

also notes that in the last 20 years, the Ikire-Apomu and Gbongan communities have never experienced these kind of erosion that ravaged the communities, due to a heavy rainfall between Friday 21st and Saturday 22nd July 2023;

further notes that Ibadan-Ife Express road passes through Ikoyi-Apomu-Ikire and Gbongan towns. The tributaries of many streams from these towns, enters the Osun River at Asejire dam thereby making the area marshy and waterlogged always;

aware that the said Ibadan-Ife Express road reconstruction has been awarded to KOPEK Construction Company since 2019; However, the speed of work on the road is not encouraging;

concerned that, the heavy flood in these towns has destroyed properties worth several millions of Naira, many households have been displaced and motorists along the road were stranded for a whole day; and

further concerned that, if the spate of this flooding is not immediately checked, when the rainfall really starts in September to November this year, it could lead to unimaginable damages, to lives and properties. The road which is the 2nd busiest road in South West Nigeria (after Lagos-Ibadan road) may also become impassable.

also observes that the Commission in line with its mandate has requested the general public for comments on the rate review applications by the distribution licensees; while advising interested stakeholders to review and take into consideration the excerpts of the Rate Review Applications filed with the Commission by the respective licensees;

aware that as part of Nigerian Electricity Regulatory Commission (NERC) rule-making process and in the exercise of the powers conferred by the Electricity Act 2023, the Commission is empowered to conduct a Rate Case Hearing on the applications prior to making a ruling:

also aware that Nigerian Electricity Regulatory Commission (NERC) had through its official website published and set 20th July, 2023, deadline for comment by stakeholders;

worried that within the last 10 years, billions of naira were spent by Senators across Nigeria in the procurement and installation of transformers through various Zonal Intervention Projects (ZEPs) as a result of request in Senators' various Constituencies;

also worried that when these transformers are supplied and installed they become registered properties of the Discos (a privately owned enterprise); while sadly same Discos have consistently refused to energize such transformers on the ground that affected communities have to pay millions of naira arrears of bills for electricity never consumed while keeping the affected consumer in perpetual darkness;
