Matter of Urgent Public Importance: 7.

Rising on Orders 41 and 51, Senator Yar' Adua Abdulaziz Musa (Katsina Central) drew the attention of the Senate to the Urgent Need to Investigate the Abuse of Firearms by Officers of Nigeria Customs Service in Katsina State, He sought and obtained the leave of the Senate to present the matter forthwith:

The Senate:

aware that the Nigeria Customs Service (NCS) is authorized to carry firearms in the course of their duties. This is aimed at assisting the service to effectively counter activities of smugglers who have recently become embeddened in their attack on customs personnel in many cases using sophisticated weapons;

worried that some officers of the NCS who should be civil and professional in their engagements and handling of firearms have had a series of shootings of innocent citizens;

recalls that on 14th August, 2021, the former Governor of Katsina State, Rt. Hon. Aminu Bello Masari, threatened to sue the NCS over the killing of residents during border drills in the State. During this same period, the House of Representatives invited the former Comptroller General of Customs Col. Hamid Ali (Rtd) to appear before it to explain the circumstances leading to that unfortunate incident;

disturbed by the recurring killings of innocent people by customs operatives in Katsina, the

further disturbed that on 13th July; 2023, the Chief of Staff to the Katsina State, Governor Alhaji Jabiru Tsauri had a narrow escape from a harrowing assault from (NCS) officials;

worried that officers of the NCS at a location near Gorar Yammama highway shot indiscriminately at the vehicle conveying the Chief of Staff to the governor with other aides and close family members;

concerned that officials of the NCS are yet to apprehend or arrest the erring officers or bring them to book for the unfortunate incident;

recalls that in September 2021, personnel of the NCS shot at the convoy of the former Katsina State Commissioner for Local Government and Chieftaincy Affairs, Alhaji Umar Gwajo-Gwajo while driving from Daura to Mia adua Local Government Area of Katsina State; and

worried that the inability to checkmate this recurring abuse of firearms by officials of the NCS might lead to loss of innocent lives and possibly reprisal attacks by angered civilians.

notes with sadness concomitant loss of lives as a result of the bad state of the roads, as evidenced by the chilling statistics reeled out by the Federal Road Safety Commission which is a price too high and too prohibitive to pay.

Motion made: That the Senate notes the public uproar over the unabated violation of Chapter 4, Section 42 (2) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), which guarantees every citizen the rights to freedom from discrimination:

cognizance that the Black's Law Dictionary, Ninth Edition, defines discrimination as a differential treatment, especially a failure to treat all persons equally when no reasonable distinction can be found between those favoured and those not favoured, while the International Labour Organisation defines employment discrimination in economic terms, as a violation of human right that entails a waste of human talents with detrimental effects on productivity and economic growth, and generates socioeconomic inequalities that undermine social cohesion and solidarity and act as a brake on the reduction of poverty;

pathetic that a graduate in Nigeria who could not get a job upon graduation and decided to go back to school with the hope that a higher qualification, vis-a-vis a second or Masters Degree could give him a better employment opportunity is thrown into a career paradox when upon completion of his Masters Degree he comes out to find that he is now above the age of employment and therefore not employable by the sole reason of his age;

ironical that a graduate in this country can serve in the National Youth Service Corps Program at age 30 but cannot be gainfully employed thereafter on the fact that he/she is above 30 years, a situation that is a flagrant breach of his or her fundamental human rights; and

notes further that the circumstances described in the foregone presents the predicament of the Nigerian youth who has the requisite qualification, knowledge, skills and is ready to work but disqualified or excluded on the sole and unjustifiable ground that he/she is above the age limit by teason of his/her birth and this sad situation has led many to commit age fraud by going all way out to falsify their age to remain within the age limit of employability to the Nigerian Civil Service, and of course all other employer of labour in the country
