- (i) ***Abhorrent Abduction of Over 200 Students in Kuriga Community of Chikun and Secure Lives and Property in Kaduna State:***  
Hon. Munir Ahmed Mohammed (*Lere Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.*

**Abhorrent Abduction of Over 200 Students in Kuriga Community of Chikun and Secure Lives and Property in Kaduna State:**

The House:

*Notes* that on Thursday, 7 March, 2024, gunmen stormed Local Education Authority (LEA) Primary School and Government Secondary School in Kuriga Community where over 200 students and teachers have been forcibly abducted and moved to the forest unchallenged;

*Also notes* that two months back, this ugly menace occurred in the same community where a school Principal, Malam Abu Sufyan, was killed days earlier and his wife and baby abducted, though the wife and baby were later rescued in a successful joint security operation on 3 February, 2024;

*Aware* that on Friday, 8 March, 2024, gunmen attacked worshippers in a mosque at Angwar Makera, Kwasakwa Community in Birin Gwari Local Government Area of Kaduna State, with two persons declared dead;

*Also aware* that that this trend of violence is seeping into other parts of the State affecting persons of all religious and ethnic backgrounds;

*Concerned* that despite the 3.25 trillion Naira appropriation in 2024 Appropriation Act in the defence and security sector for acquisition of drones and other military equipment that could have tracked, located and rescued victims representing 11.8 percent of the national budget in 2024, yet, the security act as are reactionary rather than proactive;

*Also concerned* of the negative effect of the restrictive envelope system in the Budget process, which does not prioritize the actual needs assessment of the security sector on security procurement, planning and recruitment of personnel;

*Aware* that sometime in May 2014, the Nigerian Government with an initial ten million dollars, with another additional pledge of ten million dollars from coalition of Nigerian business leaders along with the United Nations Special Envoy for Global Education Gordon Brown launched the Safe Schools Initiative, whereby the fund is to be managed by the Federal Ministry of Finance, for protection of students and teachers in areas prone to security threats. "*The "Safe School Initiative" entails a combination of (1) school-based interventions; (2) community interventions to protect schools; and (3) special measures for at-risk populations*" A decade has gone by and yet the utilization and impact of this fund is at best questionable;

*Also aware* that the factors fueling insecurity ranges from illicit drug trade, human trafficking and proliferation of small arms is a serious threat to the development of Kaduna State and the Nation and therefore a coordinated effort encompassing all security apparatus and relevant agencies that include and not limited to Army, Navy, Air force, Police, Civil Defense, Immigration, Customs, NDLEA, DSS, DIA, NIA, Military Intelligence, Financial Intelligence Unit to track terrorism funding, NAPTIP, Refugee Commission anchored by the

Office of the National Security must quit working in silos and draw up and execute a comprehensive plan;

*Further aware* of the need for a Marshall plan on security with short-, medium- and longterm goals with specific timelines that holds security personnel found incapable accountable and to be replaced with capable hands;

*Cognizant* that Kaduna State borders the North-Western States of Zamfara, Katsina and Kano, borders the North-Eastern State of Bauchi and the North Central States of Plateau, Nasarawa, Abuja and Niger and therefore an isolated plan for just Kaduna alone will be ineffective without taking cognizant of border communities and even neighbouring countries of Cameroon, Chad, Niger, Benin Republic and the wider Sahel;

*Resolves to:*

- (i) observe a minute silence in honour of the deceased;
- (ii) urge the Office of the National Adviser (ONSA) to coordinate and galvanize all security and intelligence networks to develop and execute a proactive master plan to restore security with defined plans on coordinating with neighbouring countries and the plan must include boots on ground land and aerial sweep of locations that include but not limited to Kuyambana Forest in Zamfara, Kamuka Forest in Kaduna, Falgore Forest in Kano, Borgu and Zugurma Forests in Niger State;
- (iii) also urge the Office of the National Security Adviser (NSA), to revisit and optimize fully the Acts passed for the National Counter Terrorism Centre as well as The National Centre for the Control of Small Arms and Light Weapons , and ensure that they fully serve the purpose of their establishment;
- (iv) further urge the Executive Arm of Government to absolve the Military and Security establishment from the restrictive envelope budget system, allowing them to develop a robust budget that is based on need assessments that reflects security peculiarities and reality on ground;
- (v) mandate the Committee on Finance to investigate the utilization and effectiveness of the Safe School Initiative Fund and report within 4 weeks;
- (vi) also mandate the Committees on National Security, Finance, and Legislative Compliance to ensure compliance (*Hon. Ahmed Mohammed Munir — Lere Federal Constituency*).

Hon. Austin Asema Achado (*Gwer Esst/Gwer West Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.*

**Banditry Attack on Mbaikyor Community of Gwer East Local Government Area of Benue State:**

The House:

*Notes* that according to Section 14 2) (b) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), the primary objective of the State is the provision of maximum security of lives and properties of all citizens of our nation;

*Also notes* that, on Thursday, 7 March, 2024, between 4pm and 7pm, the Mbaikyor Community of Mbalom Council Ward in Gwer East Local Government Area was attacked by bandits, killing over 20 people including a 90-year-old set of twins, one of who was burnt beyond recognition and an 8-year-old child, who was cut into pieces;

*Further notes* that the bandits burnt down over fifty (50) houses including the village market and sacked the entire community leaving many with various degrees of injuries;

*Worried* that within the 3 hours that the attack lasted, there was no response from the security agencies, despite distress calls to the relevant government and security agencies by an indigene Barr. Ajinge Saa;

*Also worried* that the Nigerian Air Force Base, Makurdi is less than 30km to the Mbaikyor Community, while a Joint Military Security Task Force Check Point is less than 15km from Mbaikyor community. Sadly, the security forces only arrived the scene of the incident 20 hours after the bandits left;

*Further worried* that the marauding bandits have for a long time been left to operate in Benue State unhindered, built up the resilience, capacity and courage to go into communities, kill and burn down villages, without any resistance from security agencies;

*Perturbed* that as a result of the frequent baanditry, many farmers now have no access to their homes and farmlands;

*Also perturbed* that the farming communities of Mbaikyor in Benue State have known no peace as they are hindered from embarking on their daily means of livelihood as farmers;

*Concerned* with the loss of lives and the utmost implication of having farmers from Mbaikyor and across the farming regions of Benue State, without steady and peaceful settlements to practice their profession and livelihood of producing surplus food crops for the nation;

*Resolves to:*

- (i) observe a minute silence in honour of those who lost their lives;
- (ii) investigate the failure of the Nigerian Air Force Base, Makurdi and the Joint Military Security Task Force in Benue State in responding to the distress calls from Mbaikyor Community and other distress calls in the State, despite their proximity;
- (iii) urge the Joint Military Security Task Force stationed in Benue State to initiate full and coordinated security operations, with aerial surveillance and other necessary combat mission plans, to flush out the bandits around Mbaikyor and other banditry camps in Benue State, so as to allow the farmers to return to their farm lands to continue to ensure adequate food production within a secured environment;
- (iv) also urge the Executive Arm of Government to facilitate the return, resettlement, and rehabilitation of the victims;
- (v) further urge the National Emergency Management Agency (NEMA) to as a matter of absolute urgency, send relief materials to assuage the sufferings of the affected communities;
- (vi) mandate the Committees on Defence, and Police Affairs to investigate the deplorable condition of the Mbaikyor community and other communities faced by banditry attacks in Benue State and report within four (4) weeks (*Hon. Austin Asema Achado — Gwer East/Gwer West Federal Constituency*).

*Debate.*

*Agreed to.*

The House:

*Perturbed* that as a result of the frequent baanditry, many farmers now have no access to their homes and farmlands;

*Concerned* with the loss of lives and the utmost implication of having farmers from Mbaikyor and across the farming regions of Benue State, without steady and peaceful settlements to practice their profession and livelihood of producing surplus food crops for the nation;

*Resolved to:*

- (i) observe a minute silence in honour of those who lost their lives;
- (ii) investigate the failure of the Nigerian Air Force Base, Makurdi and the Joint Military Security Task Force in Benue State in responding to the distress calls from Mbaikyor Community and other distress calls in the State, despite their proximity;
- (iii) urge the Joint Military Security Task Force stationed in Benue State to initiate full and coordinated security operations, with aerial surveillance and other necessary combat mission plans, to flush out the bandits around Mbaikyor and other banditry camps in Benue State, so as to allow the farmers to return to their farm lands to continue to ensure adequate food production within a secured environment;
- (iv) also urge the Executive Arm of Government to facilitate the return, resettlement, and rehabilitation of the victims;
- (v) further urge the National Emergency Management Agency (NEMA) to as a matter of absolute urgency, send relief materials to assuage the sufferings of the affected communities;
- (vi) mandate the Committees on Defence, and Police Affairs to investigate the deplorable condition of the Mbaikyor community and other communities faced by banditry attacks in Benue State and report within four (4) weeks (**HR. 131/03/2024**).

*A minute silence was observed in honour of the deceased.*

(iii) ***Call on the Federal Government for the Salvation of People of Anyigba District in Dekina Local Government Area, Kogi State on the Incessant Armed Robbery Facing the Town:*** Hon. Paul Gowon Haruna (*Bassa/Dekina Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and

- (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.*

**Salvation of People of Anyigba District in Dekina Local Government Area of Kogi State on the Incessant Armed Robbery Facing the Town:**

The House:

*Notes* that Anyigba is a cosmopolitan town in the Eastern part of Kogi State and presently within Bassa/Dekina Federal Constituency which hosts the famous Prince Abubakar Audu University formerly known as Kogi State University. It is a central hub for commercial, educational and socio-political activities of the peace loving people of the Igala nation;

*Also notes* that Anyigba and its environs became a spectrum of attraction to criminals around the year 2000 when commercial activities became bullish due to the establishment of the State University. The hype in commercial activities, attracted prominent and numerous commercial Banks to Anyigba. This brought succor to the entire region as regards the financial inclusivity but this relief was soon truncated by armed robbery of unbearable magnitude;

*Further notes* that in 2007, there were two robbery incidences, in 2008, it had thrice of similar attacks, while in 2009, such attacks have risen to twelve banks. This led to an agonizing loss of over twenty five lives including some security personnel;

*Worried* that the armed robbers continued their attacks as they re-equipped themselves with high tech armament. In 2023 alone, Anyigba and Ankpa have had two major robbery attacks that claimed many lives and properties of immeasurable value; due to the menace of armed robberies, some Commercial Banks in the towns of Oguma and Shintaku in Bassa Local Government Area, Abejukolo the headquarters of Omala Local Government Area while Abocho in Dekina Local Government Area and Dekina town which is the headquarter of Dekina Local Government Area have shut down their operations while sizeable numbers of other commercial ventures had also closed down respectively. Undoubtedly, several measures to arrest the ugly situation have been undertaken by the Kogi State House of Assembly in collaboration with the State Commissioner of Police that resulted in the deployment of an Armoured Personnel Carrier to Anyigba town. But, regrettably, the cases of armed robbery are still on the increase with evident of resultant economic and social consequences;

*Aware* that on Thursday, 7 March, 2024, Anyigba was thrown into another chaotic situation.   - (c) establish an Army base in Anyigba that will serve the Nine Local Government Areas of Kogi East Senatorial Zone and its environs in order to forestall or abort similar incident that may occur in the future;
- (iii) mandate the Committees of Police Affairs, Army, National Security and Intelligence, and Defence to interface with the relevant security Agencies on the perennial cases of armed robbery and other related cases in Anyigba and report within four (4) weeks (*Hon. Paul Gowon Haruna — Bassa/Dekina Federal Constituency*).

*Debate.*

*Agreed to.*

*Noted* that Anyigba is a cosmopolitan town in the Eastern part of Kogi State and presently within Bassa/Dekina Federal Constituency which hosts the famous Prince Abubakar Audu University formerly known as Kogi State University. It is a central hub for commercial, educational and socio-political activities of the peace loving people of the Igala nation;

*Also noted* that Anyigba and its environs became a spectrum of attraction to criminals around the year 2000 when commercial activities became bullish due to the establishment of the State University. The hype in commercial activities, attracted prominent and numerous commercial Banks to Anyigba. This brought succor to the entire region as regards the financial inclusivity but this relief was soon truncated by armed robbery of unbearable magnitude;

*Further noted* that in 2007, there were two robbery incidences, in 2008, it had thrice of similar attacks, while in 2009, such attacks have risen to twelve banks. This led to an agonizing loss of over twenty five lives including some security personnel;

*Worried* that the armed robbers continued their attacks as they re-equipped themselves with high tech armament. In 2023 alone, Anyigba and Ankpa have had two major robbery attacks that claimed many lives and properties of immeasurable value; due to the menace of armed robberies, some Commercial Banks in the towns of Oguma and Shintaku in Bassa Local Government Area, Abejukolo the headquarters of Omala Local Government Area while Abocho in Dekina Local Government Area and Dekina town which is the headquarter of Dekina Local Government Area have shut down their operations while sizeable numbers of other commercial ventures had also closed down respectively. Undoubtedly, several measures to arrest the ugly situation have been undertaken by the Kogi State House of Assembly in collaboration with the State Commissioner of Police that resulted in the deployment of an Armoured Personnel Carrier to Anyigba town. But, regrettably, the cases of armed robbery are still on the increase with evident of resultant economic and social consequences;

*Aware* that on Thursday, 7 March, 2024, Anyigba was thrown into another chaotic situation. The very attacked was tagged the "Mother of all Robbery" (MOR) was experienced as they came in their large numbers with bombs and other sophisticated assaulted Rifles. They overran the Area Command, bombed the armoured personnel carrier, the Divisional Police Headquarters was not spared, a Police Officer and a member of vigilante group were killed. In the same vein, two other persons that were on their lawful businesses were also killed and several other wounded persons are undergoing medical treatment while three banks were robbed simultaneously;

*Resolved to:*

*Aware* that the Niger Delta Development Commission (NDDC) has proposed a paltry sum of (₦50,000,000) Fifty million Naira in the 2024 budget for the construction of the road, which sum is adjudged insufficient given the length, breadth and the kilometres of the road, construction of bridges and installation of streetlights;

*Conscious* that if the sum proposed for the construction of the road is not reviewed, the people of the communities will continue to be exposed to serious hardship, and the road will remain a death trap;

*Worried* that the Niger Delta Development Commission (NDDC) is embarking on other projects within the two Local Governments of Essien Udim and Obot Akara without first completing the road, which has more impact on the people as it traverses many communities;

*Concerned* that embarking on other projects by the Niger Delta Development Commission (NDDC) without first completing the road will lead to abandonment of many projects;

*Resolves to:*

*Aware* of the construction of an Oil Tank farm at the Nembe Creek flow station from where crude oil are transported via the St John/Rio Bento River, through Nembe, Brass, Okpoama and Beletiana, to the offshore crude oil storage facility in the Atlantic Ocean, 27km off the shoreline of the island of Brass;

*Worried* about the effects of the project on the environment and humans, in terms of shoreline erosion, accidents from collision of operational vessels and the possible loss of lives, massive crude oil spillage that will destroy the ecosystem, damage aquatic life with negative impact on the basic means of livelihood, which is fishing, the deforestation of the mangrove forests and the attendant noise pollution;

*Resolves to:*

- (i) urge the Federal Ministry of Environment to compel the Management of Aiteo E&P to conduct an environmental impact assessment of the project, as dictated by the Environment Impact Assessment Act, 2004, and include the host communities, the State Government and stakeholders, in line with international global practice, subject to scrutiny of the public and environmental experts;
- (ii) mandate the Committees on Environment and Petroleum Resources (Midstream) to:
  - (a) investigate Environmental Impact of Transporting Crude Oil by Mega Seagoing Vessels from Nembe Creek Trunk to Offshore Crude Oil Storage in the Atlantic Ocean by Aiteo E & P, and
  - (b) monitor compliance with the Ministry of Environment and the Management of Aiteo E&P with this requirement, and report within four (4) weeks (*Hon. Marie Enenimiete Ebikake — Brass/Nembe Federal Constituency*).

*Debate.*

*Agreed to.*

The House:

*Noted* the acquisition of OML29 from Shell Petroleum Development Company (SPDC) and the takeover of the Nembe Creek Trunk Line by Aiteo E&P in 2016;

*Also noted* the commencement of the transportation of crude oil using mega seagoing vessels by Aiteo E & P to reduce the distance of crude oil transportation through pipelines and drastically minimize the incidence of crude oil theft;

*Aware* of the construction of an Oil Tank farm at the Nembe Creek flow station from where crude oil are transported via the St John/Rio Bento River, through Nembe, Brass, Okpoama and Beletiana, to the offshore crude oil storage facility in the Atlantic Ocean, 27km off the shoreline of the island of Brass;

**22. Need to Establish Garri Processing and Storage facility in Otuokpoti, Ogbia Local Government Area of Bayelsa State**

*Motion made and Question proposed:*

The House:

*Notes* that food is essential to the existence of man and Garri is one of the staple foods in Nigeria that cuts across all tribes and social strata;

*Aware* that the people of Ogbia Federal Constituency in Bayelsa State are predominantly Cassava farmers, a major raw material in the manufacturing of Garri, Fufu, Cassava Flour, Farina Colloquially referred to as Kpokpo garri;

*Worried* that Farmers face significant losses due to inadequate storage facilities and limited production on small scales, while younger generations are discouraged by the rigorous manual procedures;

*Recognizes* that establishing a Garri processing and storage facility will reduce waste from cassava farm produce, encourage youth farming, reduce unemployment, boost economic conditions, and address the hunger crisis.

*Cognizant* that Bayelsa State government plans to upgrade its mini Garri processing facility due to outdated equipment and machinery, and to expand it to accommodate the growing population and neighbouring States;

*Resolves to:*

- (i) urge Federal Ministry of Agriculture, Fadama II to approve the construction of a Garri storage and processing facility to be located in Otuokpoti, Ogbia; and
- (ii) mandate Committees on Agricultural Production and Services, and Legislative Compliance to ensure compliance (*Hon. Mitema Obordor — Ogbia Federal Constituency*).

*Debate.*

In Prayer (i), immediately after the word “Ogbia”, *insert* the words “and the entire three hundred and sixty Federal Constituencies” (*Hon. Obinna Aguocha — Ikwuano/Umuahia North/Umuahia South Federal Constituency*).

*Question that the amendment be made — Negatived.*

*Question on the Motion as amended — Negatived.*
