(a) **Implementation of Resolutions:**

The President of the Senate announced that he had received two (2) letters from Mr. President, Commander-in-Chief of the Armed Forces of the Federation which he read as follows:

**REQUEST FOR SUPPORT IN THE IMPLEMENTATION OF THE RESOLUTIONS OF
ECONOMIC COMMUNITY OF WEST AFRICAN STATES (ECOWAS) ON THE POLITICAL
SITUATION IN NIGER REPUBLIC**

I present my modest compliments to the Distinguished Senate President and have honour to inform you that, following the unfortunate political situation in Niger Republic, culminating in the overthrow of the administration of His Excellency, President Mohammed Bazoum on 26th July, 2023, the Economic Community of West African States (ECOWAS) under my leadership, condemned the Coup in its entirety and resolved; alongside other members of the international community, to seek the return of the democratically elected government in Niger.

2. Consequently, and in a bid to broker peace and restore democracy in the country, the ECOWAS convened an Extra-Ordinary Summit of the Authority of Heads of State and Government on Sunday, 30th July, 2023 in Abuja. The body, consistent with African Union and ECOWAS Protocols on unconstitutional changes of Government, thereafter, issued a Communique (copy attached) on the line of action decided upon by member States. As chair of ECOWAS, Nigeria has the obligation to lead in the implementation of the directives outlined in the Communique and, as such, steps have been taken to give effect to the resolutions, therein.

3. Accordingly, the Distinguished Senate is invited to note the foregoing and the following actions expected of Ministries, Extra-Ministerial Departments and Agencies, including Military and Para-Military Agencies. These actions include:

- (a) Closure and monitoring of all land borders with Niger Republic and reactivation of the Border Drill Exercise.
- (b) Cutting off Electricity supply to Niger Republic.
- (c) Mobilizing international support for the implementation of the provisions of the ECOWAS Communique.
- (d) Preventing the operation of commercial and Special flights into and from Niger Republic.
- (e) Blockade of goods in transit to Niger Republic especially, from Lagos and Eastern Sea Ports.
- (f) Embarking on the sensitization of Nigerians and Nigeriens on the imperative of the action by ECOWAS particularly, via social media.
- (g) Military build-up and deployment of personnel for military intervention to enforce compliance of the Military Junta in Niger Republic should they remain recalcitrant.
- (h) Freezing assets of state enterprises and parastatals in commercial banks.

4. In the light of the foregoing, I wish to respectfully solicit the support of the National Assembly in the successful implementation of the ECOWAS Resolution as outlined in the attached Communique.

5. While looking forward to your usual cooperation, kindly accept, Distinguished Senate President, the assurances of my highest consideration and esteem.
