REQUEST FOR APPROVAL OF ADDITIONAL FINANCING OF THE NATIONAL SOCIAL SAFETY NET PROGRAMME (SCALE UP) BY THE NATIONAL ASSEMBLY

It is with pleasure that I refer the above matter to you. Please note that the Federal Executive Council led by President Muhammadu Buhari, GCFR ("FEC") approved an additional loan facility to the tune of USD 800,000,000 (Eight Hundred Million United States Dollars) to be secured from the World Bank for the National Social Safety Net Programme (the "Programme") (Copy of FEC Extract attached).

- You may also wish to note that the purpose of the facility is to expand coverage of 2. shock responsive safety net support for poor and vulnerable Nigerians and to help them cope with the cost of meeting basic needs.
- You may further wish to note that under the conditional cash transfer window of the 3. Programme, the Federal Government of Nigeria will transfer the sum of ₹8,000 per month to 12,000,000 (twelve million) poor and low income households for a period of 6 (six) months with a multiplier effect on about 60,000,000 (sixty million) individuals. In order to guarantee the credibility of the process, digital transfers will be made directly to beneficiaries' account and mobile wallets.

- 4. It is expected that the Programme will stimulate economic activity in the informal sector and improve nutrition, health and education outcomes for beneficiary households.
- 5. Given the above, I wish to invite the Senate to kindly grant approval for the additional loan facility of USD800,000,000,000 (Eight Hundred Million United States Dollars) to be secured from the World Bank for the National Social Safety Net Programme.
- 6. While hoping that this submission will receive expeditious consideration by the Senate, please accept, Distinguished Senate President, the assurances of my highest regards.
