**RESCISSION MOTION ON SENATE DECISION**

*The Senate:*

*Recalls* its debate on Wednesday, 3<sup>rd</sup> July, 2024 on a motion: "Urgent need to investigate the continued Importation of Hazardous Petroleum Products and Dumping of Substandard Diesel into Nigeria" moved by Sen. Asuquo Ekpenyong (Cross River North);

*Recalls also* its resolution on Thursday, 11<sup>th</sup> July, 2024 to recaption the title of the Ad-hoc Committee to "Ad-hoc Committee to Investigate Alleged Economic Sabotage in the Nigerian Petroleum Industry";

*Notes* that the House of Representatives debated on the same matter and also constituted an Ad-hoc Committee to investigate it; and

*Observes* that there is need for the Ad-hoc Committees of the two chambers to work jointly to avoid duplication and clash in the discharge of their assignment.

*Accordingly resolves to:*

1. Recaption the title to “National Assembly Joint Ad-hoc Committee to Investigate Alleged Economic Sabotage in the Nigerian Petroleum Industry”;
2. Communicate the decision to the House of Representatives for a composition of equal number;
