### **OVERVIEW OF THE LEGISLATIVE INTERNSHIP PROGRAMME**

Policy and Legal Advocacy Centre (PLAC) legislative Internship Programme began in 2013. The objective of the internship programme is to create a platform for young Nigerian graduates between eighteen to thirty-five years old to gain firsthand knowledge of the workings of the Nigerian Legislature and enhance youth engagement with the National Assembly.

Youths form a significant part of Nigeria's demography with statistics putting young peoples as a significant percentage of the population. Despite this young people are not usually integrated in governance and policy issues. To address the lack of access and knowledge gap, it is important that young persons are deliberately given access to democratic institutions, such as the legislature to help them understand high level policy and decision making.

The European Union EU has supported the annual internship programme since 2018 with about 227 interns passing through the internship. The 2023 edition of the Legislative Internship programme (LIP) ran between 3rd October 2023 and 13th December 2023 with Forty-one (41) interns drawn from Nigeria's six geo-political zones.

Interns were deployed to various committees of the National Assembly after an orientation ceremony. At the National Assembly, they were given the opportunity to attend plenary sessions and committee meetings, learn about Bills, and other legislative activities.

# Objectives of the Legislative Internship Programme

- To provide an opportunity for young Nigerians to gain theoretical and practical knowledge of the Nigerian Legislature
- To create better understanding and appreciation of the Nigerian Legislature
- To create an opportunity to increase youth/citizens participation and involvement in governance.
- To Encourage young professionals to gain skills and experience that would be helpful to career growth
- To provide support to legislative committees

# Eligibility Criteria

- First degree or equivalent in any discipline from a recognized tertiary institution
- Completion of National Youth Service Corps (NYSC) programme
- Good computer Skills
- Good verbal and writing Skills
- Aged between 18 and 35

# Some Responsibilities of Interns

# Selection Process

- Carrying out legislative and legal research
- Handling of correspondence and communications
- Attendance or observation of plenary sessions
- Assisting with organizing committee hearings and meetings
- Participating in bi-weekly capacity/team building sessions
- Participation at the Model Legislative Assembly (a reenactment of a National Assembly plenary session).

The LIP usually begins with an advertisement and the 2023 edition was no different. Adverts were placed in three National Newspapers in July 2023 which included ThisDay Newspaper, The Guardian Newspaper, Daily trust Newspaper. The advert was also circulated on PLAC's social media handles such as Facebook and Twitter. About 3,000 applications were received from applicants across the country. The internship is quite competitive with limited slots and at the end, 41 interns (20 women and 21 men) made it to the 2023 cohort. **PHOTO GALLERY OF INTERNS**





## 2.1 Welcome Reception

The welcome reception for the 2023 PLAC Legislative Interns was organised at the PLAC office on Tuesday, 3rd October 2023 to welcome the interns to the internship programme and promote team bonding among the cohort and members of the PLAC Staff.

Mr. Clement Nwankwo, Executive Director, PLAC, in his remark, recounted a brief history of how he started out as a Human Right Activist and the importance of being passionate about charting courses that lead to good governance and change in the society. He concluded by encouraging the interns to be of excellent conduct at the National Assembly.

Omolara Akinyeye, Deputy Executive Director, PLAC, guided the interns to make introductions and write out their expectations from the Internship Programme. Interns' expectations included; networking, becoming more informed about the legislative process, gaining exposure about the National Assembly, building career paths and forming long lasting professional relationships.



# 2.2 Orientation Workshop

The orientation session/workshop for the 2023 Legislative Interns held on Wednesday, 4th October to Friday, 6th October 2023. The Orientation session included two-day presentations and a third day devoted to a tour of the Nigerian National Assembly complex.

The workshop aimed to prepare and provide guidance to the Interns ahead of their journey at the National Assembly by acquainting them with basic and necessary information to ensure they make the most of their learning experience at the internship. Over the course of these two days, a series of information packed lectures were delivered to interns by various Resource persons.

Opening remarks at the orientation were made by PLAC Executive Director, Mr. Clement Nwankwo whose speech focused on the importance of the National Assembly in a democratic setting like Nigeria. He laid emphasis on the importance of sensitizing Nigerian youths on the roles of the National Assembly in a democracy which is the foundation of the PLAC Legislative Internship.

Delivering the EU's goodwill remarks, Ms. Laolu Olawumi, Programme Manager, Democracy and Rule of Law, Delegation of the European Union to the Federal Republic of Nigeria and ECOWAS stressed on the EU's interest in the work, expertise and contribution of young people. She encouraged the Interns to utilize the opportunity given and to also be attentive during the course of the internship programme, especially during their engagements with assigned Committees at the National Assembly.



# 2.2.1 Presentations on Day One of the Orientation Session - Wednesday, 4th October 2023

The first day of the orientation commenced with an introductory presentation titled "An Overview of the Structure and Functions of the National Assembly." This was delivered by Dr. Rahila Amadu (Former Director, National Secretariat of the Nigerian Legislatures) who explained the political, administrative and leadership structures of the National Assembly, as well as their law-making, representative, quasi-judicial and oversight functions.

The second paper presentation titled "The Practice and Politics of Law-making" was presented by Hon. Rima Shawulu (Member representing Takun/Donga/Ussa Federal Constituency, Taraba State (2015 to 2023) who gave an elaborate paper on the historical development of lawmaking in Nigeria.

The third paper titled "From Passion to Action: The Role of Young People as Change-makers" was presented by Mrs. Agianpe Onyema (Former Coordinator, Nigerian Civil Society Situation Room). She shared her thoughts on the role of young people as change-makers who make positive impact and bring about transformation in the society.

The final activity for the day was a team bonding exercise facilitated by Stella Onwochie (Chief Operating Officer at CERCA Africa). The exercise was aimed at fostering team spirit among interns and offering guidance on how to work in a corporate environment.



# 2.2.2 Presentations on Day Two of the Orientation Session – Thursday, 5th October 2023

The second day of the orientation session began with an icebreaker facilitated by Nkiru Uzodi (Programme Manager, PLAC) to further strengthen team building among the interns.

This was followed by a presentation titled "Understanding the National Assembly Work Environment: A Practical Guide for Current Interns by Past Interns".

In this session, three Alumni members of the PLAC LIP were invited to share their personal experiences and enlighten the current interns in understanding the working environment in the National Assembly. The essence of this was to create a guide for the current interns in their journey through the Internship.

Abiye Briggs, (2022 PLAC LIP Cohort, Rivers State) stressed on the importance of setting goals during the course of the internship which would facilitate the learning process.

Eniola Bisiriyu, (2022 PLAC LIP Cohort, Lagos State) commenced by giving a brief composition of the bureaucratic structure of the National Assembly. She also encouraged the interns to imbibe proper work etiquette and professionalism during the internship.

Mark Okhakhume, (2022 PLAC LIP Cohort, Edo State) encouraged interns to be open to tasks assigned to them by their respective Committees to ensure a fruitful learning experience.

The second paper presentation titled "Ensuring Safety and Security at the National Assembly" was presented by Mr. Manasseh Aliyuda (Sergeant-at-Arms, National Assembly).

The third presentation by Mrs. Adaora Onyechere Sydney-Jack (Broadcast Journalist and Executive Director, Gender Strategy Advancement International) focused on the topic "Essential Communication Skills and Professional Etiquette" in her presentation, she noted that effective communication is integral to a productive working environment, therefore interns need to learn the basics of workplace etiquette.

The final presentation by Mrs. Ilobah Isabella (Deputy Clerk of the Senate) focused on the important topic "Understanding the National Assembly Plenary Sessions and Committee Hearings." This was aimed at teaching the interns what to expect at plenary session and committee hearings.



# **BI-WEEKLY TRAINING SESSIONS**

Bi-weekly meetings are an integral and important part of the Legislative Internship Programme. They are aimed at complementing the experience and learning of interns during the programme. They create an opportunity for the interns to learn both technical and soft skills that enrich their engagement with the legislature, their personal development and a foundation for their respective careers. The bi-weekly meetings also create an avenue for PLAC to interact with the interns, address concerns that might have arisen during their engagement with the National Assembly and evaluate the progress of the programme.

Four bi-weekly meetings were held during the 2023 Legislative Internship Programme, including an interactive session/visit to the European Union Delegation to Nigeria and ECOWAS.



# 3.1 First Bi-Weekly Meeting

The first bi-weekly meeting held on Friday, 20 October 2023 at the PLAC office.

Resource persons at the first meeting included Nkiru Uzodi, Programme Manager, PLAC; Mrs. Oluwaseyi Tetteh, State Focal Person (FCT) at EU-Agents for Citizen-Driven Transformation (ACT) Programme, British Council; and Reuben Imarha, Esq., Chief Law Research Officer at Nigerian Law Reform Commission and Legal Advisor at Legacy Leadership & Development Outreach (LLDO).

The presentation by Nkiru Uzodi was on "Best Practices in Legislative Engagement" which was aimed at sharing useful knowledge and experience from operating in the legislative space, increasing interns understanding of engagement with legislators and providing insight on how to carry out legislative advocacy and engagement.

Addressing the topic "NGOs as Drivers of Social Change" Mrs. Oluwaseyi Tetteh highlighted the roles of NGOs as watchdogs of the society who engage in sensitization, service delivery, advocacy on various issues, civic engagement and collaboration. Going further, she noted the types of donor agencies and the role of donors in supporting NGOs to create impact in their communities. In conclusion, she shared impact stories of NGOs in various states and communities, achieved through the support of donor agencies.

The last presentation on "How to Analyse Bills and Legislation" by Reuben Imarha (Esq.) discussed bills generally. It introduced interns to the various types of bills and how to carry out bill scrutiny.



# 3.2 Second Bi-Weekly Session



The second bi-weekly meeting held on Friday, 3rd November 2023 at the PLAC office.

Resource persons included Mr. Benjamin Ekeyi, Legislative Strengthening/Legislative Policy Expert; Dr. Kelechi Akubueze (representing Mr. Anthony Ojukwu, Executive Secretary, National Human Rights Commission); Reuben Imarha, Esq., Chief Law Research Officer at Nigerian Law Reform Commission and Legal Advisor at Legacy Leadership & Development Outreach (LLDO).

Mr. Benjamin Ekeyi (Legislative and Parliamentary Policy Expert) who spoke on the topic "How the National Budget is passed," explained the importance of the budget to the governance process and the crucial role the National Assembly plays in passing the Appropriation bill. He concluded his presentation by guiding the interns through a mock budget defence debate session.

The presentation by Dr. Kelechi Akubueze on the topic "Enforcing Fundamental Human Rights in Nigeria: A Crucial Role of the Legislature" highlighted the role of the legislature in enforcing human rights and made recommendations for the strengthening of human rights institutions.

Finally, there was a Practical Session on "Reading and Analysing Bills: Overview of select youth-centric bills before NASS." The facilitator, Reuben Imarha, concluded the session by guiding the interns through the understanding and analysis of some youth-centered Bills brought before the 10th National Assembly and put them through practical exercises on bills drafting.

At this meeting, interns elected members of their cohort to lead the Model Legislative Assembly (MLA) session scheduled to take place at the end of the internship. The following interns emerged as principal officers in the elections:

# **3.3 Third Bi-Weekly Session**

The third bi-weekly meeting held on Friday, 24th November 2023 at the PLAC office.

Resource persons included Dr. Innocent Mebiri, Clerk, Senate Ad-hoc Committee on the Review of the 1999 Constitution (6th to 9th Assembly); Barr. Chinedu Akubueze, Clerk, Senate National Assembly represented by Mr. Sani Abdullahi (Clerk, Senate Committee on Defence); Omolara Akinyeye, Deputy Executive Director, PLAC.

The welcome remarks were made by Nkiru Uzodi, on behalf of Mr. Clement Nwankwo, Executive Director, PLAC. She reiterated the purpose of the bi-weekly meetings in her remarks.

Dr. Innocent Mebiri, who took the interns on the topic "Understanding the Constitutional Review Process," explained the Constitution amendment process, its challenges and lessons learned from previous amendment exercises.

The second presentation by Mr. Sani Abdullahi was on the topic "Legislative Practice and Procedure in the National Assembly: Motions, Resolutions and Plenary". The facilitator took the interns through the theoretical aspect of plenary, to help them better understand the management of plenary and the order which chamber proceedings must follow.

The final presentation for the day was a refresher on the Internship Code of Conduct and Safeguarding by Omolara Akinyeye, Deputy Executive Director, PLAC.

The interns commenced their practical training on drafting of bills and motions, as well as rehearsals on reenactment of House Plenary sessions in preparation for the Model Legislative Assembly.



# 3.4 Fourth Bi-Weekly Session

The fourth bi-weekly meeting for the LIP was held on Friday, 1st December 2023 at the PLAC office.

Resource persons included Mrs. Ene Obi, Former Convener, Nigeria Civil Society Situation Room; Mr. Gani Ojagbohunmi, Former Clerk, House of Representatives.

In line with the theme for the 16 Days of Activism: Unite! Invest to Prevent Violence against Women and Girls, Mrs. Ene Obi spoke on the topic "Efforts of Civil Society in Preventing Gender Based Violence and Promoting Women's Right".

The final activity of the day was the Model Legislative Assembly Rehearsal session facilitated by Mr. Gani Ojagbohunmi speaking on the topic "Model Legislative Assembly Rehearsal: Re-enactment of a House of Representatives Plenary Sitting."





# INTERNS VISIT TO THE EUROPEAN UNION DELEGATION OFFICE IN ABUJA

The Ambassador and Head of Delegation of the European Union Delegation to Nigeria and the ECOWAS Samuela Isopi, the Deputy Head of Delegation, Zissimos Vergos and Laolu Olawumi, the Programme Manager, Rule of Law, Migration and Gender welcomed the interns to the EU Delegation Office on 4th December 2023. It offered an opportunity for the leadership of the EU delegation to have one-on-one interactions with interns and get direct feedback on their experience of the internship. The Ambassador also used it as an opportunity to restate the EU's commitment to promoting democracy and the socio-political inclusion of young people in Nigeria. The visit was planned to occur during the 16 days of action against Sexual and Gender Based Violence (SGBV) and interns turned out in their themed T-shirts to express their solidarity with the campaign.

i. The first live radio show for the programme took place on 6th December 2023 at 95.1 Naija Info Morning show with Femi D as the Host. # MODEL LEGISLATIVE ASSEMBLY



The Model Legislative Assembly (MLA) is a major concluding activity under the Legislative Internship Programme. It is a simulation of legislative proceedings of NASS and is aimed at demonstrating the skills and learning of the interns during their stay in NASS. It serves as a platform to discuss real-life policy, legal, social, political and economic issues affecting the country.

It also provides an opportunity to assess interns' knowledge of plenary sessions observed during the programme and illustrate their knowledge on legislative processes and procedures such as Bill drafting, role of principal officers in chambers and duties of legislators.

Some of the expected outcomes which formed the assessment of the performance of interns include:

- Demonstration of understanding of Legislative practice and procedure
- Informed discussion of current socio-political issues
- Constructive and Collaborative problem solving

The Model legislative Assembly session held on 11th December 2023 at Abuja Continental Hotel and was anchored by Abubakar Ahmed, a former intern and Head of current affairs and English programs, Liberty TV and Radio, Kaduna.

The opening remark was made by Mr. Clement Nwankwo, Executive Director, PLAC. Ms. Laolu Olawunmi, Programme Manager, Democracy and Rule of Law, Delegation of the European Union to the Federal Republic of Nigeria and ECOWAS, in her goodwill remark laid emphasis on the priority placed on youth engagement by the European Union with the aim of achieving Sustainable Development Goals and political stability.

Panelists at the session include; Dr. Rahila Ahmadu, Former Director, National Secretariat of Nigerian Legislatures; Benjamin Ekeyi, Legislative and Parliamentary Policy Expert; Alhaji Muhammed Sani Abdullahi, Director of Legislation, Senate, National Assembly; Dr. Nurudeen Mohammed, Former Minister of foreign Affairs and supervising Minister, Ministry of Information; and Hajiya Aisha Ahmed El-Rufai, former First lady of Kaduna State.

The MLA session was graced by Legislators like; Hon. Clement Jimbo, Member representing Abak/ Etim/Ekpo/Ika Federal Constituency of Akwa Ibom State; Hon. Olamijunwoala Alao-Akala, Member representing Ogbomosho North Federal Constituency, Oyo State and Chairman House Committee on Youth in Parliament; Hon. Akintunde Rotimi, Member Representing Ekiti North 1 Federal Constituency, Ekiti State and Chairman House Committee on Media and Public Affairs. Interns presented sample bills and motions they had drafted on issues affecting Nigeria's six geopolitical zones and led debates on them.

Some of the bills and motions discussed at the session include the following:

- A Bill for an Act to amend the Compulsory Free Universal Basic Education Act, 2004 to extend coverage to Senior Secondary School Education, increase Federal Government block grant Amount, Reduce Contribution by States, increase fines and for other related Matters;
- A Bill for an Act to Prohibit and Criminalize Spectating and Participating in Lynching to Protect Human Rights and ensure fair and just Legal Processes and for Related Matters;
- A Bill for an Act to amend the Electoral Act to mandate the Compulsory Transmission of polling unit results, provide stiffer sanctions for Dereliction of Duty, strengthen the powers of Independent National Electoral Commission to Regulate and Discipline its Staff, and for related Matters;
- An Act to provide for the Digitisation of Government Institutions and the Civil Service for the Modernization, efficiency, transparency, Data Security and Enhanced service delivery of Government Operations in the Federal Republic of Nigeria;
- A Bill for an Act to Amend the Discrimination Against Persons with Disabilities Prohibition) Act to enhance the protection of the Rights and Dignity of Persons with Disabilities, promote Political Inclusivity and Equal Opportunities and for Related Matters 2023;
- A Bill for an Act to Amend the National Institute for Nigerian Languages Act CAP. N50 Laws of the Federation of Nigeria 2004 to revise the functions of the Institute to provide for the Documentation and Digitisation of Nigerian Indigenous Languages and to create Zonal Centres and for Related Matters;
- A Bill for an Act to Amend the Labour Act, CAP L1, LFN 2004 to Extend the Nursing Period, Increase Maternity Leave Wages, Provide for Paternity Wages and Mandate Institutions to Designate Daycare Spaces and for Related Matters;
- Urgent Need to Investigate the unfortunate Accidental Bombing of Tudun Biri in Igabi Local Government of Kaduna State on Sunday, 3rd December 2023;
- Need to Curb the Activities of Miscreants on Public transportation system known as "one chance" in the Federal Capital Territory;
- Need for immediate Intervention to tackle malnutrition in Children under five years of Age in Gombe;
- Need to enforce Traffic Regulation and address the misuse of Sirens in Nigeria;
- Urgent need to ensure Federal Character in Political Appointments and Recruitments across Government Ministries, Departments and Agencies (MDA's);

- Need for the Niger Delta Development Commission (NDDC) to include Humanities, Management and Social Science Courses in its Scholarship Scheme;
- Urgent need to investigate the Incessant Arrest and Detention of Youths and Students by the Economic and Financial Crimes Commission (EFCC) and other Law Enforcement Agencies.
