The Senate:

Notes the need to amend the Senate Standing Orders to accommodate issues that will facilitate effective legislative process;

Aware that it is imperative to amend the Standing Orders of the Senate 2023 (as amended) to establish additional Committees and have their functions and jurisdictions reflected in the Standing Orders;

Also notes that in view of the foregoing, there would be need for a consequential approval of the Senate to renumber the Rule in Order 96, to accommodate the new Committees;

Further aware that the amendments have been circulated to Senators in accordance with Order 109 Rule 2 of the Senate Standing Orders,

Accordingly resolves to:

- i. Enter into the Committee of the Whole to consider the proposed Amendment;
- ii. *Approve* the proposed amendment as contained therein; and
