MOTIONS

11. Need to provide Electricity Supply to Agoi Ibami Community in Yakurr Local Government Area Cross Rivers State:

Hon. Alex Egbona:

The House:

Notes that the Agoi Ibami Community in the Yakurr Local Government Area of Cross River State has long been without access to electricity, and this has hindered the socio-economic development in the area:

Aware that the people of the Community are predominantly farmers who have contributed significantly to food production and agricultural activities in Cross River State and beyond;

Also aware that recently gold and other mineral deposits in large quantities were discovered in the community, which is another opportunity for economic growth, industrial development, and job creation if only it can be harnessed effectively with adequate electricity supply;

Concerned that the absence of electricity supply has continued to limit the potential for agro-processing, local businesses, and investment in mining, and this has adversely affected activities while slowing down the livelihood of residents and their economic progress;

Resolves to:

- (i) urge the Federal Ministry of Power to take immediate steps to provide electricity supply to the Agoi Ibami community;
- (ii) call on the Rural Electrification Agency (REA) to include the Agoi Ibami Community in its electrification projects to enhance rural development;
- (iii) mandate the Committees on Power and Rural Electrification to ensure compliance.

12. Illegal Felling and Exportation of Forest Woods in Nigeria: Hon. Henry Odianosen Okojie:

The House:

Notes the increasing cases of illegal felling and exportation of forest wood in Nigeria, leading to significant deforestation and degradation of our forests;

Concerned that illegal felling and exportation of forest wood result in widespread environmental damage, loss of biodiversity, increasing climate change impacts, and triggering adverse effects on rural communities and the economy;

Aware that illegal wood trade is a violation of national laws, including the Nigerian Forestry Law, and constitutes a criminal offense that needs to be addressed urgently;

Acknowledged the need to strengthen the enforcement of existing laws and regulations by providing adequate resources to relevant agencies responsible for monitoring and enforcing forestry regulations and international trade:

Resolves to:

- (i) urge the Federal Ministry of Environment through its National Parks Service to establish a specialized anti-illegal logging task force, comprising representatives from relevant government agencies, to coordinate efforts aimed at curbing illegal felling and exportation of forest wood;
- (ii) mandate the Committees on Environment and Customs Excise to conduct an in-depth investigation into the root causes of illegal felling and exportation of forest wood in Nigeria and recommend appropriate legislative and policy actions to address the issue and report within four (4) weeks for further legislative actions.

13. Need to Regulate Arbitrary Rent Increase and Protect Tenants from Exploitation: Hon. Bassey Akiba:

The House:

Notes that Section 14(2) (b) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) prioritizes the welfare of the people as the primary responsibility of government;

Also notes that housing has been universally accepted as the second most important basic need for human survival and an essential component to the advancement of the quality of life of the citizenry, and according to the United Nations Habitat Agenda, the provision of adequate housing that is safe, secure, accessible, affordable and sanitary is a fundamental human right;

Aware that housing is crucial for national development and is an important source of national capital formation, employment generation, and income production;

Concerned that the challenging economic climate is exerting a detrimental effect significantly felt by individuals, households, and businesses alike, especially people residing in rental accommodations who are now grappling with escalating rents;

Also concerned that there is usually a sudden hike in the rent in an area after infrastructure such as roads, markets, and other amenities are constructed, particularly in the Federal Capital Territory (FCT), where the rent in areas where roads are newly constructed surged from 800,000 to as high as N2.5 million per annum, thereby placing an unbearable financial burden on tenants;

Worried that the wanton exploitation by property owners undermines the government's intention to improve citizen's welfare through public infrastructure and drives the teeming Nigerian youths into hardship, forcing some to resort to crime to meet the inflated demands;

Cognizant of the urgent need to balance the rights of property owners with the welfare of tenants to ensure fairness, stability, and sustainability in the housing sector;

Resolves to:

- (i) urge the Federal Ministry of Housing to collaborate with State Governments to enforce rent control measures, ensuring that public infrastructure projects do not lead to exploitative rent hikes, and ensure that rent increase are capped at not more than 20% of the existing rent, irrespective of infrastructure improvements or other factors;
- (ii) also urge the Federal Government to increase investment in affordable housing initiatives, ensuring access to low-cost housing for citizens and reducing pressure on the rental market;
- (iii) mandate the Committee on Housing and Habitat to ensure compliance.

14. Need for Federal Government to Procure and Lease Mechanized Agricultural Machineries to Farmers at Subsidized Rate in all the Local Government Areas Across the Federation: Hon. Aderemi A. Oseni:

The House:

Notes that the uncontrollably high cost of food and related items has left the average Nigerian income struggling to keep up, thereby increasing the cost of living in the country;

Aware that the primary responsibility of the government is to ensure food security and control food and related product prices to minimize their impact.

Observed that the continuous increase in the prices of food is largely triggered by factors like insecurity, high cost of agricultural inputs, and low production, aligned to the fact that most farmers in Nigeria engage only in subsistence farming systems, which can only produce meager outputs;

Cognizant of the need for the Federal Government, through the Ministry of Agriculture and Food Security, to aggressively encourage small farmers to engage in modern mechanized farming to increase agricultural production and ensure food security by providing modern farming machines, introducing modern farming skills with the aid of technology to boost food production in Nigeria;

Also aware of the need for the federal government, through the Ministry of Agriculture and Food Security and Millennium Development Goals Office, with the Development Partners in collaboration with the Thirty-Six States, FCT, and the 774 Local Government Areas to set up farm settlements in each of the local government areas, equip them with modern farming machinery and other agricultural inputs for leasing to farmers, some of which will be sold to farmers at subsidised rate, to boost production and ensure food security;

Also notes that these measures, when implemented, will revolutionize the agricultural value chain and food production sector, make it more attractive, encourage more people to go into farming, and attract investment to the sector;

Further aware that timely and effective implementation of this program will be a very smart and easy way of getting our teaming youths to embrace agriculture, which will in turn bring in fresh energy, vibes, and innovation into the sector for the prosperity of our dear nation.

Resolves to:

- (i) mandate the Committee on Agricultural Production and Services to invite the Hon. Minister of Agriculture and Food Security, Millennium Development Goals office to work out a modality to Procure and Lease Mechanized Agricultural Machineries to Farmers at subsidized rate in all the Local Government Areas Across the Federation;
- (ii) also mandate the Committee on Legislative Compliance to ensure compliance.

15. Need to Enforce the Right of Every Child to Basic Education as Provided under the Universal Basic Education Scheme:

Hon Obi Aguocha:

The House:

Notes that in partial fulfillment of its duty to provide education for citizens of Nigeria, the State had enacted the Child's Rights Act, 2003, and the Compulsory Free Universal Basic Education Act, 2004;

Also notes both laws guarantee the right of every Nigerian Child to Compulsory Basic Education from Primary to Junior Secondary School at the expense of the State.

Aware that with respect to the funding of the Universal Basic Education Scheme, the Federal Government is required to contribute 2% of its Consolidated Revenue Fund to the Universal Basic Education Fund (UBEF) annually while State Governments are entitled to access the Universal basic Education Fund through the provision of counterpart funding.

Also aware that to ensure compliance with the law, parents and guardians who refuse to allow their children and wards to be educated by the State are liable to be prosecuted.

Concerned that in spite of the clear provisions of both legislations, the Country continue to witness increase in the number of out of school children, insufficient funding, uneven distribution of resources, poor teacher quality, socio-cultural barriers such as child labour, early marriage, gender bias against girl education;

Also concerned that millions of children of school age are found on the streets either begging for alms or hawking goods, thus increasing the number of out-of-school children which will eventually lead to serious crisis in the nearest future;

Disturbed that according to UNICEF, as of September 2024, Nigeria has 18.3 million out of school, one of the highest figures in the world;

Also disturbed that the crisis has continued to escalate the insurgency in the Northeast region, which has led to the closure of schools on account of the abduction of school children, displacement of parents and children, and destruction of schools by the Boko Haram sect and other terrorist Organizations in the country;

Cognizant of the need for the Universal Basic Education Commission (UBEC) to provide a supervisory role on the scheme and ensure an impressive enrollment of Children for basic education in the Country;

Resolves to:

- (i) urge the Universal Basic Education Commission to ensure that every Nigerian child has access to Free and Compulsory Education as contained in Article 17 of the African Charter on Human and Peoples' Rights, Section 15 of the Child's Rights Act, and Section 2 of the Compulsory Free Universal Basic Education Act, 2004;
- (ii) mandate the Committee on Basic Education and Services to invite the Management of the Universal Basic Education Commission (UBEC) to provide report on the implementation of the scheme; and
- (iii) also mandate the Committee on Basic Education and Services to ensure compliance.
