# MOTION

1. Urgent Need to cushion the Impact of the Fire Incident at Simra Multi-Purpose Market and Small Scale Rubber Recycling Industries in Dakata, Nasarawa LGA, Kano Central Senatorial District, Kano State.

Sponsor: Sen. Rufa'i, Sani Hanga (Kano Central)

The Senate:

*Notes with deep concern* over the devastating fire outbreak in Kano's Simra Multi-Purpose Market and small-scale industrial hub in Dakata, and the significant impact on businesses and livelihoods;

*Informed* that the fire incident occurred in the night on Saturday, March 22, 2025, which severely damaged multiple factories specializing in nylon and plastic production. The fire consumed machinery, raw materials, and finished products, with the origin of the blaze still under investigation;

Also informed that the destruction was extensive, affecting the livelihood of over 250,000 business men and women and significantly impacting numerous businesses that rely on the facilities for their daily operations. The losses include, but are not limited to, expensive industrial equipment, production machines, raw materials, and finished goods ready for delivery, all of which were destroyed in the fire, with estimated damages exceeding N100 billion;

*Further informed* that although the fire broke out during the night, it is fortunate that the number of casualties was relatively low; and

*Worried* that the impact of this disaster is devastating. Many small business owners have lost everything, facing an incredibly challenging road to recovery. The financial and emotional toll is indeed significant. Rebuilding and recovering from such a loss can be overwhelming. Support systems and resources will likely play a crucial role in helping those affected navigate this challenging time,

# Accordingly resolves to:

i. *Urge* the Federal Ministry of Humanitarian Affairs and the National Emergency Management Agency (NEMA) to promptly dispatch relief materials, including building materials, to support the victims of the Simra Multi-Purpose Market and Small Scale Rubber Recycling Industries fire disaster in Dakata. This will enable them to rebuild their shops, resume operations, and alleviate their suffering and losses;

- ii. *Also urge* the Bank of Industry to provide accessible soft loans to the fire victims, enabling them to restock their shops. This support is crucial, especially for those who had taken loans to stock their shops prior to the incident;
- iii. *Further urge* the Federal Fire Service and National Emergency Management Agency (NEMA) to conduct a thorough investigation into the cause of the fire, with the aim of enhancing fire safety protocols in similar facilities and preventing future incidents; and
- iv. *Mandate* the Committee on Environment to oversee the response efforts, ensure compliance with relevant regulations, and submit a report within a reasonable time.
