**7. Matters of Urgent Public Importance (Standing Order Eight, Rule 5)**

- (i) ***Outrage Resulting from Unguarded Comments by the Chief Executive of the Nigerian Midstream and Downstream Petroleum Authority:***

Hon. Esosa Iyawe (*Oredo Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.*

**Outrage Resulting from Unguarded Comments by the Chief Executive of the Nigerian Midstream and Downstream Petroleum Authority:**

The House:

*Notes* that fuel quality can impact engine hardware, thus ultra-low sulfur diesel is recommended for all types of companies, power plants, storage tanks, industrial facilities, fleets and heavy equipment, and even ships, as high Sulphur content in fuels causes damage to engines and contributes to air pollution;

*Also notes* that considering the various risks associated with Sulphur, governments around the world have taken steps to regulate it by setting standards that require maximum reduction of emissions of this chemical compound, which diesel producers are expected to adhere to;

*Further notes* that Sulphur dioxide has dire environmental and health consequences, as it can damage the human respiratory system, compromise lung function and even cause cancer;

*Aware* that the Nigerian Midstream and Downstream Petroleum Authority (NMDPRA) permits local refiners to produce diesel with Sulphur content of up to 650 parts per million (ppm) until January 2025, as approved by the ECOWAS;

*Also aware* that recently, the Chief Executive of the NMDPRA stated that the diesel produced by the Dangote refinery is inferior to the ones imported into the country, and that their fuel had a large content of Sulphur, which he put at between 650 to 1,200ppm ppm;

*Further aware* that in their defence, Dangote called for a test of their products, which was supervised by Members of the House of Representatives, wherein it was revealed that Dangote's diesel had a Sulphur content of 87.6 ppm (parts per million), whereas the other two samples diesel imported showed Sulphur levels exceeding 1800 ppm and 2000 ppm respectively, thus disproving the allegations made by the NMDPRA boss;

*Concerned* that allegations have been made that the NMDPRA was giving licences to some traders who regularly import high-Sulphur content diesel into Nigeria, and the use of such products poses grave health risks and huge financial losses for Nigerians;

*Also concerned* that the unguarded statements by the Chief Executive of the NMDPRA, which has since been disproved, sparked an outrage from Nigerians who tagged his undermining of local refineries and insistence on the continued importation of fuel an act of economic sabotage, as the imported products have been shown to contain high levels of dangerous compounds;

*Worried* that the statement by the Chief Executive of the NMDPRA without conducting any prior investigation is not only unprofessional, but also unpatriotic especially in the face of the recent calls for protest against the Federal Government;

*Resolves to:*

Call on the Executive Arm of Government to suspend the Chief Executive of the Nigerian Midstream and Downstream Petroleum Authority (NMDPRA) pending conclusive investigations into the allegations against the Authority (*Hon. Esosa Iyawe — Oredo Federal Constituency*).

*Debate.*

**Amendment Proposed:**

*Insert* a new Prayer (ii), as follows:

“mandate the Committees on Petroleum Resources (Midstream), and Petroleum Resources (Downstream) to investigate the matter” (*Hon. Esset Mark Udo — Uyo/Uruan/Nsit Atai/Asutan/Ibesikpo Federal Constituency*).

*Question that the amendment be made — Agreed to.*

*Question on the Motion as amended — Agreed to.*

The House:

  - (ii) mandate the Committees on Petroleum Resources (Midstream), and Petroleum Resources (Downstream) to investigate the matter (**HR.51/07/2024**).
- (ii) ***Devastating Effect of Flooding in Madagali and Michika Local Government Areas of Adamawa State:***  
Hon. Zakaria Dauda Nyampa (Madagali/Michika *Federal Constituency*) introduced the matter and prayed the House to:
- (a) consider and approve the matter as one of urgent public importance; and
  - (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

**Devastating Effect of Flooding in Madagali and Michika Local Government Areas of Adamawa State:**

The House:

*Notes* that on 12 July, 2024, Madagali/Michika Federal Constituency of Adamawa State experienced severe flooding which resulted to the destruction of houses, food, bridges and other properties worth Billions of Naira;

*Also notes* that the incident caused the displacement of families and other inhabitants of the affected areas and thereby threatening their lives;

*Aware* that the flood affected Waga Madagali of Madagali Local Government Area, Dlaka and Moda of Michika Local Government Area, Mutsi and Bulaburi of Michika Local Government Area;

*Also aware* that inhabitants of the aforesaid communities are experiencing severe hardship and are exposed to hazardous health risks, currently not only do the people in these communities have to live in and walk through stagnant dirty water to get to work or school, they also experience daily battles of waterborne diseases;

*Resolves to:*

Urge the National Emergency Management Agency (NEMA) to:

- (a) carry out sensitization and provide relieve materials to the victims;
- (b) monitor the state of preparedness against disaster, formulate policies and educate citizens on measures to help prepare and prevent flood (*Hon. Zakaria Dauda Nyampa — Madagali/Michika Federal Constituency*).

*Debate.*

*Agreed to.*

The House:

*Noted* that on 12 July, 2024, Madagali/Michika Federal Constituency of Adamawa State experienced severe flooding which resulted to the destruction of houses, food, bridges and other properties worth Billions of Naira;

*Also noted* that the incident caused the displacement of families and other inhabitants of the affected areas and thereby threatening their lives;

*Aware* that the flood affected Waga Madagali of Madagali Local Government Area, Dlaka and Moda of Michika Local Government Area, Mutsi and Bulaburi of Michika Local Government Area;

*Also aware* that inhabitants of the aforesaid communities are experiencing severe hardship and are exposed to hazardous health risks, currently not only do the people in these communities have to live in and walk through stagnant dirty water to get to work or school, they also experience daily battles of waterborne diseases;

*Resolved to:*

Urge the National Emergency Management Agency (NEMA) to:

- (a) carry out sensitization and provide relieve materials to the victims;
- (b) monitor the state of preparedness against disaster, formulate policies and educate citizens on measures to help prepare and prevent flood (**HR. 52/07/2024**).

(iii) ***Negative Portrayal of the House Resolution by the Nursing and Midwifery Council of Nigeria:***

Hon. Patrick Umoh (*Ikot Ekpene/Essien Udim. Obot Akara Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.*

**Negative Portrayal of the House Resolution by the Nursing and Midwifery Council of Nigeria:**

The House:

*Notes* the power of the House to make laws for the peace, order and good government of the Federation including the power of the House to, by its resolution, compel an executive agency to carry out a particular act or take necessary action on a given matter in the interest of the public;

*Also notes* that the House by its Resolution of Tuesday, 27 February, 2024, urged the Nursing and Midwifery Council of Nigeria not to implement the Revised Guidelines for Verification dated February 7, 2023, pending investigation by the House;

*Further notes* that in a letter dated 13 March, 2024, and received on 14 March, 2024, the Clerk to the National Assembly communicated the House's Resolution of Tuesday, 27 February, 2024, to the Registrar/CEO of the Nursing and Midwifery Council of Nigeria;

*Aware* that upon the receipt of the House's Resolution of Tuesday, 27 February, 2024, on 14 March, 2024, the Council immediately shut down their site for verification of nurses and midwives, and boldly and maliciously wrote on the site:

*Verification services suspended in compliance with the directive of the House of Representatives of the Federal Republic of Nigeria;*

*Also aware* that the House's Resolution of Tuesday, 27 February, 2024 did not by any stretch of the imagination or interpretation requested the Council to shut down their site for verification of nurses, rather it requested the Council not to implement its Guidelines dated February 7, 2023, pending investigation by the House:

*Further aware* that the shutting down of the site for verification of nurses by the Council is done contrary to, and in total disregard for, the House's Resolution of Tuesday, 27 February, 2024;

*Concerned* that the Council is acting in bad faith and deliberately so to portray the House in bad light with the aim of pitting the People's House presided by the Rt Hon. Speaker against the Nigerian nurses and midwives, and by extension, the Nigerian masses;

*Worried* that it is over 4 months since the site was maliciously shut down by the Council, thereby denying nurses and midwives the right to pursue their dreams and earn a living in line with international conventions of which Nigeria is a signatory;

*Conscious* of the need to protect and preserve the House's institutional sanctity and name, and correct the erroneous impression created by the Council against the House;

*Resolves to:*

- (i) urge the Nursing and Midwifery Council of Nigeria to open its site and commence verification of nurses and midwives based on its former Guidelines (not the revised Guidelines for Verification dated February 7, 2023) pending the conclusion of investigation by the House Committee on Health Institutions;
- (ii) mandate the Committees on Health Institutions, and Legislative Compliance to ensure compliance and report within six (6) weeks (*Hon. Patrick Umoh — Ikot Ekpene/Essien Udim/Obot Akara Federal Constituency*).

**Amendment Proposed:**

*Leave out* all the words in Prayer (i), and *insert* as follows:

“urge the Nursery and Midwifery Council of Nigeria to use the revised guide lines for verification of its members ” (*Hon. Chinedu Ogah — Ikwo/Ezza South Federal Constituency*).

*Question that the amendment be made — Negatived.*

The House:

*Noted* the power of the House to make laws for the peace, order and good government of the Federation including the power of the House to, by its resolution, compel an executive agency to carry out a particular act or take necessary action on a given matter in the interest of the public;

*Also noted* that the House by its Resolution of Tuesday, 27 February, 2024, urged the Nursing and Midwifery Council of Nigeria not to implement the Revised Guidelines for Verification dated February 7, 2023, pending investigation by the House;

*Further noted* that in a letter dated 13 March, 2024, and received on 14 March, 2024, the Clerk to the National Assembly communicated the House's Resolution of Tuesday, 27 February, 2024, to the Registrar/CEO of the Nursing and Midwifery Council of Nigeria;

*Aware* that upon the receipt of the House's Resolution of Tuesday, 27 February, 2024, on 14 March, 2024, the Council immediately shut down their site for verification of nurses and midwives, and boldly and maliciously wrote on the site:

*Verification services suspended in compliance with the directive of the House of Representatives of the Federal Republic of Nigeria;*

*Also aware* that the House's Resolution of Tuesday, 27 February, 2024 did not by any stretch of the imagination or interpretation requested the Council to shut down their site for verification of nurses, rather it requested the Council not to implement its Guidelines dated February 7, 2023, pending investigation by the House:

*Further aware* that the shutting down of the site for verification of nurses by the Council is done contrary to, and in total disregard for, the House's Resolution of Tuesday, 27 February, 2024;

*Concerned* that the Council is acting in bad faith and deliberately so to portray the House in bad light with the aim of pitting the People's House presided by the Rt Hon. Speaker against the Nigerian nurses and midwives, and by extension, the Nigerian masses;

*Worried* that it is over 4 months since the site was maliciously shut down by the Council, thereby denying nurses and midwives the right to pursue their dreams and earn a living in line with international conventions of which Nigeria is a signatory;

*Conscious* of the need to protect and preserve the House's institutional sanctity and name, and correct the erroneous impression created by the Council against the House;

*Resolved to:*

- (i) urge the Nursing and Midwifery Council of Nigeria to open its site and commence verification of nurses and midwives based on its former Guidelines (not the revised Guidelines for Verification dated February 7, 2023) pending the conclusion of investigation by the House Committee on Health Institutions;

- (ii) mandate the Committees on Health Institutions, and Legislative Compliance to ensure compliance and report within six (6) weeks (**HR. 53/07/2024**).

***Motion made and Question proposed***, “That the House do suspend Order Eight, Rule 5 (4) to enable it take more than 3 matters of urgent public importance” (*Hon. Julius Ihonybere — House Leader*).

***Agreed to.***

- (iv) ***Oil Spillage at Olugboboro Community in Southern Ijaw from Nigerian Agip Oil Company Facility:***

Hon. Rodney Ebikebina Ambiowei (*Southern Ijaw Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and  
(b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

***Question that the matter be considered as one of urgent public importance — Agreed to.***

***Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.***

**Oil Spillage at Olugboboro Community in Southern Ijaw from Nigerian Agip Oil Company Facility:**

The House:

*Aware* that National Oil Spill Detection and Response Agency (NOSDRA) was set up by Parliament to regulate and respond to oil spillage problems in Nigeria;

*Also aware* that the Oil Spill Recovery, Clean-Up, Remediation and Damage, Assessment Regulation, 2011, is a regulatory tool setting out operational standards and guidelines dealing with Oil spillages to protect the environment, economic interest and health of host communities who suffer direct impact of Oil spillages and production in Nigeria;

*Notes* that Southern Ijaw Federal Constituency and several constituencies of the South-South Geopolitical Zone host Oil Installations, Facilities and companies that carry out Oil exploration in the coastal communities, i.e. Nigerian Agip Oil Company (NAOC) among others;

*Concerned* that since April 2024, the Oil facility belonging to Nigerian Agip Oil Company, the Ogboinbiri/Teibidaba Pipeline ruptured and has been gushing out crude continuously till date without the requisite urgent action to abate the nuisance which communicated to the Nigerian Agip Oil Company that has failed to arrest the spillage;

*Disturbed* that the spillage has affected the economic wellbeing and livelihood of the community that has been very peaceful over time;

*Also concerned* that the failure to urgently address this very serious situation could lead to unrest in the community that is heavily relying on fishing, farming and also ravaged by poverty;

*Also concerned* that despite the prompt reporting of this incident, the slow reaction of the Nigerian Agip Oil Company who own these Facilities to immediately arrest the spillage to assuage residents of the impacted Southern Ijaw coastal communities is disturbing;

*Further aware* that these communities are predominantly fishermen whose livelihood, health and right to clean and safe environment is being violated by the continuous spillage;

*Resolves to:*

- (i) urge the Management of Nigerian Agip Oil Company to urgently stop/contain the Oil leakages from its Facilities at Ogboinbiri/Teibidaba affecting Olugboboro Community in Southern Ijaw Federal Constituency;
- (ii) also urge the National Emergency Management Agency to urgently supply relief materials to ameliorate the sufferings of the impacted communities who have lost source of livelihood.
- (iii) further urge the Nigerian Agip Oil Company to immediately pay compensation to the affected community for the economic trees and aquatic life damaged since April 2024, by the spillage;
- (iv) mandate the Committees on Environment, and Petroleum Resources (Upstream) to carry out an extensive investigation into the immediate and remote causes of the Spillage, to ascertain and assess the extent of impact to Olugboboro Community of Southern Ijaw Federal Constituency and report within four (4) weeks (*Hon. Rodney Ebikebina Ambaiowei — Southern Ijaw Federal Constituency*).

*Debate.*

*Agreed to.*

The House:

*Aware* that National Oil Spill Detection and Response Agency (NOSDRA) was set up by Parliament to regulate and respond to oil spillage problems in Nigeria;

*Also aware* that the Oil Spill Recovery, Clean-Up, Remediation and Damage, Assessment Regulation, 2011, is a regulatory tool setting out operational standards and guidelines dealing with Oil spillages to protect the environment, economic interest and health of host communities who suffer direct impact of Oil spillages and production in Nigeria;

- (2) The amount mentioned in subsection (1) of this section shall be appropriated to heads of expenditure as set out in the Schedule to this Act.
- (3) No part of the amount aforesaid shall be released from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.

- (d) where projects are wrongly costed, sited or posted to Ministries, Departments or Agencies

- (2) Such revenues as specified in Sub-section (1) of this section refers to Revenues accruing from sales of government crude oil in excess of the approved benchmark price per barrel, the Petroleum Profit Tax and Royalty on Oil and Gas

- (c) any bank that fails to pay the windfall profit levy to the Service and has not executed a deferred payment agreement by 31st December, 2024, shall be liable to pay the windfall profit levy withheld or not remitted in addition to a fine of 10% of the levy withheld or not remitted per annum and interest at the prevailing Central Bank of Nigeria (CBN) minimum rediscount rate. The fine shall be deducted by the CBN from any fund of the bank domiciled with CBN and turned over to the Federal Inland Revenue Service (FIRS).

32. The provision of section 30 shall commence from 1st January, 2023.

**Interpretation.**

33. For the purpose of section 30 - 33:

- (a) 'Financial year' means either the year commencing from 1st January, 2023 to 31st December, 2023 or/and 1st January, 2024 to 31st December, 2024 or any period within the financial years not aligned with the calendar year comprising twelve calendar months of the bank's financial activity.
