Julius Ihonvbere, Owan Federal Constituency*) – *Second Reading*.

MOTIONS

6. **Investigation of Electricity Debts Owed by Security Agencies, Ministries, Departments and Agencies (MDAs):**
Hon. Kama Nkemkanma:

The House:

Notes that Security Agencies, Ministries, Departments and Agencies (MDAs) of the Federal Government have accumulated substantial debts to Electricity Distribution Companies (Discos) across Nigeria;

Also notes that the Eko Electricity Distribution Company (EKEDC) reported a total outstanding debt of 144 billion naira, with Ministries, Departments and Agencies and the military owing 42 billion, naira;

Further notes that the Abuja Electricity Distribution Company (AEDC) is owed 47.1 billion naira by eighty-six (86) MDAs, including significant amounts by prominent institutions such as the Presidential Villa, the Office of the National Security Adviser, and the Ministry of the Federal Capital Territory;

Aware that the Nigerian Electricity Regulatory Commission's 2023 report indicates that Discos recorded a bill collection efficiency of 73.65%, receiving 1.07 trillion naira from customers out of a total invoice of 1.4 trillion Naira leaving a shortfall of over 300 billion naira;

Concerned that the continuous indebtedness of Security Agencies and MDAs to DISCOs adversely affects the operations of these Companies, leading to inadequate maintenance and expansion of infrastructure, which in turn hampers the overall electricity supply to the populace;

Also concerned about the recent Lagos incidents where military personnel have reportedly attacked facilities and staff of DISCOs over power-related disputes;

Disturbed that on 14 March 2025, soldiers invaded EKEDC's injection Substation in Badagry at 1:00 am, attacking and abducting staff over a power outage, earlier, on 6 March 2025, personnel from the Nigerian Air Force Base in Ikeja stormed the headquarters of Ikeja Electricity Distribution Company (IKEDC), attacking staff and journalists after the company disconnected power to the base over unpaid electricity bills amounting to 4.34 billion naira;

Cognizant of the need to ensure that Security Agencies, Ministries, Departments and Agencies of Government are financially responsible to pay up its utility to prevent future indebtedness;

Resolves to:

set up an *Ad-hoc* Committee to:

- (i) investigate the cause of accumulated electricity debts owed by Security Agencies, Ministries, Departments and Agencies (MDAs) to DISCOs;

- (ii) assess the impact of indebtedness on the operations of DISCOs and the implications on electricity supply in the country and examine the payment processes between DISCOs and government entities;
- (iii) investigate the recent incidents involving the Ikeja military personnel and DISCOs, including the invasions of Eko Electricity Distribution Company (EKEDC) and Ikeja Electricity Distribution Company (IKEDC) facilities, and recommend measures and strategies for the timely settlement of outstanding debts to prevent future occurrences, and report within four (4) weeks for further legislative action.

**7. Ravaging Effects of Gully Erosion in Kwanyawa Town, Karaye Local Government of Kano State:
Hon. Abdullahi Sani Rogo:**

The House:

Notes that Section 14(2)(b) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), states that the security, safety and welfare of its citizens shall be the primary purpose of government;

Also notes that erosion in Kwangawa Town has caused severe damage to the residents of the area.;

Observes that landslides from the erosion have become a threat to houses, farmlands, schools, football fields, and the main road leading to Karaye, the Local Government Area headquarters;

Concerned that the erosion has caused fear among community residents and serious hardship for indigenous people, affecting their social and economic livelihood;

Resolves to:

- (i) also urge the National Emergency Management Agency (NEMA) to swiftly provide relief materials to the affected victims; and
- (ii) mandate the Committee on Environment to visit the Kwanyawa Town, Karaye Local Government of Kano State to assess the level of damage in the Area and report within four (4) weeks for further legislative action.

**8. Need to Address the Recent Flood, Windstorm, and Thunderstorm in Dass, and Tafawa Balewa Local Government Areas of Bauchi State:
Hon. Jafaru Gambo Leko:**

The House:

Notes that recently Communities across Dass and Tafawa Balewa Local Government Areas of Bauchi State experienced severe flooding, windstorms, and thunderstorms which claimed lives, farms, markets, worship centres, and critical infrastructure, rendering thousands of citizens homeless, jobless, and almost stripped off their human dignity;

Also notes that the scale of the disaster has plunged families into crisis, exposing the residents to disease outbreaks, hunger, poverty and long-term displacement;

Aware that the plight of Dass and Tafawa Balewa residents deserve the urgent attention and support of the Federal Government and relevant humanitarian agencies;

Concerned that if urgent action is not taken to address the flooding in Dass and Tafawa Balewa Local Government Areas, it will continue to deteriorate, thereby leading poverty, and precipitate serious humanitarian and security challenges within the affected communities;

Resolves to:

- (i) urge the Federal Ministry of Humanitarian Affairs and Poverty Reduction to collaborate with National emergency Management Agency (NEMA), State authorities, and Non – Governmental

Organisations (NGOs) to provide humanitarian aid, psycho-social support and long-term recovery interventions:

- (ii) also urge the North-East Development Commission (NEDC) to mobilize resources for the rehabilitation and reconstruction of critical infrastructure such as homes, schools, hospitals, markets, and access roads across Dass and Tafawa Balewa Local Government Areas;
- (iii) further urge the Federal Ministry of Environment and relevant climate and disaster resilience institutions to conduct an environmental impact assessment of the affected areas and recommend long-term climate-adaptation measures to mitigate the impact of future flooding, windstorm, and thunderstorm;
- (iv) mandate the Committee on Legislative Compliance to ensure compliance.

10. **Committee on Customs and Excise:**

Hon. Leke Abejide:

“That the House do consider the Report of the Committee on Customs and Exercise on the issue from the Statutory Revenue Fund of the Nigeria Customs Service's Projected Revenue the total sum of ₦1,132,548,855,205.88 (one trillion, one hundred and thirty two billion, five hundred and forty-eight million, eight hundred and fifty-five thousand, two hundred and five Naira, eighty-eight Kobo) for the 2025 fiscal year, of which the sum of ₦1,070,488,214,675.04 (one trillion, seventy billion, four hundred and eighty-eight million, two hundred and fourteen thousand, six hundred and seventy-five Naira, four Kobo), based on a 4% FOB (Free on Board) Cost of Service, ₦33,007,042,273.87 (thirty-three billion, seven million, forty-two thousand, two hundred and seventy-three Naira, eighty-seven Kobo) is for 2% share of imports VAT for 2025, ₦29,053,598,256.97 (twenty-nine billion, fifty-three million, five hundred and ninety-eight thousand, two hundred and fifty-six Naira, ninety-seven Kobo) is fund accrued for Ongoing Capital Projects, ₦247,156,436,799.26 (two hundred and forty-seven billion, one hundred and fifty-six million, four hundred and thirty-six thousand, seven hundred and ninety-nine Naira twenty-six Kobo) is for Personnel costs, ₦239,973,932,653.35 (two hundred and thirty-nine billion, nine hundred and seventy-three million, nine hundred and thirty-two thousand, six hundred and fifty-three Naira, thirty-five Kobo) is for Overhead costs while the sum of ₦645,418,485,753.26 (six hundred and forty-five billion, four hundred and eighteen million, four hundred and eighty-five thousand, seven hundred and fifty-three Naira, twenty-six Kobo) is for Capital cost for the fiscal year, 2025 and approve recommendations therein” (*Laid: 24/5/2025*) *Committee of Supply*

Recommendations:

- (i) that the Nigeria Customs Service's projected revenue for 2025, amounting to ₦1,070,488,214,675.04 (one trillion, seventy billion, four hundred and eighty-eight million, two hundred and fourteen thousand, six hundred and seventy-five Naira, four Kobo), based on a 4% FOB Cost of Service be approved;
- (ii) that a 2% share of imports VAT for 2025, totaling ₦33,007,042,273.87 (thirty-three billion, seven million, forty-two thousand, two hundred and seventy-three Naira, eighty-seven Kobo) for the Nigeria Customs Service be approved;
- (iii) that Fund accrued for Ongoing Capital Projects, ₦29,053,598,256.97 (twenty-nine billion, fifty-three million, five hundred and ninety-eight thousand, two hundred and fifty-six Naira, ninety-seven Kobo) be approved;

- (iv) that Personnel costs for the 2025 fiscal year, amounting to ₦247,156,436,799.26 (two hundred and forty-seven billion, one hundred and fifty-six million, four hundred and thirty-six thousand, seven hundred and ninety-nine Naira twenty-six Kobo) be approved;
- (v) that Overhead costs for the 2025 fiscal year, totaling ₦239,973,932,653.35 (two hundred and thirty-nine billion, nine hundred and seven-three million, nine hundred and thirty-two thousand, six hundred and fifty-three Naira, thirty-five Kobo) be approved;
- (vi) that Capital costs for the 2025 fiscal year, with a budget of ₦645,418,485,753.26 (six hundred and forty-five billion, four hundred and eighteen million, four hundred and eighty-five thousand, seven hundred and fifty-three Naira, twenty-six Kobo) be approved;
- (vii) that the total Budget of ₦1,132,548,855,205.88 (one trillion, one hundred and thirty-two billion, five hundred and forty-eight million, eight hundred and fifty-five thousand, two hundred and five Naira, eighty-eight Kobo) be approved for Nigeria Customs Service for the 2025 fiscal year;
- (viii) urge the Nigeria Customs Service to:
 - (a) stop the collection of 1% Comprehensive Import Supervision Scheme (CISS) and 7% Cost of Collection not backed by any known law which is an Act of Parliament;
 - (b) stick to the legal 4% Free-On-Board (FOB) as their only source of income as signed into Law by the President of the Federal Republic of Nigeria in Laws of the Federation of Nigeria;
 - (c) make substantial provisions for Corporate Social Responsibility (CSR) to foster harmonious relationship with the Border Communities; and
 - (d) re-introduce Excise on Telecomm Services and Single-used plastics policies.

11. Committee on Police Affairs:

Hon. Makki Abubakar Yalleman:

“That the House do consider the Report of the Committee on Police Affairs on a Bill for an Act to Amend the Nigeria Police Trust Fund Act No. 6 of 2019 to Increase the duration of the Trust Fund for continued training, Provision of Security Equipment, and Related Facilities, enhance the Skills of the Personnel of the Nigerian Police and for Related Matters (HB.1720) and approve recommendations therein” (Laid: 24/6/2025).

12. Committee on Governmental Affairs:

Hon. Nwachukwu Canice Moore Chukwugozie:

“That the House do consider the Report of the Committee on Governmental Affairs on a Bill for an Act to Repeal the National Lottery Act No. 7 of 2005 and the National Lottery (Amendment) Act No. 6 of 2017, and to Enact the Central Gaming Bill to Regulate the Operation and Business of all forms of Online and Remote Gaming Across the Geographical Boundaries of the Federating Units and beyond the Borders of Nigeria, Provide for the Conduct of Gaming in the Federal Capital Territory, and enhance Revenue Generation for the Federation and for Related Matters (HB. 2062) and approve recommendations therein” (Laid: 28/5/2025).

13. *Ad-hoc* Committee on the Petition by Comrade Igbini Odafe Emmanuel (Engr) against Total Energies E & P Nigeria Limited:

Hon. Kwamoti Bitrus Laori:

“That the House do consider the Report of the *Ad-hoc* Committee on the Petition by Comrade Igbini Odafe Emmanuel (Engr) against Total Energies E & P Nigeria Limited on Unethical Conduct perpetuated by the Management of the Company and approve recommendations therein (Laid: 13/3/2025)”.

- (i) that the Petitioner, being a permanent and pensionable senior staff of Total Energies EP Nig. Ltd and whose employment was terminated with disregard and without due compliance to

statutory guidelines, is entitled to recall and reinstatement to the company, his employment not being one of a mere master/servant relationship but one tainted with statutory flavour. He should therefore be recalled and reinstated by the company as has been decided by the Supreme Court;

- (ii) that considering the total non-compliance to due process in the procedure that led to the termination of employment of the petitioner, the *Ad-hoc* Committee hereby recommend that with cognizance to his entitled promotions in service to at least the position of Executive Director. All promotions due the Complainant be affected as at when due up to the time of his retirement on 1st January 2024;
- (iii) that all Salaries, Allowances and all other Entitlements be paid in full to the Petitioner from August 1, 2000 as and at when due in line with his cadre and promotions till the date of his supposed statutory retirement after 35 years in 1st January, 2024);
- (iv) that the Respondent should be enrolled to the pension scheme of the company and his retirement benefits and all other benefits due to the Complainant be paid to him in full; and
- (v) that Total Energies EP Nig. Ltd retracts the Public Disclaimers of the Petitioner in This Day Newspaper, Vanguard Newspaper and The Tide Newspaper.
