Need for Intervention in the communal crisis and Flooding Disaster in Konshisha Local *(i)* Government Area, Benue State:

Hon. David Agada Ogewu (Oju/Obi Federal Constituency and 2 Others) introduced the matter and prayed the House to:

- *(a)* consider and approve the matter as one of urgent public importance; and
- suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith. *(b)*

Question that the matter be considered as one of urgent public importance — Agreed to.

Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith - Agreed to.

Need for Intervention in the communal crisis and Flooding Disaster in Konshisha Local **Government Area, Benue State:**

The House:

Notes that Section 14 (2) (b) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) provides that the security, safety and welfare of the people of Nigeria shall be the primary purpose of government;

Recalls that sometimes in July 2024, a Motion was moved about Ubajor, Ubatwe and Umajobor communities of Konshisha Local Government Area which had been engaged in communal crises, wherein plethora of people were killed and rendered homeless in Okpenehi,

Ogilewu and Imankodi communities of Oju Local Government Area of Benue State, consequent upon land dispute. The crises have displaced most people and properties worth hundreds millions of Naira were destroyed;

Also recalls that on 5 July, 2024, Bonta community of Konshisha Local Government engaged Ukpute community of Oju Local Government Area of Benue State again on same land dispute particularly with disagreement to boundary demarcation that led to the loss of lives and properties, and on 10 July, 2024, another Ukpute man was killed by Bonta Militia while working in his farm, while Banta Militia have unabatedly attacked the people of Ukpute community on several occasions, the age-long crisis is as a result of the inaction of the relevant Federal and State agencies to adopt and enforce the existing boundary demarcation survey/documents with file **No. Otukpo Sheet 270 SE**, as conducted by the Surveyor General of the Federation and domiciled with the Kaduna office of the National Boundary Commission;

Worried that sometimes in August 2024, a truck of fertilizer from Federal Government meant for the people of Oju/Obi Federal Constituency was blocked and ceased by the Bonta Militia; rendering the Oju-Awarji road connecting Konshisha and Oju Local Government Areas of Benue State is at the moment impassable and impervious, due to the garrison of Banta Militia;

Aware that the crises and insecurity bothered on land dispute which has to do with the boundary demarcation and that if the relevant authority concerning boundary demarcation do not take frantic efforts and have these disputed areas; boundary demarcated in line with the existing order and laws, the reoccurring clashes between these communities would continue unabated and lead to further loss of lives and properties;

Further recalls that sometime ago these Bonta Militia killed about 12 soldiers and this needs not to be handled with kid-gloves for the sake of the two affected communities;

Also worried that as a result of the heavy downpour and deluge; Otakini- Ainu community of Oju Local Government Area of Benue State is engulfed with a very devastating flood, which washed away farmlands, road and houses. As it stands the road connecting the densely populated people of Otakini, Ekpong, Okoyongo, Achangba of Oju and Obi Local Government Areas of Benue State is impassable and the communities are submerged in the flood; leading to untold loss of lives and properties rendering survivors homeless and in dire need of food and shelters;

Resolves to:

- (*i*) observe a minute silence in honour of those who lost their lives;
- (*ii*) urge the National Emergency Management Agency (NEMA) to assist in providing the people with relief materials to cushion the effect of the crises and flood disaster as many are already dying of starvation;
- (iii) also urge the Executive Arm of Government to beef up security in the Local Government Area especially the affected communities and a combine security (Army, Police, DSS, and Civil Defence operation base should be established between the two communities of Oju and Konshisha Local Government Areas of Benue State with constant security patrol around the affected area;
- (*iv*) further urge the National Boundary Commission in conjunction with the relevant agencies in Benue State to resolve these incessant crises with finality by demarcating the boundary between the two communities of Banta and Ukpute, in line with the

original boundary demarcation/ survey documents domiciled with Kaduna office of the National Boundary Commission as conducted by the Surveyor General of the Federation with file **No. Otukpo Sheet 270 SE**. Federal Government should monitor this process by deploying security personnel to ensure a smooth boundary demarcation exercise and safety of the people (*Hon. David Agada Ogewu — Oju/Obi Federal Constituency*).

- (ii) Need to Address the Massive Flooding, Destruction of Farmlands, and Damage to Federal Roads, in Benue State:
 Hon. Terseer Ugbor (Kwande/Ushongo Federal Constituency) introduced the matter and prayed the House to:
 - (a) consider and approve the matter as one of urgent public importance; and
 - (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

Question that the matter be considered as one of urgent public importance – Agreed to.

Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith - Agreed to.

Need to Address the Massive Flooding, Destruction of Farmlands, and Damage to Federal Roads, in Benue State:

The House:

Notes that the annual incidence of flooding caused by over flowing of the River Benue has led to massive loss of farm lands, displacement of thousands of persons from their homes and submerged major roads within the Benue State has become a national emergency which cannot be ignored any longer;

Also notes that the road linking Gboko-Ugbema-Kwande-Kashimbila-Cameroon is a very important road for regional trade and transit routes that serves as a crucial link between eight Local Governments including Buruku, Kwande, Ushongo, Logo, Katsina-Ala, Ukum,

Vandeikya, Konshisha) of the Benue North Central region. It is not only significant for local trade and transportation, but it also connects the State to neighbouring States like Taraba and Cross River, further extending our reach to international borders with Cameroon;

Concerned that the current state of the Gboko-Ugbema-Kwande road is alarming, conditions on this road have become increasingly perilous, transforming it into a death trap for motorists and travellers and the dilapidated road has resulted in frequent armed robbery attacks on innocent travellers and extended travel times, with motorists spending up to a week navigating these treacherous conditions just to reach their destinations, making the situation unbearable and demanding immediate attention;

Worried that the implications extend beyond mere inconvenience, while the ongoing deterioration of the road has severely impacted the livelihood of farmers who rely on the route to transport their perishable goods to markets, many facing devastating losses, as their harvests perish while they attempt to navigate this unsafe passage, and the loss of lives and goods due to the flooding and infrastructural neglect is a tragic reality that can no longer be ignored;

Observes that the road in context was earmarked for rehabilitation in the Supplementary Budget of the Federal Government of Nigeria, allocated to the Federal Roads Maintenance Agency (FERMA), but has been unfortunately abandoned, with no potential or visible attempt that the road would be rehabilitated before the festive season;

Resolves to:

- (*i*) urge the Federal Ministry of Works and the Federal Roads Maintenance Agency (FERMA) to immediately commence repairs on the failed portion of the road to ease movement during the festive season;
- (*ii*) invite the Federal Roads Maintenance Agency (FERMA) to explain the contract award for the road, including other ongoing rehabilitation projects nationwide to ease movement before the high traffic festive season;
- (*iii*) mandate the Committees on Works, and Federal Roads Maintenance Agency (FERMA) to ensure compliance and report within four (4) weeks (*Hon. Terseer Ugbor Kwande/Ushongo Federal Constituency*).

Agreed to.

11. A Bill for an Act to Establish Jury Trial and Services for special Crimes, Corruption and other Offences and the Administration of Jury Trials Criminal Justice in the Federal High Court and FCT High Court Division and for Related Matters (HB. 293) — *Second Reading*

Order read; deferred by leave of the House.

12. Matter Requiring Attention of the House

Hon. Isa Bello Ambarura (*Illela/Gwadabawa Federal Constituency*), drew the attention of the House to a motion presented by Hon. Chinedu Emeka Martins, on Wednesday, 16 October, 2024, "*Call on Airline Operators to Compensate Passengers for Flight Cancellations and Delays*". He recalled

that Hon. Kelechi Nwogu had raised a point of Order, stating that he had presented a motion on the same subject matter, and that the House had referred the matter to a Standing Committee. He also recalled that Mr Speaker had ordered that Hon. Chinedu Emeka Martins' motion be stepped down to enable the Committee on Rules and Business ascertain the veracity or otherwise.

He informed the House that the Committee on Rules and Business confirmed that Hon. Kelechi Nwogu's motion was presented on 25 October, 2023, and that by virtue of effluxion of time, Hon. Chinedu Emeka Martins' motion can be resumed.

Ordered: Hon. Kelechi Nwogu's motion is not caught up by effluxion of time and as such, Hon. Chinedu Emeka Martins' motion be withdrawn.

13. Outstanding Bill from Preceding Assembly

Motion made and Question proposed:

The House:

Notes that the Constitution Alteration Bill, 2024 (HB. 1630), seeks to alter the Constitution of the Federal Republic of Nigeria, 1999 (as amended) to provide for independent candidacy;

Constitution of the Federal Republic of Nigeria, 1999 (Alteration) (Independent Candidates) Bill, 2024 (HB. 1630)

Also notes that the Bill was duly passed by the preceding Assembly but was not assented to;

Aware that Order Twelve, Rule 17 of the House of Representatives Standing Orders permits the reconsideration of outstanding Bills from the Preceding Assembly and provides that:

- (a) the Bill may upon being re-gazetted and circulated, reconsider in the Committee of the Whole, without commencing *de novo*, the Bills,
- (b) whose report was presented by the Committee before consideration,
- (c) passed by the House and forwarded to the Senate for concurrence, for which no concurrence was made or negative,
- (d) passed by the Senate and forwarded to the House for which no concurrence was made or negative, or
- (e) passed by the preceding Assembly and forwarded to the President for assent, but for which assent or withholding thereof was not communicated before the end of the tenure of the preceding Assembly;

Also aware that Order One, Rule 1 (2) empowers the House to regulate its procedure by resolution in circumstances not expressly covered;

Cognizant of the importance and constitutional implications of the Bill, and based on the combined effect of Order Twelve, Rule 17 and Order One, Rule 1 (2), recommit Constitution of the Federal Republic of Nigeria, 1999 (Alteration) (Independent Candidates) Bill, 2024 (HB. 1630) to the Committee on Constitution Review;

Resolves to:

Recommit the Constitution of the Federal Republic of Nigeria, 1999 (Sixth Alteration) Bill, 2024 (HB.1630) to the Committee on Constitution Review for comprehensive consideration (*Hon. Isa Bello Ambarura — Illela/Gwadabawa Federal Constituency*).

14. Need to Construct Embankment Around Askunne Bridge, Talata Mafara, Zamfara State *Motion made and Question proposed:*

The House:

Notes that the Askunne Bridge is an important transportation link in Talata Mafara Local Government Area of Zamfara State connecting communities and facilitating economic activities in neighboring states of Kaduna, Kano, Katsina, Sokoto, Kebbi, etc.;

Also notes that the bridge consistently experiences flooding during rainy seasons, disrupting traffic and posing safety risks to commuters with the most recent flooding occurring during this year's rainy season;

Aware of the need to rehabilitate the road top surface of the bridge and its environs in order to make it smooth, safe and conducive for the road users;

Also aware that the construction of an embankment and ecological safeguards will help control water flow, prevent bridge submersion during heavy rains, and improve infrastructure and connectivity in Talata Mafara, supporting economic and social development in the region;

Cognizant of the need to construct an embankment on the Askunne bridge to prevent further flooding and collapse, ensure the safety of the bridge and the lives of commuters, while also implementing ecological safeguards.

Resolves to:

- (*i*) urge the Ecological Fund Office to conduct a "Needs Assessment" of the affected bridge to ensure its safety from further flooding and potential collapse;
- (*ii*) also urge the Federal Roads Maintenance Agency (FERMA) to conduct a "Needs Assessment" of the top surface of the bridge and its environs to ascertain its repair status and take necessary steps to rehabilitate the bridge; and
- (*iii*) mandate the Committees on Ecological Fund and Federal Roads Maintenance Agency (FERMA) to ensure proper oversight and follow-up with the Ecological Office of the Federation and FERMA and report within four (4) for further legislative action;
- (*iv*) also mandate the Committee on Legislative Compliance to ensure compliance (*Hon. Isa Mohammed Anka Anka/Talata Marafa Federal Constituency*).

Agreed to.

Concerned that the existing funds provided for the Bureau is grossly inadequate to meet the extensive responsibilities of the procurement audits, monitoring and surveillance in the Ministries, Departments and Agencies (MDAs) in the six geopolitical zones of the nation;

Also concerned that given the prevailing trend of procurement irregularities in Nigeria, constituting over 70% of corruption in the public sector, there is an increasing need to ensure the implementation of procurement policies, and due process compliance, in line with global best practices;

Cognizant that the increasing rate of procurement irregularities in the public sector necessitate urgent measures for effective oversight to ensure value-for-money, transparency, competitiveness and professionalism;

Resolves to:

The House:

Notes the negative impacts of flooding and gully erosion in Ubah-Isunjaba, Uburu Ekwe, Umunam, Amaju-Amaigbo, Amucha, Okwudor, Umuozu, Umuokwara-Ihebinowerre, Umuezikeukwu and other locations in Isu, Njaba, Nkwerre, Nwangele Local Government Areas, Imo State;

Aware that erosion has led to the loss of fertile top soil, affecting farmers' livelihoods and resulting in decreased agricultural productivity;

Worried that the devastating effect of the gully erosion has caused property destruction and compounded the integrity of substructure building, causing residents to evacuate without shelter due to fear of collapse, hence the need for temporary shelters and relief materials;

Also worried that the deteriorating condition of the roads poses severe safety and security risks to commuters often resulting in fatal accidents and increased cases of kidnapping;

Concerned that if remedial action is not taken during this rainy it will may lead to heavy landslide with severe health issues, loss of human lives and negative impact on agricultural productivity;

Convinced that if the menace of this gully erosion is controlled, it shall bring succour and relief to the people of Isu, Njaba, Nkwerre, Nwangele Local Government Areas, especially families and Communities directly affected by this gully erosion;

Resolves to:

- (i) urge the Ecological Funds office and Federal Ministry of Environment to immediately commence remedial work of erosion control and land reclamation in Ubah-Isunjaba, Uburu Ekwe, Okwudor, Umuokwara-Ihebinowerre, Umunam, Amaju-Amaigbo, Amucha, Umuezikeukwu, Umuozu and other locations in Isu, Njaba, Nkwerre, Nwangele Local Government Areas, Imo State;
- (*ii*) also urge the National Emergency Management Agency (NEMA) to provide immediate relief materials to ameliorate the sufferings of the affected people;
- *(iii)* further urge the Niger Delta Development Commission (NDDC) to capture the repair and reconstruction of failed roads in the 2025 budget estimates; and
- (*iv*) mandate the Committees on Environment, Ecological Funds and Niger Delta Development Commission (NDDC) to ensure compliance (*Hon. Harrison Anozie Nwadike — Isu/Njaba/Nkwerre/Nwangele Federal Constituency*).
