### HOUSE OF REPRESENTATIVES FEDERAL REPUBLIC OF NIGERIA VOTES AND PROCEEDINGS

Thursday, 5 October, 2023

- 1. The House met at 11.15 a.m. Mr Deputy Speaker read the Prayers.
- 2. The House recited the National Pledge.

#### 3. Votes and Proceedings

Mr Deputy Speaker announced that he had examined and approved the *Votes and Proceedings* of Wednesday, 4 October, 2023.

The Votes and Proceedings was adopted by unanimous consent.

#### 4. Remarks by the Deputy Speaker

Esteemed colleagues, as we have noted today, it is evident that our Order Paper is filled with motions and requests for federal road rehabilitation and construction projects. While these requests are essential for the development and connectivity of our nation, the truth we must confront is that there is a stark financial challenge before us.

According to data provided by the Minister of Works, Engineer Dave Umahi, we currently face a backlog of 269 projects requiring immediate attention, with a staggering cost of  $\aleph$ 217 billion. To put this into perspective, it would take a monumental sum of Seven Trillion Naira to address all the federal road issues in the South-East alone. Our current budgetary allocations for ongoing capital projects in the 2023 budget amount to  $\aleph$ 530 billion, with  $\aleph$ 61 billion earmarked for road rehabilitation and  $\aleph$ 185 billion for road construction.

Clearly, we have a unique financing problem on our hands, one that demands innovative solutions. Nigeria's vision for transportation infrastructure development, as outlined in the 2021 National Integrated Infrastructure Master Plan, recognizes the need to galvanize private capital for the overhaul of our ailing infrastructure. The plan estimates that we need at least \$575 billion over the next 22 years to meet the demands of our growing economy and population.

Already, in our previous sessions, the House took the initiative to pass the Federal Road Fund Bill, which introduces innovative funding mechanisms for addressing the broader issue of deteriorating road infrastructure across the country.

In response to this challenge, the federal government has embarked on promising initiatives, including the Private-Public Partnership fund, InfraCo, which boasts an initial public-private capital fund of \$1.6 billion, backed by institutions like the Africa Finance Corporation (AFC), the Nigeria Sovereign Investment Authority (NSIA), and the Central Bank of Nigeria (CBN).

I implore all esteemed colleagues to consider this direction seriously. Instead of merely advocating for more government financing, let us focus our efforts on catalyzing innovative private-sector financing models for road rehabilitation and construction projects. By embracing these new approaches, we can work together to address the pressing infrastructure needs of our nation effectively.

In addition, as a House, we should also strive to dedicate a day where we can extensively deliberate on improving legislation similar to the Federal Road Fund Bill in the 9th Assembly that unlocks a flurry of financing alternatives for road infrastructure upgrades in the country.

### Need to Address the Unfortunate Death of Miss Greatness Olorunfemi by One Chance Syndicate in Abuja:

intentionally of his or her life and that every Nigerian citizen is entitled to move freely throughout Nigeria, and to reside in any part therein respectively;

*Also notes* that the right to life, safety and security of a person which are crucial fundamental human rights, which any reasonable government must upheld are being threatened as residents of Abuja are living in constant fear and vulnerability due to the growing cases of insecurity and can no longer go about their businesses peacefully;

Aware that in recent times, the Federal Capital Territory (FCT) has become a hotbed of insecurity characterized by frequent robbery, kidnapping and killing of motorists and commuters;

*Concerned* about the different tactics and daring manner used by these criminals/thieves who disguise as taxi operators (one chance) to carry out their devilish intentions by deceiving unsuspecting commuters by leaving one seat for them;

*Also concerned* that this deteriorating situation of insecurity and incessant attacks in the "Seat of power" has made motorists and commuters to become fearful and vulnerable to indiscriminate robberies and kidnapping consuming the once peaceful atmosphere in Abuja and its environs;

*Cognizant* of the recent unfortunate death of Miss Greatness Olorunfemi who was the latest victim of one chance operation in Abuja, a vibrant young lady who passed away on 26 September, 2023 after she was allegedly pushed off a moving vehicle by a suspected one chance syndicate along the Maitama- Kubwa road;

Also cognizant that on 20 September, 2023 an elderly woman was abducted and dispossessed of all her valuables including money and jewelries after she boarded a commercial vehicle in Zone 3 area of FCT and unknown to her was occupied by one chance syndicate, her abductors also demanded for the sum of \$500,000.00 from the family members as narrated by her daughter @bigTems via her X social media handle;

*Further cognizant* of the fact that some weeks ago, a Legislative Aide while returning from work unknowingly boarded a one chance vehicle wherein her mobile phone was collected and a large sum of money was transferred from her bank account via a PoS machine, and also the case of the wife of a journalist who was kidnapped in front of NNPC Tower and taken to an unknown destination where she was dispossessed of her phone, other belongings and push out of the vehicle;

*Also aware* that some of the red flags spots according to multiple reports which are identified to be plied by these criminals/one chance syndicate in Abuja include Area 1Berger, Area 1-Area 10, Area 1- Lugbe, Apo Mechanic Village Axis, Kubwa expressway and along, Jabi axis, City Gate, Area 1 under bridge and across, Area 2 plaza behind VIO Office area, Zone 2 and Zone 3 among others;

#### Resolves to:

- (*i*) observe a minute silence in honour of Miss Greatness Olorunfemi and other victims of insecurity and one chance operations;
- (*ii*) urge the Federal Government, the Nigeria Police force, Federal Road Safety Corps (FRSC), Vehicle Inspection Officers (VIO) and other relevant security agencies to:
  - (*a*) work together for a comprehensive review of the security measures within the FCT so as to develop a working strategy to resolve the cases of robbery,

kidnapping and other criminal activities, to prevent further harm on the citizens,

- (b) ensure that the culprits involved in one chance operations within the FCT are brought to book;
- (*iii*) also urge the Executive Arm of Government to ensure the installation of close circuit cameras in various and strategic locations across the FCT;
- (iv) further urge the Federal Capital Territory Administration (FCTA) to ban commercial vehicles with tinted glasses, mandate commercial drivers to have commercial plate numbers and mandate that commercial vehicles to be painted in the colour of the State in which they operate, e.g., Abuja- Green and White colour, as well as insists on the installation of cameras in all approved taxi and commercial vehicles;

*Notes* that Mubi North and Mubi South Local Governments constitute significant pillars of trade, commerce and agricultural activities that contribute economic development of Adamawa State and the Nigeria in general;

Aware that the strategic locations of Mubi-North and South neighbouring the Republic of Cameroon create a flourishing opportunities to maximize the prospects of the presidential Economic Diversification Initiative (PEDI), aimed at improving the welfare, security and economic prosperity of Nigerian citizens;

*Worried* that the deteriorating condition of Mubi-Maiha, Mubi-Gella and Mubi-Sahuda roads will constitute an impediment in realizing the anticipated socio-economic opportunities;

*Concerned* that the condition of the roads resulted in frequent accidents and a massive decline in economic activities and loss of lives;

*Regrets* that the primary purpose of government may be completely lost if urgent action is not taken to address the dilapidated existing road infrastructure connecting Mubi-North and Mubi-South to the neighbouring Local Governments in order to sustain the traditional established socio-economic activities in the affected areas;

#### Resolves to:

- (*i*) urge the Federal Ministry of Works to include the road rehabilitation project of Mubi-Maiha, Mubi-Gella and Mubi-Sahuda in the 2024 budget estimates; and
- (*ii*) mandate Committee on Works to ensure compliance (*Hon. Jingi Rufai Maiha/Mubi* North/Mubi South Federal Constituency).

Agreed to.

**20.** Investigation of the Nation's Galloping Non-Debt Recurrent Expenditure *Motion made and Question proposed:* 

The House:

*Notes* that the Federal Government personnel expenses, pensions and other non-debt recurrent expenditures increased by 241% in 13 years from \$2.4 trillion in 2011 to \$8,27 trillion in 2023;

Also notes that the total non-debt expenditure from 2011 to 2023 is \$51.97 trillion while \$42.24 trillion expended from 2015 till date represents 81.8% of the total expenditures of the period under review;

*Aware* that the country's revenue within the period received massive hits from debt servicing obligations, the government have little or nothing left for the recurrent expenditures and has resorted to borrowing;

Also aware that the Debt servicing obligations gulped 97 per cent of the total revenue of the \$3.42 trillion generated in 2011, Nigeria expended \$3.34 trillion on debt servicing, meaning all Federal Government's salaries, overhead and Capital Expenditure was financed with loans and Central Bank of Nigerian support;

*Informed* that the country's revenues of  $\aleph$ 3.42 trillion in 2020,  $\aleph$ 4.39 trillion in 2021 and N7trillion in 2022 could hardly fund the wage bill of  $\aleph$ 5.7 trillion,  $\aleph$ 5.76 trillion and  $\aleph$ 7.1 trillion in 2020, 2021 and 2022 respectively;

*Worried* that the Federal Government wage bill, pension obligations and other non-debt recurrent expenditures continue to grow significantly, despite the marginal increases in revenues and apparent increases in debt servicing pressure;

Also worried that the sharp difference in the wage bill from  $\aleph 2.4$  trillion in 2011 and  $\aleph 8.7$  trillion in 2023 in a country of 113 million people living in multidimensional poverty is alarming and unjustifiable;

*Concerned* that despite the present administration economic restructuring policies, revenues cannot continue to pay salaries and other recurrent expenditures when there are still humongous debt servicing obligations to be taken care of;

#### Resolves to:

- (*i*) urge the Executive Arm of Government through the Office of the Secretary to the Government of the Federation to carry out a forensic audit of its staff to address the problem of ghost workers to save money and reduce the increasing wage bill; and
- *(ii)* also urge the Executive Arm of Government to embark on cost-cutting measures to reduce other non-debt recurrent expenditures;
- (*iii*) mandate the Committee on Finance to investigate the matter and report;
- (*iv*) mandate the Committee on Legislative Compliance to ensure compliance (*Hon. Ademorin Aliu Kuye Shomolu Federal Constituency*).

trillion generated in 2011, Nigeria expended ₦3.34 trillion on debt servicing, meaning all Federal Government's salaries, overhead and Capital Expenditure was financed with loans and Central Bank of Nigerian support;

*Informed* that the country's revenues of  $\aleph$ 3.42 trillion in 2020,  $\aleph$ 4.39 trillion in 2021 and N7trillion in 2022 could hardly fund the wage bill of  $\aleph$ 5.7 trillion,  $\aleph$ 5.76 trillion and  $\aleph$ 7.1 trillion in 2020, 2021 and 2022 respectively;

*Worried* that the Federal Government wage bill, pension obligations and other non-debt recurrent expenditures continue to grow significantly, despite the marginal increases in revenues and apparent increases in debt servicing pressure;

Also worried that the sharp difference in the wage bill from  $\aleph 2.4$  trillion in 2011 and  $\aleph 8.7$  trillion in 2023 in a country of 113 million people living in multidimensional poverty is alarming and unjustifiable;

*Concerned* that despite the present administration economic restructuring policies, revenues cannot continue to pay salaries and other recurrent expenditures when there are still humongous debt servicing obligations to be taken care of;

#### Resolved to:

- (*i*) urge the Executive Arm of Government through the Office of the Secretary to the Government of the Federation to carry out a forensic audit of its staff to address the problem of ghost workers to save money and reduce the increasing wage bill; and
- *(ii)* also urge the Executive Arm of Government to embark on cost-cutting measures to reduce other non-debt recurrent expenditures;
- (*iii*) mandate the Committee on Finance to investigate the matter and report;
- *(iv)* also mandate the Committee on Finance to investigate the position of the contributory pension, particularly the percentage contributed by the employer and employee
- (v) further mandate the Committee on Legislative Compliance to ensure compliance (HR. 214/10/2023).

# 21. Deplorable state of Akonike Junction-Ugwuomu-Emene NNPC Depot-Abakaliki/Ogoja Gateway in Enugu State to Reduce the High Rate of Accidents in the Area *Motion made and Question proposed*:

The House:

*Notes* that Akonike Road Junction-Ugwuomu-Emene -NNPC Depot/Abakaliki/Ogoja gateway road approximately 24.1 km is a major highway linking the Southeast and parts of south-south to the Northern region of the country;

*Also notes* that the socio-economic development of the constituency bordering the road has been stalled due to the deplorable state of the roads which adversely affected the free flow of traffic and occasioned a high rate of accidents and deaths;

*Further notes* that the road sections from Ako-Nike junction along Enugu/Ugwogo/ OPI Nsukka road harbours major economic concerns such as the NNPC Depot, Federal Ministry of Works, a private University and a Nigeria Army Estate, when stimulate high volume of human and vehicular traffic estimated to be about 4,231,980 for the daily movement of essential goods, services and passengers in and out of the southeast and northern parts of the country;

*Disturbed* that the month-long gas flaring from an OPL gas well in the area could not be accessed for weeks due to limited road access;

*Also disturbed* that the deplorable and impassable state of the roads is a source of worry for over 10 million people who transverse the roads, thus becoming a haven for kidnappers, armed robbers and urchins for nefarious activities on innocent citizens unhindered;

*Worried* that as at December 2022, the Federal Road Safety Commission, recorded a total of 9,383 incidents, with 2,587 being fatal and 5,121 people killed across the country within the period, while the two Local Government Areas account for 516 crashes and 197 deaths;

*Aware* of the social-economic importance of the road to the people of the South East and South South zone it will create room for employment, and contribute to infrastructure development;

*Cognizant* that if urgent action is not taken to construct the Akonike Junction-Ugwuomu-Emene Nnpc Depot-Abakaliki/Ogoja Gateway in Enugu State to forestall further accidents and loss of lives and properties it will lead to economic devastation to the nation;

#### Resolves to:

- (i) mandate the Committee on Works to liaise with the Federal Ministry of Works, and the Federal Roads Maintenance Agency (FERMA) to come up with a workable modality that will ensure the speedy construction of the Akonike Junction-Ugwuomu-Emene NNPC Depot -Abakaliki/Ogoja road;
- (*ii*) also mandate the Committees on Works and Appropriations to include Construction of the Road in the 2024 budget estimates (*Hon. Paul Sunday Nnamchi Enugu East/Isi-Uzo Federal Constituency*).

*Aware* of the recent rainstorm disaster that affected Okpella in Etsako East Local Government Area, washing away the bridge connecting Iddo-Okugbe with Awuyemi leading to the Federal Highway, electricity poles and communication facilities connecting parts of the State in the country;

*Also aware* that in Etsako West Local Government Area, there are several cases of gully erosion sites of different magnitudes posing significant danger to lives and properties in the communities in those areas rendering vehicular movement from the Northern to Southern parts of the country through the route impassable;

*Cognizant* of the need to stem this ugly trend of environmental degradation in Etsako Federal Constituency, Edo State;

Resolves to:

- (*i*) urge the Rural Electrification Agency to replace the damaged electricity poles, wires and to reconnect the affected communities to the national grid;
- (*ii*) also urge the Federal Road Maintenance Agency (FERMA) to urgently intervene and reconstruct the bridge linking Iddo-Okugbe Communities with Awuyemi Community and Ayogwiri-Ogbona axis of the Auchi to Agenebode Federal Highway to allow immediate access by vehicles and commuters to other parts of the country;
- (*iii*) further urge the Federal Ministry of Works to compel the Contractors handling the road project to resume work without delay;
- (*iv*) again urge the Federal Ministry of Environment and the Office of Ecological Fund to declare a state of emergency on Auchi and its environment to provide holistic remediation to safeguard lives and properties in Etsako Federal Constituency, Edo State;
- (v) still urge the Federal Ministry of Humanitarian Affairs and Poverty Alleviation and National Emergency Management Agency (NEMA) to provide relief materials to affected Communities across Etsako Federal Constituency, Edo State; and
- (vi) mandate the Committees on Federal Roads Maintenance Agency, National Emergency Management Agency, Ecological Fund, and National Rural Electrification to ensure compliance and report within four (4) weeks (*Hon. Anamero Sunday Dekeri — Etsako Central/Etsako East/Etsako West Federal Constituency*).

Agreed to.

*Notes* that the Otuocha-Anam-Nzam-Inoma-Iheaka-Ibaji-Odulu-Ajegwu Federal road is a strategic road linking Anambra and Kogi States through Anambra West Local Government, connecting Ibaji Local Government as well as other Northern States from the South-East;

Also notes that the road is about 88 kilometres to Lokoja and the shortest route from South-East to Abuja, as well as other Northern States;

*Worried* that the rehabilitation of the road was abandoned due to lack of funds, leaving it in the worst deplorable condition, with robbery attacks and kidnappings, activities endangering the lives of commuters and other users within the axis;

*Aware* that the Federal road cut across over twenty-five agrarian communities in Anambra and Kogi States, however the deplorable road nature of those poses great threat to the socio-economic life of the people;

Worried that about 80% of agricultural produce come from Anambra and Kogi States, as the food

baskets of the nation contributing about 4096 to the nation's Agricultural sector;

*Also worried* that people no longer ply this road, during rainy season as, harvesting farm produce is difficult ,thereby translating into huge wastes and losses;

*Cognizant* of current harsh economic reality in the country, and the need for the Otuocha-Anam-Nzam-Innoma-Iheaka-Ibaji-Odulu-Ajegwu Federal Road in Anambra East and West Federal Constituency of Anambra State to be rehabilitated in order to reduce the escalating bad economic conditions of the people;

Resolves to:

- (*i*) urge the Executive Arm of Government to interface with the Federal Ministry of Works and Federal Roads Maintenance Agency (FERMA) to commence the rehabilitation on the road;
- (*ii*) mandate the Committee on Legislative Compliance to ensure compliance (*Hon. Peter* Aniekwe Anambra East/Anambra West Federal Constituency).

#### Agreed to.

*Also notes* that the infiltration of illegal and artisanal miners contribute to the increasing insecurity in the areas;

*Aware* that the nature of illegal miners with the absence of accurate data is making monitoring and regulating their activities a herculean task;

*Also aware* that the attacks on the people have generated public outcry, thus necessitating the need for special military presence in communities Zamfara State;

*Worried* that the continuous attacks on Anka, Talata-Mafara, Bukkuyum, Maradun, and Bungudu Local Government Areas of Zamfara State have led to the loss of lives, properties and liberty of the people;

*Cognizant* that the Chief of Army Staff recently launched "Operation Hakorin Damisa" in Mangu Local Government Area of Plateau State to deal with security upsurge in the state;

*Also cognizant* that if the action of the Chief of Army Staffs if replicated in Zamfara State it will go a long way in curbing insecurity in the State;

Resolves to:

- (*i*) urge the Chief Army Staff to launch a special operation in the affected areas of Zamfara State to deal with the issue holistically and ensure air surveillance in Zamfara State to identify hideouts of bandits and crush them entirely;
- (*ii*) also urge the State Security Services (SSS) to increase security information gathering across Zamfara State to identify bandits or informants or protectors of the bandits in the communities and deal with them according to the law of Terrorism of the country;
- (*iii*) further urge the Inspector General of Police ("IGP") and other security operatives manning the roads of the affected areas of Zamfara State to increase surveillance of those roads to protect people plying the roads and filtering bandits that may test the efficacy of the security on those roads;
- (*iv*) again urge the Federal Ministry of Solid Minerals Development, the Mining Cadaster Office and other relevant agencies of the mining sector to devise strategic mechanisms of enumerating illegal or artisanal miners to regulate and monitor their activities to enhance the security of the affected areas; and

#### The House:

*Notes* that Aba branch Mbano-Afor Oru-Ahiara junction-Ahiazu Mbaise-Eke Nguru-Aboh Mbaise-Oboama-Ezinihitte-Okpala expressway, which cuts across Ehime-Mbano, Ahiazu-Mbaise,

Ezinihitte-Mbaise, Aboh-Mbaise and Ngor-Okpala Local Government Areas in Imo State is a major link road that connects Imo State to Enugu, Abia, Rivers and other States in the country;

*Concerned* that due to many years of neglect, the road has broken badly and is in such a deplorable State that it has become impassable, putting commuters at great risks as they try to navigate the route;

*Also concerned* that as a result of the devastating condition of the road, commuters are forced to create alternative routes by creating pathways through peoples' ancestral homes and compounds, which often results in destruction of farmlands and incessant altercation between the villagers and motorists;
