# Non-Payment of Contractors Working with Federal Ministries, Departments, and Agencies (MDAs) Since 2024:

*Notes* with grave concern that contractors across all Federal Government Ministries, Departments, and Agencies (MDAs) have not received payment for certified work completed since October 2024, despite budgetary provisions for capital projects in the 2024 Appropriation Act;

Also notes that budget releases under the 2024 financial year to MDAs remain below 50%, resulting in widespread project abandonment, financial distress among contractors, and overall negative impact on the economy;

Aware that the non-payment has severely hindered the implementation of critical constituency projects, undermined public confidence in government delivery, and weakened investor trust in the nation's infrastructure sector;

Concerned that the delay in payment to contractors has resulted in job losses, stalling of infrastructure development, and disruptions to community-based projects across the Federation;

Also concerned that the situation, if left unchecked, could lead to mass protests, legal disputes, and complete paralysis of public projects;

#### Resolves to:

- (i) urge the Executive Arm of Government to:
  - (a) take immediate administrative measures to clear all outstanding debts owed to contractors,
  - (b) institute a transparent payment mechanism for contractor claims to prevent recurrence of delays,
  - (c) ensure prompt releases of the fund for capital projects to safeguard jobs and

restore confidence in government project delivery;

Devastating Windstorm in Itobe, Adumu, Ajengo, Oladebu Tagidi and Umomi Communities in Ofu Local Government Area, Kogi State:

The House:

*Notes* that on Friday, 28 March, 2025, a devastating windstorm occurred in Itobe, Adumu, Ajengo, Oladebu, Tagidi and Umomi communities, all in Ofu Local Government Area of Kogi State, which destroyed properties worth over Nine Hundred Million Naira (†900,000,000.00), claimed two lives and left several persons including women and children with injuries of varying degrees;

Also notes that in the wake of the incident, rendered over 500 households homeless, with many schools, health centres and religious centres destroyed;

*Informed* that one Mr Amanda Oguche, lost his life while trying to render assistance to the victims of the devastating windstorm;

Concerned with the magnitude of the windstorm as described by Salihu Ocholi, the District Head of Itobe, in an interview granted to Arise News "The wind was acting like a dynamite — blowing concrete and solid materials that ordinarily wouldn't have been blown up; and all the iron and pieces of wood in the air were turned into missiles":

Aware that although Nigerian Meteorological Agency (NIMET) had predicted early and heavy rainfall across the nation for the year 2025, the current havoc was occasioned by not only rainfall but by accompanying windstorm;

Worried that since the unfortunate incident, the affected persons in the communities have been left stranded without shelter, food, or access to basic necessities as they are now prone to starvation, sicknesses with devastating healthcare condition which calls for swift humanitarian assistance;

#### Resolves to:

- (i) observe a minute silence for those who lost their precious lives to the incident;
- (ii) urge the National Emergency Management Agency (NEMA) to quickly ensure the supply of relief materials to the affected persons in the communities to ameliorate the sufferings of the people, as well enable them return to their normal lives (Hon. David Idris Zacharias Idah/Igalamela Odulu/Ibaji/Ofu Federal Constituency).

Incessant Attacks and Killings in Jos, with Particular Focus on Recent Violence in Bokkos and Bassa Local Government Areas, Plateau State:

#### The House:

*Notes* the continuing cycle of violence and brutal attacks against innocent citizens in Jos and surrounding communities in Plateau State, particularly the recent devastating attacks in Bokkos and Bassa Local Government Areas;

Aware that these attacks have resulted in the tragic loss of numerous lives, displacement of thousands of residents, destruction of property and severe disruption of economic and agricultural activities in the affected communities;

Worried that these incidents represent a troubling pattern of violence that has persisted in Plateau State over several years, with insufficient resolution despite previous interventions;

Also worried that the frequency and brutality of these attacks indicate serious security challenges that require urgent, comprehensive and sustainable solutions;

*Disturbed* that the humanitarian crisis resulting from these attacks continues to worsen, with inadequate relief materials and support for survivors and internally displaced persons;

Cognizant that the Constitution of the Federal Republic of Nigeria places the security and welfare of citizens as the primary purpose of government; that lasting peace in the communities is essential for National cohesion, economic development and the overall stability of the North Central region and Nigeria as a whole;

# Resolves to:

- (i) observe a minute silence for the lives lost;
- (ii) urge the President and Commander-in-Chief of the Armed Forces to direct the immediate deployment of additional security personnel to Jos, Plateau State, with specific focus on Bokkos and Bassa Local Government Areas and other vulnerable communities to prevent further attacks and restore peace;
- (iii) also urge the National Emergency Management Agency (NEMA), National Commission for Refugees, Migrants and internally Displaced Persons (NCFRMI) to immediately provide comprehensive relief materials and medical supplies to the affected communities and establish well-equipped camps for the displaced persons;
- (iv) further urge the Federal Ministry of Humanitarian Affairs, Disaster Management and Social Development to Develop and Implement a Comprehensive rehabilitation plan for the affected communities, including rebuilding of destroyed homes, schools and

healthcare facilities;

- (v) mandate the Committees on National Security and Intelligence, Defence, and Police Affairs to investigate the root causes of these persistent attacks and submit a report within four weeks, recommending sustainable solutions;
- (vi) also mandate the Committee on Legislative Compliance to ensure implementation of these resolutions and provide monthly progress reports (*Hon. Daniel Asama Ago Bassa/Jos North Federal Constituency*).

# **24.** Call to Establish More Compressed Natural Gas Conversion Centers Across Nigeria *Motion made and Question proposed*:

*Notes* that in the implementation of the Presidential Compressed Natural Gas Initiative (Pi-CNG), the federal government distributed CNG conversion kits across the country;

Also notes that the advantages of the conversion to CNG are enormous, as it will bring down the cost of living in Nigeria and reduce air and noise pollution, which makes it environmentally friendly;

Aware that its benefits are numerous, as CNG burns more cleanly than PMS, which means less carbon buildup in the engine, thus reducing the need for frequent engine repairs and prolonging the life of engine components;

Also aware that vehicles powered by CNG experience less wear and tear on critical components such as spark plugs and exhaust systems;

Further aware that for the take-off of the Presidential Compressed Natural Gas Initiative, the Federal Government proposed to establish CNG conversion Centers in some States, including Abia, Bayelsa, Cross River, and Ebonyi, with one Center each, while Akwa Ibom has 5 Centers, Delta, 9 Centers, Edo with 11 Centers, Ekiti 7 Centers, Enugu and Kogi with 3 Centers, FCT-Abuja 3 Centers, Kaduna 10 Centers, Kwara 8 Centers, Lagos 70 Centers, Nasarawa 2 Centers, Ogun 7 Centers, Oyo 17 Centers and Rivers 8 Centers:

Concerned that from the above-listed Centers, only Kaduna in the North West States is benefiting from the presidential initiative, while no State in the North East is listed as a beneficiary;

Worried at the exemption of other States from the initiative as commuters of those States are not put into consideration;

Acknowledges that States like Kano, Borno, Katsina, and Sokoto, which are commercially viable, are exempted;

Cognizant of the need to establish more Compressed Natural Gas (CNG) conversion centers in the Northwest and Northeast to facilitate legitimate business operations for all citizens;

#### Resolves to:

- (i) urge the Executive Arm of Government to establish Compressed Natural Gas Conversion Centers equitably across the country to give Nigerians a sense of belonging; and
- (ii) mandate the Committee on Gas Resources to ensure compliance and report within four (4) weeks (Hon. Sani Aliyu Madaki Dala Federal Constituency).

Debate.

*Concerned* that from the above-listed Centers, only Kaduna in the North West States is benefiting from the presidential initiative, while no State in the North East is listed as a beneficiary;

Worried at the exemption of other States from the initiative as commuters of those States are not put into consideration;

Acknowledged that States like Kano, Borno, Katsina, and Sokoto, which are commercially viable, are exempted;

Cognizant of the need to establish more Compressed Natural Gas (CNG) conversion centers in the Northwest and Northeast to facilitate legitimate business operations for all citizens;

#### Resolved to:

- (i) urge the Executive Arm of Government to establish Compressed Natural Gas Conversion Centers equitably across the country to give Nigerians a sense of belonging; and
- (ii) Set up an *Ad-hoc* Committee with membership from the Six Geopolitical zones to investigate the implementation of the CNG policy (HR. 123/05/2025).

Disturbed by the current dilapidated state of permanent orientation camps in the country, which is causing dissatisfaction due to inadequate facilities overstretching the existing facilities, leaving Corps Members with no options other than to be redeployed to neighbouring states for camping activities;

*Concerned* that due to space limitations, Corps Members frequently have to travel for longer periods of time after being deployed;

*Cognizant* of the need for spacious, habitable orientation camps, with each camp accommodating at least 5,000 participants at a time across the states of the Federation;

Also cognizant of the need to ensure the provisions of the state-of-the-art facilities, build additional camps, to empower Nigerian Corps Members with life survival skills and strategies, ensuring sustainable development and evolutionary trends;

#### Resolves to:

- (i) urge the Executive Arm of Government to collaborate with States Government to construct additional camps and expand existing ones to accommodate at least 5,000 participants in each States of the Federation;
- (ii) urge the Federal Ministry of Youth, in collaboration with other stakeholders, to work out modalities to achieve the construction and expansion of NYSC orientation camps; and
- (iii) mandate the Committees on Youth Development, and Legislative Compliance to ensure compliance and report within four (4) weeks (Hon. Garba Ibrahim Muhmmad Gwale Federal Constituency).

- (iii) mandate the Committees on Youth Development, and Legislative Compliance to ensure compliance and report within four (4) weeks (HR. 124/05/2025).
