SUBMISSION OF 2024 STATUTORY BUDGET PROPOSAL OF THE NIGER DELTA DEVELOPMENT COMMISSION (NDDC)

In line with the provisions of Section 121 of the Constitution of the Federal Republic of Nigeria, I forward herewith the 2024 Statutory Budget Proposal of the NDDC for consideration and passage by the House of Representatives.

- 2. The Budget Proposal has been prepared on the basis of the NDDC's revenue and expenditure forecasts and is aligned with the fiscal and developmental policies of the Federal Government and the Renewed Hope Agenda. In addition, the Budget Proposal takes into consideration the 2024 2026 Economic Recovery Growth Plan as well as key assumptions of the 2024 Appropriation Act of the Federal Government.
- 3. The NDDC is prioritizing improvement in security, job creation, youth and women empowerment, social welfare, education infrastructure and increased productivity in agriculture in order to contribute to the economic growth of Niger Delta region and the development of the nation at large.

Also notes that the Minister of Aviation and Aerospace Development will implement the decision of the Federal Executive Council (FEC) by sending out circulars to relevant authorities in a matter of days;

Further notes that men and women of the Armed Forces honour the nation with the highest form of service and without reservation by keeping us safe from harm, protecting our wealth and territorial integrity, ensuring safe navigation on Nigerian territorial waters, protecting borders including the Gulf of Guinea, Creeks, Sahara Desert and forests, and fighting armed bandits who invaded the communities;

Aware that it is important to show gratitude by honouring our brothers and sisters who are voluntarily serving under our flag, putting in their active years to keep our nation safe with some losing their lives, and some becoming disabled from the battlefield amidst other effects;

Also aware that honouring these men and women in uniform, and also encouraging fellow citizens to acknowledge their service to the nation is the right step to take as a way to appreciate the immeasurable sacrifices they make;

Prevalent Insecurity and Incessant Attacks Against the People of Yagba Land Perpetrated by Herdsmen and their New Settlements:

The House:

Notes the shocking incident that occurred on May 7, 2024, in Ejiba community, Yagba West Local Government Area of Kogi State, where a group of armed kidnappers numbering about 10, all dressed in black, stormed the central market area and abducted a prominent businesswoman, Bukky, and a male customer after shooting sporadically, causing panic and fear among the residents;

Also notes that on 11 May, 2024, security personnel were not spared by those herdsmen and their communities as a Policeman was matcheted along Okutadudu in Yagba West Local Government Area underscoring the grim security situation and the regrettable failure of the current security architecture, which appears to be overwhelmed by the audacity of these herdsmen and their community;

Troubled by the fact that comparable violent attacks and kidnappings have been occurring on a weekly basis, including a prior incident approximately 2 (two) weeks before the Ejiba event where two individuals were abducted from the residence of a prominent businessman and political figure named Mr David Joseph, an abduction that tragically resulted in the death of one of the victims;

Also troubled by another recent development on Friday, May 17, 2024, where two persons were ambushed and brutally killed at Ogbe Community in Yagba West Local Government Area of the State by herdsmen armed with sophisticated weapons, who slaughtered their victims without being apprehended by local security services;

Recalls that more than 6 (six) persons were kidnapped within the space of 48 hours around Isanlu, in Yagba East LGA, and 3 (three) people were again murdered between Idofin and Isanlu in an attempt to escape from the kidnappers;

Worried with grave concern that these attacks are perpetrated under the pretext of migration by cattle herders, lots of whom are non-Nigerians;

Also worried that these armed groups infiltrate farms and forests in the area, populate the regions from within the forests, the outskirts and fringes of existing communities, and engage in kidnapping, killing, raping, and maiming of indigenes, causing severe insecurity and fear among the local populace;

Further worried that these armed groups are not known to the indigenous people of the land, do not live civilized lives, and have adopted a hostile existence completely at variance with the local culture and way of life, creating a divide within the community;

Disturbed that the indigenous people, who do not own weapons, now live in fear of the heavily armed non-indigenes who have forcibly seized farmlands, causing serious famine due to the inability of indigenes to farm and access their agricultural lands;

Also disturbed about rhe inability of the security apparatus to address the systematic takeover of lands belonging to the good people of Yagba Federal Constituency, as they allow private individuals to carry arms in broad daylight, watch as non-natives take over farms, eat crops of indigenous farmers, and sack indigenes from their farmlands, with many killed for trying to access their lands or objecting to the eating of their crops;

Saddened that the herders and their newly established communities are known to openly carry arms, cutlasses, and machetes openly, in contrast to the indigenous people of Yagba Land, who have traditionally relied on the Nigeria Police for protection and do not engage in such practices;

Also saddened by the trend of violence and hopelessness that has befallen the once peaceful Yagba axis of Kogi West Senatorial District, which has now turned into an epicentre of banditry and kidnapping, with criminals operating on a daily basis, leaving the local populace in a state of constant fear and despair;

Resolves to:

- (i) urge the Executive Arm of Government to direct urgent attention and concentrated efforts towards the Yagba axis of Kogi West Senatorial District, an area formerly renowned for its peaceful nature but which has tragically devolved into a hotbed of banditry, kidnapping, and other criminal activities occurring on a daily basis;
- (ii) also urge the Chief of Defence Staff and the Inspector General of Police to identify and profile each individual living in obscurity within the forests of the Yagba Federal Constituency, lots of whom are non-Nigerians for security purposes;
- (iii) further urge the Inspector General of Police to carry out a comprehensive mop-up of all arms, ammunition, AK-47, cutlasses, and other weapons in the possession of herders and individuals within the constituency, and to prohibit the public carrying of such arms and weapons;

- (iv) still urge the Security Architecture, including the Inspector General of Police, the Director General of State Security Service, the Commandant General of the Nigerian Security and Civil Defence Corps to comb Yagba forests and secure immediate release of victims and arrest the kidnappers;
- (v) again urge the Executive Arm of Government to set a comprehensive security strategy, in collaboration with local stakeholders to address the root causes of the insecurity and ensure the safety and well-being of all residents in Yagba Federal Constituency in Kogi State (Hon. Leke Joseph Abejide Yagba East/Yagba West/Mope Muro Federal Constituency).

Disturbed that the stalled Safe Tower project, despite significant investment, needs urgent attention to improve the efficiency of our towers;

Also disturbed that the Aeronautical Information Service (AIS) Automation project has been ongoing for over fifteen (15) years without completion, which could solve communication challenges in the Airspace when completed;

Concerned that recent reports and observations indicate potential irregularities in the employment and appointment of personnel and contractors at major Nigerian airports, specifically in Lagos, Abuja, Port Harcourt, Kano, and Enugu;

- (v) also mandate the Committee on Legislative Compliance to ensure compliance (HR. 217/05/2024).

8. Personal Explanation (Order Eight, Rule 6)

Hon. Waive Ejiroghene Francis (*Ughelli North/Ughelli South/Udu Federal Constituency*), referred to the Resolution of the House on Thursday, 9 May, 2024, on a motion on the *Tracking of the Activities of Private Sector (Foreign and Local) Trade Malpractice (HR.* 187/05/2024) and the constitution of an *Ad-hoc* Committee to investigate the matter. He noted that the mandate of the *Ad-hoc* Committee was too broad, and infringes on the jurisdictions of most Standing Committees of the House, as well as statutory duties and responsibilities of the Executive Arm of Government. He therefore prayed the House to rescind its decision on the motion.

Alarmed that without incidences of grid collapses, residents and businesses in Minna metropolis and its environs have continued to experience prolonged power outages despite being consumers under different tariff bands:

Concerned that the recent banding of customers into A, B, C by the Nigerian Electricity Regulatory Commission (NERC) based on expected hours of supply has not translated to actual supply realities on the ground;

Also concerned that the citizens of Minna are presently getting a grossly inadequate electricity supply regardless of the tariff paid, in stark contrast to expectations.

Further concerned that the citizens of Minna are currently receiving inadequate electricity supply, despite the paid tariff, which is in stark contrast to their expectations;

Resolves to:

- (i) mandate the Committee on Power to interface with Nigerian Electricity Regulatory Commission, Transmission Company of Nigeria and Abuja Electricity Distribution Company to identify and address the issue of poor supply; and
- (ii) also mandate the Committee on Power to Monitor the restoration of stable electricity in Minna as soon as possible and investigate the poor electricity supply situation in Minna and its environs and report in two weeks (Hon. Yusuf Kure Baraje Booso/Paikoro Federal Constituency).

Also aware that during the administration of Late President Umaru Musa Yar-Adua, the contract for the reconstruction of the road was rewarded to Messrs Enerco Company Limited at a contract sum of \$\frac{1}{2}\$,983,340,780.00 with a completion term of 24 months;

Further aware that only 6 kilometres of the road was constructed by the contractor, thus abandoning the project;

Worried that the non-completion of this road project has negatively affected travel time and access to local markets, workplaces, educational institutions, and farms;

Also worried that several commuters and residents, especially farmers, have lost their lives and farm produce worth millions of naira as a result of the deplorable state of the road and robbery incidences;

Resolves to:

- (i) urge the Federal Ministry of Work to prompt Messrs, Enerco Company Limited, back to site and expedite the construction of the road project; and
- (ii) mandate the Committees on Works and Federal Roads Maintenance Agency (FERMA) to ensure compliance (Hon. Mitema Obordor Ogbia Federal Constituency).

Aware that the rehabilitation of this road is vital not only for the safety and well-being of the residents of Borno and Adamawa States, but also for the overall connectivity and economic stability of the region. The Biu-Garkida-Gombi road is a key route for transportation, trade, and access to essential services:

- (i) urge the Federal Ministry of Works to prioritize rehabilitation of Biu -Garkida- Adamawa Road without delay to safeguard lives, support economic growth, and enhance transportation infrastructure in the Askira-Uba/Hawul Federal Constituency and the Northeast subregion;
