

# HOUSE OF REPRESENTATIVES FEDERAL REPUBLIC OF NIGERIA VOTES AND PROCEEDINGS

Tuesday, 3 October, 2023

- 1. The House met at 11.10 a.m. Mr Deputy Speaker read the Prayers.
- 2. The House recited the National Pledge.

#### 3. Votes and Proceedings

Mr Deputy Speaker announced that he had examined and approved the *Votes and Proceedings* of Thursday, 26 September, 2023.

The Votes and Proceedings was adopted by unanimous consent.

#### 4. Announcement

#### Discharge of Ad-hoc Committees:

Mr Deputy Speaker announced the discharge of all *Ad-hoc* Committees and urged them to submit their reports immediately. He directed *Ad-hoc* Committees with pending investigation to recommend same to the Standing Committees that have jurisdictions on the matter.

#### 5. Remarks by the Deputy Speaker

Mr Deputy Speaker noted that the events of the previous weeks were remarkable and instructive in our national history. He recalled that the events of the 63<sup>rd</sup> Independence celebration, Ed-el-maulud. Mr Speaker's birthday anniversary as well as the calling-off of the strike actions by the Nigeria Labour Congress/Trade Union Congress were all positive development. He expressed delight at the decision of the labour union to call off their proposed strike action, stating that it gave credence to age of reasoning, a platform for jaw, jaw rather than war, war, and collective good for our national development. He appreciated all those that played role in averting the strike.

He commended the efforts of the present administration led by the President, Bola Ahmed Tinubu in providing 1003 Mass Transit Buses to ease transportation as a step in the right direction. Mr Deputy Speaker noted that the 3<sup>rd</sup> Quarter rise in oil production from 1.2 mbpd to 1.4 mbpd was an improvement in the national economic development. He maintained that continued synergy between the Executive and the National Assembly is a solution for the economic growth in the country.

(i) Escalating and Persistent Insecurity and Banditry Attacks in the North West Region of Nigeria:

Hon. Kabiru Amadu (Gusau/Tsafe Federal Constituency and 27 Others) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

Question that the matter be considered as one of urgent public importance —  $Agreed\ to$ .

Question that the House do suspend Order Eight, Rule 4 (3) to enable it debate the matter forthwith — Agreed to.

## Escalating and Persistent Insecurity and Banditry Attacks in the North West Region of Nigeria:

The House:

*Notes* that in the past three months, there has been a significant rise in banditry activities within Zamfara, Sokoto, Kebbi, Katsina, and Kaduna States with the surge in violence resulting in numerous casualties and displacement of considerable number of residents;

Also notes that in Zamfara State, the innocent casualties of these attacks who are mostly farmers, women, children, and students have been cut off from their means of livelihood;

Concerned that an alarming surge of abductions is currently unfolding within Gusau/Tsafe Federal Constituency in Zamfara State, with the deeply troubling upswing in abduction incidents, witnessed recently on 22 September, 2023, when heavily armed Bandits stormed off campus female hostel of Federal University, Gusau and abducted over 40 female students, only 13 were rescued by the military so far, on 21 August, 2023, eight NYSC members from Akwa Ibom State were also kidnapped on their way to Sokoto State, and as of the present moment, they remain in captivity;

Also concerned that in Tsafe town, six persons were brutally killed and dozens were taken hostage, on 21 September, 2023, while a notable young businessman who is into the telecommunication business named Anas Umar Wali Tsafe was gruesomely murdered by Bandits at exactly 8:00 p.m inside his residence;

Further concerned that this wave of criminality has since extended its reach into various communities such as Magami, Mada, Hayin Alhaji, Wanzamai, K/Kanuwa, Yan Kuzo, Yanware, Mareri, Damba, and Karazau;

Worried that in Gusau/Tsafe Federal Constituency alone, over 126 individuals were abducted including 33 children, and tragically, more than 56 innocent lives were claimed, all in the span of these 3 months;

*Observes* that these grim events have not only left a trail of sorrow, but sparked widespread concern and outcry among the constituents where the people feel that they are abandoned, ignored, rejected, unwanted, forsaken, neglected and unattended by the Government;

Worried that the security situation remains precarious within the region for over a decade with residents continually killed and kidnapped on a daily basis without anything being done by the government;

#### Resolves to:

- (i) observe a minute silence for the departed souls;
- (ii) call on the Federal Government to intensify efforts towards rescuing all those held hostage by these Criminals, conduct a comprehensive investigation into these Bandit attacks, apprehension of those responsible, and their prosecution to the fullest extent of the law;
- (iii) urge the President and Commander in Chief to direct the relocation of the Defense Ministry to the Northwest region until peace and sanity are fully restored;
- (*iv*) also urge the Executive Arm of Government to deploy additional security personnel equipped with adequate logistical support, to concerned States in order to fortify security measures and thwart any potential future attacks;
- (v) mandate the Committees on Legislative Compliance, Defence, National Security and Intelligence, and Police Affairs to ensure strict compliance with these resolutions (Hon. Kabiru Amadu Mai Palace Gusau/Tsafe Federal Constituency and Twenty-seven Others).

Need to Reconstruct the Collapsed Bridge at New Artisan Enugu Section of Enugu-Port Harcourt Federal Expressway and Other South Eastern Deteriorating Roads:

The House:

*Notes* that on Monday, 5 September, 2023, a tragedy occurred as a bridge along the Enugu-Port Harcourt Federal Expressway at the New Artisan Market in the Enugu section of the road, collapsed, when a truck conveying Nigerian Breweries products and an unidentified lorry were on the bridge;

Also notes that there was no loss of life during the incident as emergency responders quickly swung into action to ensure that no unwary vehicle plunged into the water underneath the bridge;

*Disturbed* that the collapsed bridge left commuters seriously stranded for a long time as traffic was diverted within the area where the bridge collapsed to avoid terrific traffic jam and chaos in the State;

*Cognizant* that this collapsed bridge which is of great economic value to Nigeria, is not only located along Enugu federal expressway, but is equally a connecting road to some parts of Imo State, Ebonyi State, then to Umuahia and Aba (commercial nerve centre of South East) both in Abia State, finally connecting some other South-South region like Port Harcourt in Rivers State, Cross River and Akwa lbom States respectively;

Concerned that if this bridge is not urgently repaired, it will affect logistics and movement of goods and services and also business-economic growth in Enugu State and across some other states, leading to huge losses and sufferings of commuters;

Further notes that a bridge is constructed over the road for the purpose of traffic management in various cities, as well as curbing road accident mishaps, prevalent traffic jam and disasters which may lead to high rate of human deaths and injuries;

Still notes that the collapse of bridges can be caused by overloaded or heavy duty transport vehicles operating daily on the road as well as lack of periodic infrastructural maintenance of the bridges. The incidence and prevalence of this occurrence in our country have been alarming over the years;

Again notes that it has become imperative to examine the phenomena of highway disasters with a view to underscoring its implications on national security in Nigeria, as a veritable threat to road safety as well as human security, in view of its destructive impacts and complications and urgent need for construction of quality bridges and its maintenance to curb the menace:

Observed that statistical study shows the alarming state of dilapidating roads and bridges in South East due to long neglect and paucity of funds to reconstruct or maintain the roads as the collapse of bridges and deteriorating road infrastructure seems to be on a growing trend, which calls for urgent intervention;

Worried that these unprecedented and hideous incidents have been reoccurring incessantly despite public outcry in the media and other mediums, as several road mishaps and collapse of bridges in Nigeria have consequential effects on human safety and our environment, hence exposing our lack of accident risk management structure;

#### Resolves to:

- (i) urge the Federal Government through the Federal Ministry of Works, to urgently intervene in the reconstruction of this collapsed bridge at New Artisan, Enugu-Port Harcourt expressways, and also the Aba-Port Harcourt section of same road due to its commercial importance to the nation and provide lasting solution to this road deteriorating menace in South East;
- (ii) also urge the Federal Government to ensure that adequate funds are provided for durable roads and bridges with optimum facilities across South East, as well as taking proactive measures to ensure maximum safety of lives through quality risk assessment and implementation of safety findings;
- (iii) mandate the Committee on Works, to monitor and liaise with Federal Ministry of Works in adhering spontaneously with the resolutions to repair the aforementioned collapsed bridge and other South Eastern roads;
- (iv) also mandate the Committees on Works, and Legislative Compliance to ensure compliance with any legislative framework and the resolutions thereof and report within two (2) weeks (Hon. Nnolim Nnaji Nkanu East/West Federal Constituency and Ten Others).

Need to Stop Killing Peasant Farmers in Chibok, Damboa and Gwoza Local Government Areas of Borno State and Provide Safe and Reliable Security for Farmers to Harvest their Hard-Earned Farm Produce:

#### The House:

Aware of the fact that agriculture is the backbone of our economy and the main source of livelihood for the majority of our constituents, we cannot afford to overlook the constant attacks on our farmers. These attacks not only result in loss of lives but also severely disrupt food production, leading to food scarcity, increased prices, and economic instability in our constituency;

Concerned that the persistent insecurity in the Chibok/Damboa/Gwoza Federal Constituency has created an environment of fear and uncertainty, discouraging farmers from cultivating their lands and leaving their hard-earned farm produce unharvested. This not only leads to financial losses for the farmers but also exacerbates the food insecurity situation in our constituency and the country as a whole;

Acknowledges the efforts of the security agencies in combatting insurgency and terrorism in our constituency, we must recognize that more needs to be done to provide a safe and reliable security environment for our farmers. The current security measures have proven inadequate in deterring attacks on innocent farmers, and it is high time we take decisive action to protect their lives and ensure their economic well-being;

*Realizes* that the killing of peasant farmers goes beyond a local issue and has broader implications for national security, as it directly impacts our food production and the stability of our nation. It is imperative that we prioritize the safety of our farmers, who toil day and night to provide food for our nation, and create an enabling environment for them to carry out their agricultural activities without fear or hindrance;

#### Resolves to:

- (i) urge the Executive Armed of Government to, in collaboration with the State and Local Governments, deploy additional security personnel and resources to the Chibok/Damboa/Gwoza Federal Constituency to provide adequate protection to peasant farmers and their farms;
- (ii) also urge the security agencies to intensify intelligence gathering and surveillance activities in the constituency to identify and apprehend the perpetrators of attacks on farmers;
- (iii) further urge the Executive Arm of Government to establish a special task force dedicated to addressing the security challenges in the Chibok/Damboa/Gwoza Federal Constituency, with a mandate to protect the lives and property of the farmers;
- (*iv*) still urge the Executive Arms of Government to provide financial assistance and support to affected farmers who have suffered losses due to attacks, to help them recover and sustain their agricultural activities;
- (v) again urge the Executive Arm of Government to engage in dialogue and collaboration with relevant stakeholders, including community leaders, traditional rulers, and local vigilante groups, to develop a comprehensive security strategy tailored to the specific needs of the Chibok/Damboa/Gwoza Federal Constituency;
- (vi) urge the Executive Arm of Government to invest in infrastructure development, such as access roads, communication network and rural electrification, to improve the security and economic viability of the Constituency (Hon. Ahmadu Usman Jaha Damboa/Gwoza/Chibok Federal Constituency).

Acknowledged the efforts of the security agencies in combatting insurgency and terrorism in our constituency, we must recognize that more needs to be done to provide a safe and reliable security environment for our farmers. The current security measures have proven inadequate in deterring attacks on innocent farmers, and it is high time we take decisive action to protect their lives and ensure their economic well-being;

Realized that the killing of peasant farmers goes beyond a local issue and has broader implications for national security, as it directly impacts our food production and the stability of our nation. It is imperative that we prioritize the safety of our farmers, who toil day and night to provide food for our nation, and create an enabling environment for them to carry out their agricultural activities without fear or hindrance;

- (v) again urge the Executive Arm of Government to engage in dialogue and collaboration with relevant stakeholders, including community leaders, traditional rulers, and local vigilante groups, to develop a comprehensive security strategy tailored to the specific needs of the Chibok/Damboa/Gwoza Federal Constituency;
- (vi) urge the Executive Arm of Government to invest in infrastructure development, such as access roads, communication network and rural electrification, to improve the security and economic viability of the Constituency;
- (v) urge the Federal Government to engage Agro Rangers nation wide to protect farmers during harvest (HR. 187/10/2023).

#### 8. Personal Explanation (Order Eight, Rule 5)

Hon. Solomon Bob (*Abua/Odua/Ahoada Federal Constituency*) invited the attention of the House to the existence of so many motions in the House without corresponding implementation by the Executive. He regretted that while the parliament often churn out motions on the floor of the House, they were unnecessary if not implemented by the Executive Arm of Government.

*Cognizant* of the urgent need for drastic measures to secure the immediate release of the remain seven abducted corps members following the release of one of them, as confirmed by the Director General of the National Youth Service Corps (NYSC) on 20 September, 2023 and restore confidence in the nation's national security system;

Notes that various communities in Abia State's Arochukwu/Ohafia Federal Constituency, including Amekpu, Elu, Nkporo, Ihechiowa, Abam, Arochukwu, and Ututu, are experiencing an increase in floods and gully erosion, The topsoil, which is rich in nutrients essential for agriculture, has been washed away by erosion with farmers' livelihood harmed by the loss of fertile land, thus leading a decline in agricultural productivity;

Concerned that flooding and erosion have caused the foundations of buildings, roads, bridges, and other infrastructure to collapse and deteriorate, posing a hazard to the safety of the population and impeding transportation and economic activity in the area;

Also concerned that community of Ebem Ohafia, has lost homes, and clans have been displaced, including the traditional monarch palace, which has withstood erosion damage since it was built in 1921;

Worried that the relentless impact of these natural disasters has resulted in significant hardships for Arochukwu/Ohafia Federal Constituency, threatening the lives and overall well-being of the Community;

#### Resolves to:

- (i) urge the National Emergency Management Agency (NEMA) to provide immediate relief materials to ameliorate the sufferings of the people;
- (ii) also urge the Federal Ministry of Works and the Federal Roads Maintenance Agency (FERMA) to commence rehabilitation to prevent further loss of lives and properties;
- (iii) further urge the Federal Government to increase Ecological Funding to address the menace of erosion in Arochukwu/Ohafia Federal Constituency of Abia State, which has become a threat to the lives and properties of the affected Communities;
- (iv) mandate the Committees on Environment, Ecological Funds, Niger Delta Ministry, Niger Delta Development Commission and Emergency Disaster Preparedness to ensure compliance (Hon. Ibe Okwara Osonwa Arochukwu/Ohafia Federal Constituency)

Also notes that the road is in deplorable condition and has only witnessed minor repairs as carried out by FERMA about five years ago;

Aware that the road is a major link to Lagos Island, Mile 2 express road, and Kirikiri Prison yard;

Cognizant of the need to rehabilitate the Boundary Market, Orodu Junction 30 Square Meter, Boundary Bridge Ayeke Bus Stop T Junction 15SquareMeter, Amore Junction before Tolu Medical 4.5 Square Meter, Bale Road Hausa Line Junction 10 Square Meter, Bale Road Green Land Bus Stop 25Square Meter, Bale Road Gbadesere Junction 9 Square Meter, Kirikiri Road Akere Health Center 24 Square Meter, Kirikiri Road Odus Bus Stop 46 Square Meter, Kirikiri Road 1st Benue Bus Stop 4 Square Meter, Kirikiri Road Goddey Bus Stop 10 Square Meter, Kirikiri Road People Bus Stop 40 Square Meter, Kirikiri Road Formula Two Bus Stop Failed Drainage of 80 Parameter in both wings, Kirikiri Road Berger Suya Bus Stop 1500 Square Meter, Kirikiri Road Berger Bridge immediately after descending 600SquareMeter;

Worried that the commercial and social life of the people has been seriously affected due to continuous neglect of the road;

18. Need to Re-construct Abandoned Portions of the East - West Road Connecting Major Communities in Bayelsa State

Worried that critical stakeholders have expressed concern that 65% of the pension funds (N100 Trillion Naira) loaned to the Federal Government is an investment which exposes the contributors to unnecessary volatility as the Federal Government may fail to pay back the loan in due time;

Also worried that being unable to access their pension has caused untold hardship to the retirees as they are unable to afford even basic necessities;

#### Resolves to:

- (i) urge the National Pension Commission (PenCom) to ensure the immediate release of funds for the payment of pension funds to all retirees;
- (ii) mandate the Committee on Pensions to:
  - (a) investigate the status of the pension fund assets of over ₹15,500,000,000,000.00 (Fifteen Trillion, Five Hundred Billion Naira) with a view to ensuring that the ₹100 trillion loaned to the Federal Government from pension funds is duly recovered and modalities are put in place to hinder a collapse of the pension scheme; and
  - (b) scrutinize the failure of Pension Fund Administrators (PFAs) in fulfilling its obligations to retirees as regards access to their retirement savings (Hon. Aliyu Bappa Misau Misau/Dambam Federal Constituency)

Joseph Folorunsho Adegbesan — Ijebu North/Ijebu East/Ogun Waterside Federal Constituency)

### 22. Reconstruction of the Calabar - Oban Ekan International Road leading to the Republic of Cameroon

*Motion made and Question proposed:* 

#### The House:

*Notes* that Section 14 (20) (*b*), Chapter II of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) provides that the security and welfare of the people shall be the primary purpose of the Government;

Also notes that on 10 October, 2002, the International Court of Justice (ICJ) ruled that the proprietorship of the Bakassi Peninsula belongs to Cameroon, due to an agreement between the governments of Nigeria and Cameroon during the civil war, the economic impact of that ruling is still being felt today;

Acknowledged that Cross River State is an Agrarian State, producing cocoa, banana, plantain, palm produce, yam, cassava, rice, coco-yam, maize, robber, and groundnut among other cash crops;

Aware that having a military base along the Calabar-Oban Ekan international road leading to the Republic of Cameroon with no good road, collapsed bridge, or wooden coverts to retreat in case of emergency is an embarrassment to the Nigeria government;

*Recognise* the economic implication of agricultural produce that always go to waste, the Lafarge cement factory located in the same area and other business that are losing money due to the terrible nature of the road has cost Cross River and the Federal Government of Nigeria a huge economic lost;

Also recognise the importance of migration and its consequences, especially for the promotion of regional integration and economic cooperation in Africa;

*Determined* to overcome the challenges of security of life and properties, the security of the military personnel, the threat to national security, issues regarding irregular migration, human trafficking, migrant smuggling, and related issues;

#### Resolves to:

- (i) urge the Ministry of Works to make provision for Reconstruction of the Calabar-Oba-Ekan International Road in the 2024 budget estimates; and
- (ii) mandate the Committee on Works to ensure compliance (Hon. Emil Inyang Akamkpa/Biase Federal Constituency and 7 Others).

Agreed to.

(HR. 197/10/2023).

Motion referred to the Committee on Works, pursuant to Order Eight, Rule 9 (5).

## 23. Call to Investigate the Abandonment of Rehabilitation Work on the Umuahia-Ikwuano-Ikot Ekpene Expressway

Motion made and Question proposed:

The House:

*Notes* that Umuahia -Ikwuano-Ikot Ekpene road is a major highway linking the South-East to the South-South states of Akwa Ibom, Cross River, and down to Cameroon;

Also notes that the Umuahia-Ikwuano-Ikot Ekpene road axis poor road network has halted Socio-economic activities in the Southeast geo-political zone;

Aware of the economic significance of the roads to the abutting states of the Southeast, South-South, Western and Northern States of the Federation for the movement of essential goods and services;

Also aware that the Federal Ministry of Works and Housing in 2019 awarded the contract for the rehabilitation of Umuahia-Ikwuano-Ikot Ekpene road to Messrs Hartland Company Ltd, howbeit, no meaningful milestones have been achieved;

Worried that effort by patriotic stakeholders in Ikwuano LGA to ascertain the real cause of the delay has proved abortive as both the Federal Ministry of Works and the Nigerian national Petroleum Corporation Limited (NNPCL) (funding agency) have not been forthcoming;

*Convinced* that the rehabilitation of the Umuahia-Ikwuano-Ikot Ekpene Expressway will bring relief to millions of commuters and propel the economic development of the country;

Resolves to:

- (i) mandate the Committee on Works to investigate and determine cause of abandonment of the Umuahia-Ikwuano-Ikot Ekpene Expressway and unattended to for almost the lifespan of the contract, provide a permanent and sustainable solution and report back within 2 weeks for further legislative action; and
- (ii) also mandate the Committee on Legislative Compliance to ensure compliance (Hon. Obi Aguocha Ikwuano/Umuahia North/Umuahia South Federal Constituency).

Agreed to.
