Tuesday, 6 February, 2024

## 7. Matter of Urgent Public Importance (Standing Order Eight, Rule 5)

### ***Need for Government to Reduce the Cost of Living:***

Hon. Ibrahim Ayokunle Isiaka (*Ifo/Ewekoro Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 5 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 5 (3) to enable it debate the matter forthwith — Agreed to.*

*Also notes* the increasing expenses on housing, food, healthcare, education due largely to inflation rate which adversely affected the purchasing power, as the prices of goods and services continuously rise;

*Regrets* that the stagnant wages, salaries and lack of job opportunities have further exacerbated the financial and economic strain on families and individuals alike;

*Concerned* that the high cost of living has increased stress and anxiety levels in families, as they can longer make plans, save or invest for the future;

*Commends* the recent policy of Government to lift the ban on poultry, dairy and rice importation from other countries as panacea towards enhanced food security in the country;

*Aware* that the increase in cost of living has been further exacerbated by the high energy cost, with the attendant increase in poverty index and untold hardship on the Nigerian citizens.

*Resolves to:*

- (i) urge the Executive Arm of Government to:
  - (a) liaise with critical stakeholders to immediately open up the national food reserve and to encourage the importation of grains, poultry products, meats, beverages, healthcare and pharmaceutical products from the top exporting countries in the world as a short-term measures;

- (iv) mandate the Leadership of the House to begin in earnest, the planned summit with the theme: “Security and Economic Development” (HR.06/02/2024).
