

# HOUSE OF REPRESENTATIVES FEDERAL REPUBLIC OF NIGERIA VOTES AND PROCEEDINGS

Wednesday, 14 June, 2023

- 1. The House met at 11.32 a.m. Mr Speaker read the Prayers.
- **2.** The House recited the National Pledge.

#### 3. Votes and Proceedings

Mr Speaker announced that he had examined and approved the *Votes and Proceedings* of Tuesday, 13 June, 2023.

The Votes and Proceedings was adopted by unanimous consent.

#### 4. Messages

Mr Speaker directed the transmission of the following messages:

- (a) (1) To the Senate of the Federal Republic of Nigeria:
  - (i) That a message be conveyed to the Senate of the Federal Republic of Nigeria informing that Body, that the House had assembled on Tuesday, 13 June, 2023 with quorum formed, and that Hon. Tajudeen Abbas, representing Zaria, Federal Constituency of Kaduna State was elected the Speaker of the House of Representatives;
  - (ii) That a message be conveyed to the Senate of the Federal Republic of Nigeria informing that Body, that the House had assembled on Tuesday, 13 June, 2023 with quorum formed, and that Hon. Benjamin Okezie Kalu representing Bende Federal Constituency of Abia State was elected the Deputy Speaker of the House of Representatives.
  - (2) To the President, Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria:

- (i) That the Clerk to the National Assembly do notify the President, Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria; that the House had assembled on Tuesday, 13 June, 2023 with quorum formed, and that Hon. Tajudeen Abbas, representing Zaria Federal Constituency of Kaduna State was elected the Speaker of the House of Representatives.
- (ii) That the Clerk to the National Assembly do notify the President, Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria that the House had assembled on Tuesday, 13 June, 2023 with quorum formed and that Hon. Benjamin Okezie Kalu representing Bende Federal Constituency of Abia State was elected the Deputy Speaker of the House of Representatives
- (iii) That the Clerk to the National Assembly do advise the Secretary to the Government of the Federation (SGF) to inform the President, Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria that the House had assembled, Quorum formed and is ready to receive any message he may wish to transmit.
- (iv) That the Clerk to the National Assembly do notify the International Parliamentary Unions and Associations that the House had assembled on Tuesday, 13 June, 2023 with quorum formed and that Hon. Benjamin Okezie Kalu representing Bende Federal Constituency of Abia State was elected the Deputy Speaker of the House of Representatives

#### 5. Petition

A petition from Cyril Nkangwung and 4 others, on behalf of Idaa Obolo Assembly of Eastern Obolo, Ibeno and Mbo Local Government Areas of Akwa Ibom State, on the ongoing re-maping agenda of Akwa Ibom State Government which will deny the communities of their full rights and benefits as Host Communities as contained in the Petroleum Industry Act, 2021, was presented and laid by Hon. Abiante Awaji-Inombek Dagomie (*Andoni/Opobo Federal Constituency*).

Petition referred to the Committee on Public Petitions.

#### 6. Matters of Urgent Public Importance (Standing Order Eight, Rule 4)

(i) Need to Commence Active Measures to Mitigate the Probable Devastation of a Severe Flood Season and prepare Palliative Intervention to Prevent the worst Socio-Economic Consequences for Nigerians in the Affected Areas:

#### The House:

*Notes* that a large portion of the country from North to South, East to West is prone to annual destructive flooding incidents which recurring events have, in recent years, increased significantly in severity and the extent of the devastation of lives and property;

Also notes that in January 2023, the Nigerian Meteorological Agency (NiMet) released the seasonal climate prediction with a forecast of early onset of rain across the country and heavy rains throughout the season, prediction of which has already come to pass, with the forecast of a heavy rainy season soon to come to fruition;

*Concerned* that the 2023 Annual Flood Outlook by the Nigeria Hydrological Services Agency shows that One Hundred and Seventy-Eight (178) Local Government Areas

in thirty-two (32) States of the Federation and the Federal Capital Territory fall within the highly probable flood risk areas;

Aware that Nigeria is yet to recover from the 2022 flood, which affected more than 4 million Nigerians, displaced over two million people, caused the death of six hundred and sixty-five (665) people, damaged about three hundred and fifty-five thousand nine hundred and eighty-six (355,986) houses and homesteads and destroyed an estimated total of nine hundred and forty-four thousand, nine hundred and eighty-nine thousand (944,989) hectares of farmland;

Also aware that the experience of the 2022 flood caused the Federal Government of Nigeria to constitute a Presidential Committee to develop a comprehensive Plan of Action for Preventing Flood Disasters in Nigeria, proposing structural and non-structural measures, land and water management systems and better coordination amongst stakeholders across the Federal and State Governments to ensure effective flood management in Nigeria;

Convinced that with sufficient preparation and collaboration between the Federal and State Governments, we can mitigate the loss of life and the socio-economic hardships caused by these recurring flooding events;

*Cognizant* of the need for the Federal Government and the State Governments to commence active measures to mitigate the probable devastation of a Severe Flood Season and prepare palliative and intervention measures to prevent the worst Socio-economic consequences for Nigerians in the affected areas.

#### Resolves to:

- (i) invite the Director-General of the National Emergency Management Agency (NEMA), the Director-General, Nigerian Meteorological Agency and the Federal Ministry of Environment to brief the Leadership of the House on the measures in place to mitigate flood disasters and manage the socio-economic impact on the citizens resident in the flood-prone areas;
- (ii) liaise with the relevant Agencies of the Government to ensure the relocation of Nigerians from the most flood-prone areas;
- (iii) ensure the Executive Arm of Government stockpiles sufficient quantities of temporary shelter materials, food and nutrition items and medicine to support people in flood-prone areas;
- (iv) encourage communication between the Federal Government of Nigeria and the State Governments to ensure effective collaboration to prevent the worst outcomes in flood-prone areas (Hon. Femi Gbajabiamila Surulere I Federal Constituency).

#### Debate.

#### **Amendments Proposed:**

"Urge National Emergence Management Agency (NEMA) to conclude the distribution of palliatives to victims of the 2022 flood disaster and take proactive steps to mitigate future occurrence" (Hon. Olumide Osoba — Abeokuta North/Obafemi Owode/Odeda Federal Constituency).

Question that the amendment be made — Agreed to.

Question on the Motion as amended — Agreed to.

- (v) urge the Secretary to the Government of the Federation to forward the 2022 Report on flood disaster in the country by the Presidential Committee for the Development of Comprehensive Plan of Action to Prevent Flood Disasters in Nigeria;
- (vi) also urge National Emergence Management Agency (NEMA) to conclude the distribution of palliatives to victims of the 2022 flood disaster and take proactive steps to mitigate future occurrence (**HR. 01/06/2023**).

#### (ii) Windstorm and Flood Disaster in Misau, Bauchi State:

Hon. Aliyu Bappa Misau (*Misau/Dambam Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

Question that the matter be considered as one of urgent public importance — Agreed to.

Question that the House do suspend Order Eight, Rule 4 (3) to enable it debate the matter forthwith — Agreed to.

#### Windstorm and Flood Disaster in Misau, Bauchi State:

#### The House:

*Notes* that on Sunday, 14 May, 2023, there was a heavy storm, downpour at Misau town leading to serious disaster in the area;

Concerned that as a result of the heavy windstorm, about 2000 houses were destroyed, farmlands submerged and shops worth millions of Naira were washed away;

Also concerned that the only access road linking various villages in the community was cut off, leaving some of the inhabitants stranded and roaming the streets without shelter and basic human needs:

Worried that as a result of the disaster some of the inhabitants of the area have been left homeless and temporarily occupying public buildings such as schools and Mosques;

Commends His Excellency, the Governor of Bauchi State, Sen. Abdulkadir Bala Mohammed for quick response and directive to the State Emergency Agency (SEMA) to provide relief materials to the victims of the disaster;

#### Resolves to:

- (i) call on National Emergency Management Agency (NEMA) to assess the level of damage and urgently provide relief materials to the affected victims and assist in rehabilitating them;
- (ii) urge the Federal Ministry of Environment and other Government Agencies that are saddled with the responsibility of windstorm, flood and erosion control to provide permanent solution;
- (iii) also urge the North East Development Commission (NEDC) to provide relief materials to the victims, design and construct drainage where necessary (Hon. Aliyu Bappa Misau Misau/Dambam Federal Constituency).

Agreed to.

*Notes* that on Monday, 29 May, 2023, President Bola Ahmed Tinubu in his inaugural speech, announced the removal of Nigeria's fuel subsidy;

Also notes that as a result of the subsidy removal, the official pump price of petrol skyrocketed from the initial \text{\text{\text{N}}195} per litre to a whopping \text{\text{\text{\text{\text{N}}}480-\text{\text{\text{\text{N}}}577} per litre as the prices varied between States;

*Concerned* that the implication of over 200 per cent price adjustment in fuel prices is that nearly all prices of goods and services have drastically increased;

Also concerned that the sudden fuel subsidy removal has left millions of Nigerians terrified, thus causing untold hardship as Nigerians grapple with the challenges of meeting up with, not only the

high cost of petrol but also the consequent increase in the prices of goods and services;

Aware that in response to the resulting financial strain of the subsidy removal on public workers, some proactive State Governments introduced temporary measures to alleviate the situation by reducing work days from five to three days per week for the State-employed workers pending when other sustainable palliatives can be provided;

Also aware that the Nigeria Labour Congress and the Trade Union Congress recently suspended a planned strike over the removal of fuel subsidy in the hopes that the Federal Government would address its adverse effects on workers:

*Notes* that the ravaging effect of gully erosion on the Ugwuonyeama 9th Mile Road in Enugu North and part of Udi Local Government Areas;

Also notes the strategic importance of the Ugwuonyeama 9th Mile Road to the economy of the South East States in particular and the country, in general, cannot be under-estimated as the road enables traders to transport goods to markets within and to neighbouring States and serves as a route to Enugu State, the commercial city in South East;

Further notes that the adverse effects of erosion on these roads have long been ignored and if not checked may cut off access to other States within the South East;

Worried that Ugwuonyeama 9th Mile Road has remained a death trap resulting in loss of lives, goods and services worth millions of Naira on a daily basis due to frequent accidents on the bad portions of the road yet to be completed;

*Cognizant* of the provisions of Section 2 (1) and (2) of the National Environmental (Soil Erosion and Flood Control) Regulations, 2011, on the objectives of the Regulations which protect human life and environment;

#### Resolves to:

(i) urge the Federal Ministry of Works and Housing, and Federal Roads Maintenance Agency (FERMA) to complete the reconstruction of Ugwuonyeama 9th Mile Road to prevent its total collapse;

- (ii) also urge the Federal Ministry of Environment and other relevant agencies to take a holistic approach in containing the gully erosion menace, particularly Ugwuonyeama 9th Mile, Enugu State:
- (iii) mandate the Committees on Environment, Federal Roads Maintenance Agency (FERMA) and Works (when constituted) to investigate the threat posed by gully erosion along Ugwuonyeama 9th Mile Road in Enugu State and recommend long term solution (Hon. Chimaobi Sam Atu Enugu North/Enugu South Federal Constituency).

#### **Amendments Proposed:**

(i) Insert a new Prayer (iv), as follows "urge the Ecological Fund Office to find lasting solution to the gully erosion at Ugwuanyeama 9th Mile Federal Road in Udi Local Government of Enugu State" (Hon. Chinedu Emeka Martins — Ahiazu Mbaise/Ezinihitte Federal Constituency).

Question that the amendment be made - Agreed to.

(ii) Leave out Prayer (iii) (Hon. Abiante Awaji-Inombek Dagomie — Andoni/Opobo Federal Constituency).

Question that the amendment be made - Agreed to.

(iii) In Prayer (ii), immediately after the words "Enugu State", insert the words, "Isu Njaba gully erosion in Isu Local Government Area and the Nkwommiri gully erosion in Nwangele Local Government Area all in Imo State" (Hon. Ugoma Ozurigbo — Isu/Njaba/Nkwere/Nwangele Federal Constituency).

Question that the amendment be made - Negatived.

(iv) Insert a Prayer (iv), immediately after the words "Geopolitical Zone", insert the words "and any other area in Nigeria that gully erosion may currently be affected" (Hon. Jimbo Ernest Clement — Abak/Etim Ekpo/Ika Federal Constituency).

Question that the amendment be made — Negatived.

Question on the Motion as amended — Agreed to.

- (*iii*) urge the Ecological Fund Office to find lasting solution to the gully erosion at Ugwuanyeama 9th Mile Federal Road in Udi Local Government of Enugu State (**HR. 04/06/2023**).
