  Hon. Olawuyi Raheem Tunji (Ekiti/Irepodun/Isin/Oke-Ero Federal Constituency and Three Others) introduced the matter and prayed the House to:
  - (a) consider and approve the matter as one of urgent public importance; and

(b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

Question that the matter be considered as one of urgent public importance — Agreed to.

Question that the House do suspend Order Eight, Rule 4 (3) to enable it debate the matter forthwith — Agreed to.

#### Need for Intervention to Address the Failure to Implement Presidential Palliatives:

#### The House:

*Notes* that section 14 (*b*) of the 1999 Constitution (as amended) provided that the security and welfare of the people shall be the primary purpose of any government;

Also notes that the removal of petrol subsidy in May 2023 has adversely affected majority of micro, small and medium enterprises in Nigeria forcing businesses shut down, destroying means of livelihood and plunging millions into poverty;

Aware that President Bola Ahmed Tinubu (GCFR) in his resolve to address the situation, unveiled via his address to the nation, on 31 July, 2023, a ₹550 billion worth of government interventions cutting across three major sector of the economy viz-viz: Agriculture (₹200 billion), MSME sector (₹250 billion) and transportation sector (₹100 billion);

Also aware that the Presidential pronouncement put the period of the implementation of the ₹550 billion palliatives between August 2023 to March 2024;

Concerned that nearly five months after the removal of petrol subsidy, the implementation of this intervention especially the MSME component that directly affect 1 million nano businesses is yet to take - up;

*Cognizant* of the contribution by the SME to the economy representing 48% of the total GDP and engaging over 84% of the total work force;

Worried that unless the House intervened, the present economic situation occasioned by the removal of petrol subsidy and the floating of the Naira will further worsen the challenges being faced by the SMEs in Nigeria;

#### Resolves to:

- (i) mandate the Leadership of the House to meet President Bola Ahmed Tinubu (GCFR) with the view to address the delay in the implementation of the intervention;
- (ii) also mandate the Committee on SME to engage the relevant MDAs, to identify the impediments to the implementation and to report within two (2) weeks (Hon. Olawuyi Raheem Tunji Ekiti/Irepodun/Oke-Ero Federal Constituency and Four Others).

Alleged Non-Remittance of \$34.2Bn to the Federation Account Being Dividends in Lieu of the Nigerian Government from the Nigerian Liquified Natural Gas from 2004 to 2021:

#### The House:

*Curious* that a Senior Advocate of Nigeria, Femi Falana has alleged non-remittance of monies by the Nigerian National Petroleum Company Limited and urged the Minister of Finance to direct the Company to remit the sum of \$34.2n to Federation Account;

*Notes* that the said \$34.2bn was received on behalf of the Federal Government of Nigeria from the Nigerian Liquefied Natural Gas Limited from 2004 to 2021 but has been alleged to be diverted by the NNPCL;

Concerned that NLNG dividends and other related payments have remained an issue since 2020 as payments are being warehoused in bank accounts designated by the NNPCL and not the federation account:

Also concerned that claims by the NNPCL that NLNG accounts are on Treasury Single Accounts domiciled with the Central Bank of Nigeria and cannot be diverted have been alleged to be false as NLNG had in 2019 and 2020 clearly stated in documents released, that out of the \$37.6bn it paid over the years, the NNPCL received 49% on behalf of the government;

Further concerned that whereas, the TSA was introduced in 2012 with full implementation by 2015, the illegal withdrawals of NLNG dividends and oil revenue dates back to 2004;

Mandate the Committees on Gas Resources, Petroleum Resources (Upstream), and Public Accounts to investigate the allegations of non-remittance of monies by the NNPCL from LNLG dividends, towards monitoring and ensuring the remittance of the \$34.2bn and other related funds to the Federation Account and report progress to the House in two (2) weeks (Hon. Sani Bala Umar — Kunchi/Tsanyawa Federal Constituency).

### 7. Matter Requiring the Urgent Attention of the House On-Going Strike by the Organized Labour:

The Deputy Speaker, Rt Hon. Benjamin Kalu, invited the attention of the House to the on-going strike by the Organized Labour, leading to a near shut down of the Country. He referred to the various provisions of the Legislative Agenda of the 10th House of Representatives, stressing that Members were called to serve in most challenging circumstances. He maintained that the resolve for Members to attend the Day's sitting despite the strike was one of those sacrifices aimed at selfless service. He urged the House to suspend further sitting and mandate the Leadership to liaise with its Senate counterpart to engage the Organized Labour in a dialogue with a view to finding a lasting solution to the on-going strike.

Mr Speaker urged the Organized Labour to suspend the On-going Strike to allow the Leadership of the House of Representatives and its counterpart in the Senate dialogue with the Organized Labour for a lasting solution to the on-going strike.
