RE-COMMITTAL OF A BILL

1. Rescission and Re-committal of Clauses 4 and 9 of the National Identity Management Commission (Repeal & Enactment) Bill, 2025.

Sponsor: Sen. Bamidele, Michael Opeyemi (*Ekiti Central-Senate Leader*)

The Senate:

Recalls that the National Identity Management Commission (Repeal & Enactment) Bill, 2025 was passed by the Senate and the House of Representatives;

Informed that after critical examination of the Bill, some fundamental issues emerged, which require fresh legislative action in Clauses 4 and 9, to allow for smooth and effective operation, Federal Character Principle and regional balance, inclusiveness and Senate Confirmation of Appointments, consistent with democratic norms and Constitutional safeguards as well as appointments of Four (4) Executive Commissioners on full-time basis; and

Relying on order 1(b) and 52(6) of the Senate Standing Orders,

Accordingly resolves to:

Rescind its decision on Clauses 4 and 9 of the Bill as passed and Re-commit same to the Committee of the Whole for Re-consideration and passage.
